Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of Floydco, Inc. (the Company) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of the Company who have one year of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may elect to defer any percentage of compensation up to the IRS maximum allowable limit. This limit was set at \$23,000 and \$22,500 based on calendar year limits in effect at the end of the Plan year 2024 and 2023, respectively. Besides this dollar limit, other special IRS rules might limit the amounts of participant contributions that would otherwise be made. When necessary to comply with IRS regulations, any excess participant contributions will be returned to the affected participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Investments are selected by the participants. On October 11, 2023, the plan was amended to allow Roth Elective Deferrals, Rollover Contributions of Roth assets, and distributions of Roth assets. The plan amendment was effective November 1, 2023.

Participants who have attained age 50 before the end of the plan year may elect to defer additional amounts (called catch-up contributions) to the Plan. The maximum catch-up contribution allowed was \$7,500 and \$7,500, based on calendar year limits in effect at the end of the Plan year 2024 and 2023, respectively.

The Company may make non-elective discretionary contributions and required minimum contributions, under the Top-Heavy rules or other legal requirements. The amount of the Company's contribution is discretionary, not limited by profitability of the Company, and determined by the Company each plan year. The eligibility to receive an allocation of the Company's contribution and the formula used are set forth in the Plan document.

Participant Accounts - Each participant's account is credited with both participant and employer contributions and subsequent earnings on those contributions. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN - CONTINUED

Vesting - Participants are immediately vested in their contributions plus subsequent earnings. Participants are vested in the Company's contribution based on years of service. Participants are 20% vested after two years of service and 20% each year thereafter.

Payment of Benefits - Upon termination of employment, retirement, or disability participants may request the Plan administrator to distribute their benefit as soon as practicable following separation of employment. The normal form of benefit payment shall be in the form of a single lump sum distribution, in an amount equal to the value of the participant's vested interest in his or her account. The spouse or beneficiary of a deceased participant will receive an amount equal to the full value of the deceased participant's account regardless of the percent vested at that time.

Forfeitures - Benefit payments to terminated participants partially vested in the Plan include their vested portion of employer contributions. The nonvested portion of terminated participants' account balances are used to reduce future employer contributions. As of October 31, 2024 and 2023, the forfeited funds totaled \$7,339 and \$2,980, respectively. For the years ended October 31, 2024 and 2023, forfeited funds were used to reduce employer contributions by \$0 and \$0, respectively.

Administrative Expenses - Certain administrative expenses are payable from the assets of the Plan. Investment expenses are payable from the assets of the Plan and are included in net appreciation of the investments and life insurance contracts. The Company paid for the Plan's audit costs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Accounting Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value as determined by the custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. Life insurance contracts are valued at net cash value as determined by the custodian. See Note 4 for discussion of fair value measurements.

Net appreciation or depreciation is reported in the statement of changes in net assets available for benefits and consists of the realized gains or losses and the unrealized appreciation or depreciation of these investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits - Benefits are recorded when paid.

Reclassification - Certain amounts in the prior period financial statements have been reclassified to conform to the current period presentation. These reclassifications had no effect on previously reported net increase (decrease) in assets available for benefits, total assets, or net assets available for benefits.

Subsequent Events - Management of the Plan has evaluated subsequent events through the date of the independent auditors' report, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN - UNAUDITED

As permitted by the rules and regulations of the Department of Labor with respect to reporting and disclosure under ERISA, John Hancock Life Insurance Company has certified to the Plan Administrator that the investments (stated at fair value or contract value), together with all other transactions which affect those assets, are complete and accurate.

Investments are presented at fair value as determined by quoted market prices or contract prices as determined by the Custodian. The plan assets and related transactions certified by the Custodian at October 31, 2024 and 2023, and for the years then ended, are summarized as follows:

4. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statement of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The three levels of the fair value hierarchy are described as follows:

Level 1 Quoted prices are available in active markets for identical assets or liabilities;

Level 2 Quoted prices in active markets for similar assets or liabilities that are observable for the assets or liability; or

Level 3 Unobservable pricing inputs that are generally less observable from objective sources, such as discounted cash flow models or valuations.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024.

Pooled Separate Accounts - Valued at daily closing price as reported by the fund. Pooled separate accounts held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Life Insurance Contracts - Valued at net cash value, which approximates fair value, as of the Plan's year end date.

5. TAX STATUS

The Plan obtained its latest determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Management is not aware of any tax positions that would have a significant impact on its financial position. The Plan's tax returns for the last four years remain subject to examination.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be entitled to their full account balance as of the date of termination, regardless of the percent vested at the time of termination.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are pooled separate accounts and life insurance contracts managed by John Hancock and Prudential, respectively. Actuary & Associates performs the record keeping function for the Plan. These companies are parties-in-interest under ERISA. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
