Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - PLAN DESCRIPTION

The Transcendia, Inc. 401(k) and Profit Sharing Plan (“the Plan”) is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Transcendia, Inc. (“the Company”) who are 18 years of age and have completed three months of service.

Contributions: Participants may elect to defer salary by making contributions to their accounts of up to 60% of their annual salary, subject to the maximum limitation imposed by the IRS (\$23,000 for 2024). Effective April 30, 2008, the Company implemented automatic enrollment for newly eligible employees at 3%. Effective March 1, 2013, the Company elected automatic annual deferral increases of 1% each year for employees automatically enrolled in the Plan to a maximum of 15%. Effective January 1, 2019, the Company began matching \$0.50 on the dollar on up to 6% of employee contributions from eligible compensation. The maximum Company match is 3% of employee eligible compensation and is payable each pay period.

The Company may also make profit sharing contributions to the participants’ accounts at its discretion. Profit sharing contributions are allocated based on the ratio that each eligible participant’s compensation bears to the total compensation paid to all eligible participants for the plan year. There were no profit sharing contributions in 2024.

Vesting: Participants are immediately vested in their 401(k) and rollover contributions plus actual earnings thereon. Vesting in employer matching contributions and related earnings is 100% immediate and vesting in nonelective employer contributions and related earnings is based on years of service with 100% vesting occurring after six years of service. Effective January 1, 2019, previous Interfilm Retirement Savings Plan employees hired prior to October 2010 were immediately vested in their employer contributions and related earnings.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, an allocation of the Company’s contribution, an allocation of the Plan’s earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled to is the benefit that can be provided from the participant’s vested account. The investment selection is determined by each participant. Participants receive quarterly statements detailing the activity in their accounts.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding notes receivable balance in the participant’s account during the prior 12-month period or (b) 50% of their vested account balance. Notes receivable terms range from one to five years or up to ten years for the purchase of a primary residence. The notes receivable are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator.

Withdrawals and Distributions: Upon retirement, death, disability, the attainment of age 59 ½, or termination of service, the participant or beneficiary is entitled to receive the vested balance in the participant's account in the form of a lump-sum distribution, installment payments, or transfer to another plan at the participant's discretion. In addition, participants may also request a distribution from their participant deferral contributions account in the event of a financial hardship as defined by the Plan.

Plan Termination: Although the Company has not expressed any intent to do so, it has the right to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

Forfeited Accounts: Forfeited nonvested accounts can be used to reduce the Plan's expenses or the Employer's contributions. During 2024, \$146 of forfeited balances reduced the Plan's expenses. At December 31, 2024 and 2023, unallocated forfeited accounts totaled \$7,988 and \$2,944, respectively.

Forfeited accounts will be restored to the participant if the participant (a) is reemployed by the Company before five consecutive one-year breaks in service and (b) repays the full amount previously distributed within the five-year period that begins on the date of reemployment.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company and are excluded from the financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, as further described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides for investment options in various mutual funds offered by Fidelity Investments, Inc. and certain other investments. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trust fund: The fair values of participation units held in the collective trust fund are based on the net asset values per unit as reported by the fund managers. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - TAX STATUS

The Internal Revenue Service has issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan has been amended since receiving the latest opinion letter. The plan administrator believes that the Plan is currently designed and being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. ERISA requires the disclosure of party-in-interest transactions.

The majority of the Plan's investments are shares of mutual funds managed by Fidelity Investments, Inc. and a collective trust managed by Fidelity Management Trust Company. Fidelity Investments, Inc. is affiliated with Fidelity Management Trust Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants are also party-in-interest transactions of the Plan. The Plan's payment of trustee fees, record keeping fees, and investment management fees qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 8 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through August 14, 2025, which is the date the financial statements were available to be issued.

We have performed audits of the financial statements of the Transcendia, Inc. 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTE 1 - PLAN DESCRIPTION

The Transcendia, Inc. 401(k) and Profit Sharing Plan (“the Plan”) is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Transcendia, Inc. (“the Company”) who are 18 years of age and have completed three months of service.

Contributions: Participants may elect to defer salary by making contributions to their accounts of up to 60% of their annual salary, subject to the maximum limitation imposed by the IRS (\$23,000 for 2024). Effective April 30, 2008, the Company implemented automatic enrollment for newly eligible employees at 3%. Effective March 1, 2013, the Company elected automatic annual deferral increases of 1% each year for employees automatically enrolled in the Plan to a maximum of 15%. Effective January 1, 2019, the Company began matching \$0.50 on the dollar on up to 6% of employee contributions from eligible compensation. The maximum Company match is 3% of employee eligible compensation and is payable each pay period.

The Company may also make profit sharing contributions to the participants’ accounts at its discretion. Profit sharing contributions are allocated based on the ratio that each eligible participant’s compensation bears to the total compensation paid to all eligible participants for the plan year. There were no profit sharing contributions in 2024.

Vesting: Participants are immediately vested in their 401(k) and rollover contributions plus actual earnings thereon. Vesting in employer matching contributions and related earnings is 100% immediate and vesting in nonelective employer contributions and related earnings is based on years of service with 100% vesting occurring after six years of service. Effective January 1, 2019, previous Interfilm Retirement Savings Plan employees hired prior to October 2010 were immediately vested in their employer contributions and related earnings.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, an allocation of the Company’s contribution, an allocation of the Plan’s earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled to is the benefit that can be provided from the participant’s vested account. The investment selection is determined by each participant. Participants receive quarterly statements detailing the activity in their accounts.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding notes receivable balance in the participant’s account during the prior 12-month period or (b) 50% of their vested account balance. Notes receivable terms range from one to five years or up to ten years for the purchase of a primary residence. The notes receivable are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator.

Withdrawals and Distributions: Upon retirement, death, disability, the attainment of age 59 ½, or termination of service, the participant or beneficiary is entitled to receive the vested balance in the participant's account in the form of a lump-sum distribution, installment payments, or transfer to another plan at the participant's discretion. In addition, participants may also request a distribution from their participant deferral contributions account in the event of a financial hardship as defined by the Plan.

Plan Termination: Although the Company has not expressed any intent to do so, it has the right to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

Forfeited Accounts: Forfeited nonvested accounts can be used to reduce the Plan's expenses or the Employer's contributions. During 2024, \$146 of forfeited balances reduced the Plan's expenses. At December 31, 2024 and 2023, unallocated forfeited accounts totaled \$7,988 and \$2,944, respectively.

Forfeited accounts will be restored to the participant if the participant (a) is reemployed by the Company before five consecutive one-year breaks in service and (b) repays the full amount previously distributed within the five-year period that begins on the date of reemployment.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company and are excluded from the financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, as further described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides for investment options in various mutual funds offered by Fidelity Investments, Inc. and certain other investments. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trust fund: The fair values of participation units held in the collective trust fund are based on the net asset values per unit as reported by the fund managers. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - TAX STATUS

The Internal Revenue Service has issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan has been amended since receiving the latest opinion letter. The plan administrator believes that the Plan is currently designed and being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. ERISA requires the disclosure of party-in-interest transactions.

The majority of the Plan's investments are shares of mutual funds managed by Fidelity Investments, Inc. and a collective trust managed by Fidelity Management Trust Company. Fidelity Investments, Inc. is affiliated with Fidelity Management Trust Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants are also party-in-interest transactions of the Plan. The Plan's payment of trustee fees, record keeping fees, and investment management fees qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 8 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through August 14, 2025, which is the date the financial statements were available to be issued.
