## Independent Auditor's Report

To the Plan Participants and the  
Administrator of the New Albany Company 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the New Albany Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. #### **1. Description of the Plan**

The following brief description of the New Albany Company 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **General**

On June 1, 1999, the Plan was originally adopted by The New Albany Company LLC (the “Company”) as a defined contribution plan, and amended and restated in its entirety effective January 1, 2013. The Plan includes the following companies (the “Employers”) at December 31, 2024:

The Plan covers substantially all the employees of the Employers who have met certain eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and is administered by The New Albany Company LLC. As of December 31, 2024 and 2023, John Hancock Life Insurance Company (U.S.A.) (the “Custodian”) held the Plan’s assets.

##### **Eligibility**

All employees who have attained the age of 21 and who have been credited with 1,000 hours of service within one year from their date of hire are eligible to participate in the Plan.

##### **Contributions**

Participants may contribute to the Plan on the basis of a flat amount per pay period, or as a percentage of compensation as tax deferred contributions, as defined in the Plan. Contributions from participants, and the related matching contributions, are recorded in the year in which the employee contributions are withheld from compensation. Participant deferrals are limited to maximum permitted amounts under the Internal Revenue Code (\$23,000 and \$22,500 for 2024 and 2023, respectively). For 2024 and 2023, participants who attain age fifty prior to the Plan year end are eligible to make catch-up contributions not to exceed \$7,500.

Participants may also make rollover contributions to the Plan from certain types of individual retirement accounts and annuities. The Employers provide a matching contribution of 100% of the first 3% and 50% of the next 2% of the participant’s voluntary contributions.

#### **Investments**

Participants direct the investments of their contributions and the matching contributions into the investment options offered by the Plan. The Plan invests in the John Hancock Group Annuity Sub Account Contract, which offers several investment options. The Plan's assets are invested in 63 and 64 Sub Accounts as of December 31, 2024 and 2023, respectively.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of an Employer's matching contribution, earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Vesting**

Participants are immediately and fully vested in their contributions and the Employer's matching contributions plus earnings thereon.

#### **Payment of Benefits**

The full value of a participant's account becomes payable upon retirement age of 65, disability or death. Upon termination of employment for any other reason, a participant's account to the extent vested, becomes payable. Benefits are payable in lump-sum payments, installments, or at the option of the participant, benefits can be paid through the purchase of a guaranteed annuity. In addition, the Plan includes a provision for participants to make withdrawals from their account under certain "hardship" circumstances. The Plan also provides for participants who have attained the age of 59 ½ to make a withdrawal from their account.

#### **Participant Loans**

Participants may borrow from the fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years, except for loans for residential purposes, which must be repaid on terms similar to bank loans on residential property. The loans are secured by the balance in the participant's account and bear interest determined by the plan administrator. Repayment of any loan must be made in equal installments at least quarterly and may be made through payroll deductions. The Plan administrator periodically reviews the loans for defaulted loans and determines if a reserve is required. At December 31, 2024 and 2023, there was no reserve for defaulted participant loans.

#### **Plan Termination**

Although the Company has not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time. The Company has the right at any time, by action of its Board of Directors, to terminate the Plan subject to provisions of ERISA. Upon Plan termination or partial termination, participants will become fully vested in their accounts.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis using fair value. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other administrative expenses include participant initiated expenses such as note receivable fees, administration fees, and distribution fees and are charged directly to the participant's account. Brokerage fees, transfer taxes, and other expenses incurred in connection with the investment of the Plan's assets will be added to the cost of such investments or deducted from the proceeds thereof, as the case may be.

Fees incurred by the Plan for the investment management services or recordkeeping are deducted from participants' accounts.

#### **Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

#### **Benefit Payments**

Benefits are recorded when paid.

#### 3. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, requires investments for which fair value is measured using net asset value per share as a practical expedient to not be categorized within the fair value hierarchy. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued at the respective net asset values (“NAV”) as reported by such account managers. The NAV, as provided by the account managers, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the accounts less their liabilities. This practical expedient is not used when it is determined to be probable that the accounts will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The Plan does not have any contractual obligations to further invest in these funds. See Note 8 below for discussion on restrictions. The pooled separate accounts primarily invest in mutual funds, except for a Stable Value Fund which invests into the John Hancock Stable Value Fund Collective Investment Trust.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan had \$19,517,877 and \$18,226,381 of investments held in pooled separate accounts through sub-accounts of the Custodian at December 31, 2024 and 2023, respectively.

The following pooled separate accounts are not in the fair value hierarchy table under ASC 820 and are presented for reconciliation purposes only.

- The target date pooled separate accounts seek high total return through its target retirement date, with a greater focus on income beyond the target date. At December 31, 2024 and 2023, the Plan held \$4,645,270 and \$3,553,041, respectively, of target date funds.
- The target risk pooled separate accounts seek a mix of growth and capital and reinvestment of income. At December 31, 2024 and 2023, the Plan held \$8,739,759 and \$7,573,918, respectively, of target risk funds.
- The aggressive growth and growth pooled separate accounts seek long term growth of capital. At December 31, 2024 and 2023, the Plan held \$746,348 and \$1,447,973, respectively, of aggressive growth funds. At December 31, 2024 and 2023, the Plan held \$3,348,305 and \$3,078,047, respectively, of growth funds.
- The growth and income pooled separate accounts seek long term growth of capital and income. At December 31, 2024 and 2023, the Plan held \$355,287 and \$507,998, respectively, of growth and income funds.
- The income pooled separate accounts seek to maximize return on investment. At December 31, 2024 and 2023, the Plan held \$988,757 and \$1,001,557 respectively, of income funds.

- The conservative pooled separate accounts seek to preserve principal and provide book value liquidity while maintaining a competitive rate of interest. At December 31, 2024 and 2023, the Plan held \$694,151 and \$1,063,847, respectively, of conservative funds.

#### **4. Unaudited Information Certified by the Plan Custodian**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and income (loss) from pooled separate accounts, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was prepared by or derived from information certified by the Custodian and furnished to the plan administrator. The plan administrator has obtained certifications from the Custodian that such information is complete and accurate within the meaning of CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

#### **5. Tax Status**

The Internal Revenue Service (the "IRS") has determined by letter dated March 29, 2013 that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and, accordingly, exempt from Federal income taxes. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended and restated since receiving the IRS determination letter to encompass all previous amendments. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effect of a tax position is recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **6. Plan Administration**

Three officers of the Employers are trustees of the Plan and received no fee.

#### **7. Parties-in-interest Transactions**

The Employers, which are parties-in-interest, provide certain administrative services to the Plan at no charge. The cost of providing these services constitutes exempt party-in-interest transactions under ERISA. John Hancock Life Insurance Company, under the group annuity contract, provides third party administrative services to the Plan for which the Plan is charged. The Plan is also serviced by an outside third party administrator, Pentegra Retirement Services that charges the plan fees which constitute exempt party-in-interest transactions.

**8. Restrictions**

The John Hancock Stable Value Fund contains a restriction that on request by the Employers to withdrawal from the fund there may be to up to a twelve-month hold on the assets or be subject to a market value adjustment. As of December 31, 2024, the Employers have not requested a withdrawal.

**9. Subsequent Events**

Effective May 2, 2025, the plan terminated the record keeping agreement with the Custodian and adopted an agreement with Empower Retirement, LLC (“Empower”). The agreement with Empower established a retirement plan under the Empower Retirement, LLC Defined Contribution Pre-Approved Plan. All funds were transferred from the Custodian to the Empower Retirement, LLC Defined Contribution Pre-Approved Plan on May 2, 2025. The plan also adopted a Trust agreement with Empower.

Subsequent events have been evaluated through May 28, 2025, the date the financial statements were available to be issued.
