## Notes to Financial Statements

### Note 1. Description of Plan

The following description of the Axiom Properties, Inc. 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering the employees of Axiom Properties, Inc. (the Company), as defined, and who are not subject to a collective bargaining agreement, considered a non-resident alien or a leased employee. Additionally, Axiom Properties, Inc.'s wholly owned subsidiaries have the option to join the Plan, pending the approval of their respective Board of Directors. Employees qualify to participate upon completion of a six-month service period, provided they have accrued a minimum of 840 hours and are 21 years or older. If an employee is unable to accumulate 840 hours within their first six months, the requirement shifts to a total of 1,000 hours within a year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may make pre-tax and Roth contributions, as defined by the Plan, subject to certain Internal Revenue Code (IRC) limitations. Upon fulfilling eligibility requirements, an employee will be automatically enrolled in the Plan at a 3% deferral percentage. Participants can opt out of participating or choose different deferral percentages. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan provides for the Company to make safe harbor matching contributions to the Plan equal to 100% of each participant's contribution, not to exceed 3% of the participant's compensation plus 50% on the next 2% of the participant's compensation contributed to the Plan.

The Company may make discretionary non-elective contributions. The Company did not elect to make any such additional discretionary non-elective contributions to the Plan for the year ended December 31, 2024.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan offers participants various pooled separate accounts and a group annuity contract as investment options.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions, as well as allocations of (a) any additional discretionary non-elective contributions and, (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions over a term not to exceed 5 years, or 15 years for loans used for the purchase of a primary residence.

## Notes to Financial Statements

### Note 1. Description of Plan (cont.)

**Vesting:** Participants are vested immediately in their contributions, the Company's safe harbor matching contributions, and actual earnings thereon. Vesting in the Company's discretionary contributions (and earnings thereon) are based on years of service. Participants vest over a 6-year graded schedule: 1 year-0%; 2 years-20%; 3 years-40%; 4 years-60%; 5 years-80%; 6 years-100%.

In the event of death, a participant becomes 100% vested.

**Payment of Benefits:** On termination of service due to death, disability, separation or retirement, a participant may elect to receive a lump-sum amount or partial withdrawals equal to the value of the participant's vested interest in his or her account. In addition, in-service withdrawals are allowed after participants reach age 59 ½ or in cases of financial hardship.

The Plan has the ability to make automatic distributions without participant consent for terminated participants who fail to affirmatively elect a distribution and have a vested account balance under \$5,000.

### Note 2. Summary of Accounting Policies

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

## Notes to Financial Statements

### Note 2. Summary of Accounting Policies (cont.)

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to distributions and the administration of notes receivable are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events:** The Plan has evaluated subsequent events through August 11, 2025, the date the financial statements were issued.

### Note 3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### Note 3. Fair Value Measurement (cont.)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) as reported by the account manager. The NAV practical expedient is based on the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The Plan has investments in multiple PSAs which invest in units of a mutual fund bearing the same name.

In accordance with Subtopic 820-10, all the Plan's investments were measured using NAV as a practical expedient and therefore have not been classified in the fair value hierarchy.

The following table sets forth disclosures of the Plan's investments whose fair value is measured using NAV as a practical expedient as of December 31, 2024 and 2023:

The objective of the pooled separate accounts is to maximize returns while maintaining an acceptable level of risk.

### Note 4. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Life Insurance Company (John Hancock), the custodian of the Plan.

## Notes to Financial Statements

### **Note 5. Fully Benefit-Responsive Investments**

The Plan entered into a fully benefit-responsive investment contract with John Hancock. Contributions made to the contract are through a group annuity contract, the John Hancock Stable Value Guaranteed Income Fund (the Fund). Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

John Hancock maintains the contributions in a general account. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset periodically.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The contracts do not permit the contract issuer to terminate the agreements prior to the scheduled maturity date.

### **Note 6. Related-Party Transactions and Party in Interest Transactions**

Certain Plan investments are shares of investment contracts managed by John Hancock. Administrative and recordkeeping fees of \$49,930 were paid to John Hancock in 2024. These transactions qualify as exempt party-in-interest transactions.

### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any Company contributions.

## Notes to Financial Statements

### **Note 8. Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
