### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Allison Transmission Employee Retirement Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Allison Transmission Employee Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of the Plan**

The following description of Allison Transmission Employee Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator. Any inconsistencies between the Plan Document and the *Summary Plan Description* would be governed by the Plan Document.

**General**

The Plan is a defined-contribution plan sponsored by Allison Transmission, Inc. (Company or Allison). The Plan was created for the benefit of its salaried non-union employees who were last hired or rehired on or after January 1, 2011. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company is the trustee of the Plan. The Company serves as Plan Administrator.

**Contributions**

The Plan permits eligible employees through a deferral election to have the Company make annual contributions of up to 75% of eligible compensation. The first 4% deferred by participants is considered "Basic Savings" contributions, while amounts deferred from 4% to 75% of eligible compensation are considered "Additional Savings" contributions. Employee rollover, catch-up, after-tax and Roth contributions are also permitted.

The Company makes matching contributions of 100% of employees' pre-tax, Roth and after-tax contributions up to 4% of employees' eligible compensation. Catch-up contributions, rollover contributions, flexible compensation contributions, special retirement contributions, 1% benefit contributions, 4% benefit contributions and qualified nonelective contributions are not subject to matching.

The Company makes a contribution equal to 4% of an employee's eligible compensation for employees who were hired by General Motors Corporation (GM) or Allison, have a beginning service date on or after January 1, 2001, and have completed three months of service (six months of service prior to January 1, 2011).

The Company also makes a contribution equal to 1% of an employee's eligible compensation for employees who were hired by GM or Allison, have a beginning service date on or after January 1, 1993, and who have completed three months of service.

The Plan includes an automatic deferral feature for eligible employees to be automatically enrolled into the Plan at a rate of 4% unless the participants make an affirmative election otherwise. Effective January 1, 2023, the automatic deferral feature also provides for an annual 1% increase in the percentage deferred and is ultimately capped at 10%. The automatic increase feature occurs annually as of the first payroll date following March 1, 2023 and each payroll date following March 1<sup>st</sup> thereafter.

**Participant Investment Account Options**

Investment account options available include various funds within the Allison Transmission Master Trust (Master Trust). Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses, as allowed by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their pre-tax, flexible compensation, pre-tax catch-up, after-tax, Roth, Roth catch-up, qualified nonelective, rollover, and special contributions plus earnings thereon. Vesting in their matching, 1% and 4% contributions plus earnings thereon is based on years of continuous service, age, or death. A participant is fully vested after three years of continuous service, including service with GM if a salaried transferred employee, or upon death or turning age 65. The nonvested balance is forfeited upon the earlier of a complete distribution of vested benefits due to a termination of service or five one-year breaks in service, whichever comes first. Forfeitures are used to reduce Company contributions and then to pay administrative expenses.

***Payment of Benefits***

Upon termination of service, a participant may elect to receive either a single lump-sum, partial withdrawal or installments equal to the value of his account. Withdrawals can also be made when a participant attains age 59½ or demonstrates financial hardship. An employee may withdraw all or a portion of his account balance attributable to after-tax and rollover contributions (excluding Roth rollover contributions) at any time. An employee may withdraw all or a portion of his account balance attributable to vested matching contributions, 1% benefit contributions, 4% benefit contributions, and special contributions and related earnings provided that either such contributions were contributed for 24 months or more preceding the month of withdrawal or the participant has at least 60 months of participation.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$25,847 and \$7,251, respectively. These accounts will be used to reduce future employer contributions and then pay administrative expenses. Also, in 2024 and 2023, employer contributions were reduced by \$1,013,018 and \$549,413, respectively, from forfeited nonvested accounts.

***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may have no more than three loans outstanding at any one time. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

***Subsequent Events***

Subsequent events have been evaluated through July 23, 2025, which is the date the financial statements were available to be issued.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

The Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses. Quoted market prices are used to value investments in the Master Trust. The fair value of the Plan's interest in the collective trusts in the Master Trust are valued at the net asset value per share (NAV) utilizing the practical expedient.

The New York Life Anchor Account is carried at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses. The objective of this fund is to provide investors stable returns and competitive rates over the long term. Redemption is at the discretion of the participants.

The Plan presents in its statements of changes in net assets available for benefits an allocation of the Master Trust's net appreciation in the fair value of its investments, which consist of realized gains or losses and unrealized appreciation or depreciation on those investments as well as interest and dividend income. This amount is reflected within the Plan's interest in Allison Transmission Master Trust investment income.

***Plan Tax Status***

The Plan obtained its latest determination letter on July 21, 2014, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses and Participant Revenue Credits***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Under the trust agreement, the Plan invests in certain investment products of the trustee that allow for a participant revenue credit each quarter.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Notes receivable from participants included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Master Trust**

The Plan's investments are in the Master Trust, which was established for the investment of assets of the Plan and one other Allison Transmission, Inc.-sponsored retirement plan. The Plan's investments are held by Fidelity Management Trust Company. The Plan's interest in the Master Trust's investment income is not proportionate to its interest in the net assets due to the ability of participants to select investment options within the Master Trust.

The Northern Trust S&P 500 Index Fund invests primarily in a portfolio of U.S. large-cap equities to approximate the risk and return of the S&P 500 Index. The Northern Trust Extended Equity Market Index Fund invests primarily in a portfolio of U.S. small and mid-cap equities to approximate the risk and return of the Dow Jones Index. The Fidelity Contrafund Pool Fund invests primarily in a portfolio of U.S. large-cap equities to approximate the risk and return of the S&P 500 Index with a focus on companies having strong long-term growth prospects. The Vanguard Target Retirement funds invests primarily in a portfolio of U.S. equities and bonds to adjust the risk and desired return based on estimated retirement dates.

**Note 5. Disclosures About Fair Value of Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include Master Trust mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 securities.

**Note 6. Contract With Insurance Company**

The Plan entered into a fully benefit-responsive investment contract with New York Life Insurance Company (New York Life) on June 4, 2019. New York Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal that is guaranteed to the Plan. New York Life also guarantees the interest rate to be no less than 0%.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the *Employee Retirement Income Security Act of 1974*. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 7. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan trustee. During 2024 and 2023, the Plan paid \$167,440 and \$158,306 of administrative fees to the trustee, respectively. There were no additional fees paid to parties-in-interest for 2024 and 2023, respectively. The revenue-sharing credits received from certain investments of \$84,970 and \$91,916 for the years ended December 31, 2024 and 2023, respectively, is netted with administrative expenses. The Company provides certain administrative services at no cost to the Plan.
