Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SIMPRO Software Limited 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of SIMPRO Software Limited 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General –

The Plan is a defined contribution plan covering substantially all employees of SIMPRO Software Limited. (the Company) as defined in the Plan agreement, who are at least age 18 and have completed three months of service. Union employees, leased employees, non-resident aliens and residents of Puerto Rico are not eligible to participate in the Plan. The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA). Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Merger and Transfer In –

Prior to the Plan's inception on January 1, 2023, the plan sponsor participated in a separate 401(k) plan that was administered through a professional employer organization (PEO). Effective January 18, 2023, the plan sponsor transferred all assets from the plan administered by the PEO to this Plan in the amount of \$916,050.

On December 31, 2022, the Board of Directors voted to merge the Clock Shark, LLC 401(k) Plan into the Plan effective January 1, 2023. Accordingly, all participants of the Clock Shark, LLC 401(k) Plan became participants in this Plan on that date. All plan assets from the Clock Shark, LLC 401(k) Plan were transferred into this plan on January 31, 2023, in the amount of \$1,662,033. Additionally, \$395 in residual plan assets were transferred into the Plan during the year ended December 31, 2024.

As a result of the merger and transfer in, the Plan recognized a transfer in totaling \$355 and \$2,578,083 in the accompanying Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023, respectively.

Contributions –

Each year, participants may contribute up to 100% of their eligible compensation, as defined in the Plan agreement, subject to the maximum amount allowed by the Code. Both pre-tax and Roth contributions are permitted under the Plan. The Plan has an eligible automatic contribution arrangement (EACA) whereby all participants hired on or after January 1, 2024, except those that make an affirmative election, are automatically enrolled in the Plan, unless they elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 4% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. With the approval of the plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions equal to 100% of eligible participant deferrals, up to 6% of each participant's eligible compensation contributed to the Plan. For the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions totaling \$865,588 and \$634,383, respectively.

1. DESCRIPTION OF PLAN (Continued)

Contributions (Continued) –

In addition, the Company may elect to make discretionary matching and profit-sharing contributions with the approval of the Company. Profit-sharing contributions are allocated to participants based on the ratio that each participant's plan compensation bears to the plan compensation of all eligible participants. For the years ended December 31, 2024 and 2023, there were no discretionary matching or profit-sharing contributions made to the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts –

Each participant's account is credited with the participant's elective deferral contributions, any rollover contributions, Company safe harbor matching contributions, as well as allocations of the Company's discretionary matching and profit-sharing contributions, if any, and Plan investment results. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances, or specific transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting –

Participants are immediately fully vested in their elective deferral contributions, the Company's safe harbor matching contributions and any rollover contributions made to the Plan, plus any actual earnings thereon. Vesting in discretionary matching and profit-sharing contributions, plus earnings thereon, varies based on hire date and prior employment.

Participants hired prior to January 1, 2023 are subject to 3-year cliff vesting. Participants hired after January 1, 2023 are subject to a 6-year graded vesting schedule, which is based on years of continuous service, as follows:

Special vesting provisions apply to former participants of the Clock Shark, LLC 401(k) Plan merged in, as defined in the Plan agreement.

Notes Receivable from Participants –

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are required to be repaid within five years unless the loan is to be used for the purchase of a primary residence in which case the note may be repaid within a period of no more than fifteen years. Participants may only have one outstanding loan at any time. The loans are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits –

Upon termination of service, retirement, disability or death, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account. A participant may withdraw from their rollover account at any time. A participant may also request an in-service withdrawal of all or any portion of their vested account balance upon attainment of age 59 ½. If a participant's account balance is greater than \$1,000 but equal to or less than \$7,000 (increased from \$5,000 effective January 1, 2024 under the SECURE 2.0 Act), the plan administrator can automatically rollover your entire vested account balance into a traditional individual retirement account (IRA). If a participant's account balance is less than \$1,000, the plan administrator can distribute the entire balance in a lump sum amount.

Hardship withdrawals are available from a participant's account, in order to meet a participant's immediate and heavy financial need, as defined in the Plan document.

Forfeitures –

Forfeitures are used to pay Plan expenses or offset future Company contributions to the Plan. As of December 31, 2024 and 2023, the Plan had available forfeitures of \$397 and \$1,051, respectively. For the year ended December 31, 2024, \$6,345 was used to reduce Company contributions. For the year ended December 31, 2023, no forfeitures were used to reduce Company contributions. For the years ended December 31, 2024 and 2023, no forfeitures were used to pay Plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting –

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates –

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition –

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor, trustee and other third parties.

Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants –

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants, if applicable, are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits –

Benefits are recorded when paid.

Administrative Expenses –

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Managed account services fees as well as fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Date of Management's Review –

The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts:

Valued daily based upon the units of such pooled separate accounts held by the Plan at year end multiplied by the respective accumulation unit value (AUV). The AUV is determined daily based on the net asset value (NAV) of shares of the underlying fund, the fund's dividends and the contract's separate account charges. The NAV is a readily determinable fair value of the underlying assets and is the basis for current transactions.

Common/collective trusts:

Valued daily based upon the fair value of the underlying assets held which is determined using the NAV per unit as provided by the trustee of the fund. The valuation is based on observable market inputs and does not involve significant unobservable inputs or assumptions. There are no restrictions on the Plan's ability to redeem its investment in the CCT at NAV at the measurement date. The NAV is a readily determinable fair value of the underlying assets and is the basis for current transactions.

4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company. Amounts allocated to the Voya Fixed Account are held in the insurance company's general account, and there are no segregated or identifiable assets ascribed to the Plan's investment. Net deposits and interest credited become liabilities against Voya Retirement Insurance and Annuity Company on the Plan's behalf. The crediting interest rate is set by Voya Retirement Insurance and Annuity Company but may not be less than 1% annually. At December 31, 2024 and 2023, the crediting interest rate was 2%. The crediting rate is declared in advance and is reset quarterly. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. Contract value is guaranteed by the full faith and credit of Voya Retirement Insurance and Annuity Company.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measure attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported by Voya Retirement Insurance and Annuity Company, represents contributions made under the contract, less participant withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (Continued)

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Company may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

5. INFORMATION PREPARED AND CERTIFIED BY PLAN'S CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

7. TAX STATUS

The Plan has adopted a prototype plan and relies on the prototype plan's favorable opinion letter from the Internal Revenue Service dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained up on examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all Company contributions.

9. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

10. PROHIBITED TRANSACTIONS

Under U.S. Department of Labor Regulation Section 2510.3-102, Plan related salary deferrals and loan repayments withheld from employees' paychecks must be deposited into the Plan as soon as reasonably possible, but in no event later than the fifteenth business day of the month following the Company's withholding. When this regulation is not satisfied, the Company has engaged in a prohibited transaction.

For the year ended December 31, 2023, the Company engaged in prohibited transactions by remitting \$336,576, in deposits to the Plan after the required reporting period. The Company has taken corrective action during the 2024 Plan year related to all prohibited transactions for the identified late participant contributions.
