## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of R. H. Barringer Distributing Co., Inc. Employees' Retirement Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits, as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank, similar institution, or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank, similar institution, or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution, Fidelity Management Trust Company ("the Trustee"), as of December 31, 2024 and 2023, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section –

- The amounts and disclosures in the financial statements, other than those agreed to, or derived from, the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the financial statements related to assets held by, and certified to by, a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). **A. DESCRIPTION OF THE PLAN**

The following description of the R. H. Barringer Distributing Co., Inc. (“the Company”) Employees' Retirement Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General.** The Plan is a defined contribution plan for which all employees are eligible after completing three (3) consecutive months of employment. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).
2. **Contributions.** Participants may contribute a portion of their annual wages, not to exceed \$23,000 and \$22,500 for 2024 and 2023, respectively (adjusted annually), plus \$7,500 additional catch-up for age fifty (50) and over, for the years ended December 31, 2024 and 2023, respectively. The employer will contribute a matching amount based on a percentage of the participant's compensation as determined each year. In addition, the employer may contribute an amount or percentage of its net profits referred to as the employer's discretionary additional contribution.
3. **Participants' Accounts.** Each participant's account is credited with the participant's contribution and an allocation of: (1) the Company's contribution and (2) the Plan earnings. Allocations are based on particular earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
4. **Vesting.** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer's matching contributions and discretionary additional contribution is based on years of continuous service with 100% vesting after three (3) years of credited service.
5. **Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2.00% as published in the Wall Street Journal. At December 31, 2024 and 2023, outstanding loans bore an interest rate of 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. The term of the loan may not exceed five (5) years unless the loan is used to purchase a participant's principal residence.
6. **Payment of Benefits.** Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options, as provided by the Plan, if the participant has reached normal retirement age of sixty-five (65). If the participant terminates and takes distribution prior to normal retirement age, then consent is required from the participant to distribute accounts in excess of \$7,000. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant may withdraw funds from their account prior to termination if they have attained the age of sixty (60), or they have incurred a financial hardship or disability. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participant reaches the age of fifty-nine and one-half (59.5) years.
7. **Forfeited Accounts.** As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,112 and \$101,397, respectively. These accounts are used to reduce administrative expenses or employer contributions.

**B. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

**Investment Valuation and Income Recognition**

Investments in mutual funds are reported at fair value except for fully benefit responsive investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in common collective trusts that are not fully benefit responsive, are reported at net asset value ("NAV"). The Plan's management determines the Plan's valuation policies utilizing information provided by Fidelity Management Trust Company ("the Trustee"). See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through August 11, 2025, the date the financial statements were available to be issued.

**C. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**D. RELATED PARTY TRANSACTIONS**

Certain Plan investments are income-based and equity-based mutual funds managed by the Trustee; therefore, as defined by the Plan, these transactions qualify as party-in-interest transactions.

**E. TAX STATUS**

The Company obtained the latest determination letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Company has not obtained a determination letter from the IRS since that date. The Company is relying on the IRS approval of the prototype (or volume submitter) plan that it is utilizing. The IRS has determined and informed the document sponsor by letter dated June 30, 2020, that the prototype (or volume submitter) plan document was designed in accordance with applicable sections of the IRC. The Plan sponsor believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt under present income tax law. Therefore, no provision for income taxes has been included in the Plan's financial statements.

As of December 31, 2024, management believes there are no uncertain tax positions.

As of December 31, 2024, and including the previous three (3) years considering extensions, the Plan's Form 5500 is open and subject to examination by tax authorities with relevant jurisdiction. Should such an examination take place, management does not anticipate any significant issues related to the open years.

**F. CERTIFIED INVESTMENTS**

All information related to investments and notes receivable from participant disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee.

**G. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Codification establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three (3) levels of the fair value hierarchy under the Codification are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liabilities;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

**Cash money market:** Valued at the closing price reported on the active market.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified as Level 1.

**H. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**I. SECURE 2.0**

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0." These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

**J. SELF CORRECTION PROGRAM**

The Company will take remedial action under Self Correction Program ("SCP") with the IRS to address a failure related to the Plan's delinquent contributions.

**K. PROHIBITED TRANSACTIONS**

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. The Plan has contributions totaling \$107, all of which represented employee salary deferrals, that were not remitted timely. These contributions are considered prohibited transactions. The company will calculate lost investment earnings and file Form 5330, as applicable, and expects to compensate the Plan for the lost earnings in 2025.
