Note 1 - Plan Description

The following description of Ensign United States Drilling, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1992 and most recently amended effective January 1, 2020. The Plan is available to all employees who have completed six months of service and are age 18 or older. Employees may enter the Plan on the first day of each calendar quarter subject to meeting the service and age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan covers employees from the following companies: Ensign United States Drilling (California) Inc.; Ensign US Southern Drilling LLC; Oilfield Supply Inc. (dba OFS Global Inc.); Ensign Services LLC; Ensign United States Drilling, Inc.; and Ensign United States Drilling (S.W.), Inc.

The 401(k) committee of Ensign United States Drilling, Inc. (the "Company") administers the Plan. Charles Schwab Trust Bank (Schwab) serves as trustee, manages plan assets, and maintains the Plan's records. Schwab offers plan participants a variety of investment options through mutual funds and a common/collective trust. Individual accounts are invested in the various investment options at the direction of participants.

Contributions

The Plan provides for employee before-tax or after-tax salary deferral contributions up to a maximum of 70 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The maximum percentage may be reduced by the plan administrator in certain circumstances. Additional catch-up contributions are available to any participant who is age 50 or older and has made the maximum contribution for the year. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Participant contributions to the Plan are made through regular payroll deductions. Participants may change their elective deferred contributions on the first day of each quarter.

Participants are eligible to defer on an after-tax basis through payroll deductions as Roth 401(k) deductions. Provided requirements are met, withdrawals of contributions and earnings are tax free. A participant's combined pretax and after-tax contributions cannot exceed the maximum annual amount allowed by law.

The Plan has elected 401(k) safe harbor provisions, and the Company contributed 100 percent of elective deferrals up to 3 percent and 50 percent of additional elective deferrals up to 5 percent of eligible annual compensation for the 2024 plan year, which is not to exceed 4 percent of total elective deferrals for the plan year. These contributions are calculated on total annual compensation. Qualified matching contributions are nonforfeitable and generally may not be withdrawn from the Plan prior to separation from service or attainment of age 65. The Company may elect, at its sole discretion, to make an additional profit-sharing contribution to the Plan. Profit-sharing contributions are allocated to participants pro rata based on total participant compensation for the plan year. No additional profit-sharing contributions were made for the 2024 plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants' contributions, the employer match contribution, and the employer discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. During 2014, participants could not have more than two loans outstanding at any time. Effective January 1, 2015, the Company amended the loan policy to allow for only one loan outstanding at any time. Any participant with two loans outstanding as of December 31, 2014 was able to maintain those two loans until the original maturity date. The notes receivable are secured by the balance in the participant's account and bear interest at rates from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions with a maximum repayment term of 5 years, unless the loan was used to acquire real estate that serves as the participant's primary residence, which may be repaid over a period of up to 15 years. The loans mature at various dates through June 2039.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation

The Plan's investments are stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying net assets. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 5, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Charles Schwab Trust Bank (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Note 5 - Fair Value Measurements (Continued)

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
