Opinion

We have audited the financial statements of Baptist Health 403(b) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of Baptist Health 403(b) Plan (Plan) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan is a defined-contribution plan sponsored by Baptist Health (Company) for the benefit of its employees and related participating employers. The Plan became effective January 1, 2009. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Company. Participants will receive predecessor employer service credit for prior employment with affiliate companies.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Milliman, Inc. serves as the recordkeeper of the Plan, while Charles Schwab Trust Bank serves as the Plan's trustee.

Contributions

The Plan permits employees, through a salary deferral election, to have the Company make annual pre-tax, Roth, or after-tax contributions of up to 75% of eligible compensation. This will be maxed at the annual IRS contribution limit. Participants who have attained the age of 50 or over by the end of the plan year are eligible to make catch-up contributions.

The plan document includes an automatic deferral feature, whereby a participant is treated as electing to defer 4% of eligible compensation unless the participant made an affirmative election otherwise. This is reviewed by the retirement committee annually. Effective December 1, 2023, the Plan was amended to increase the automatic enrollment percentage for withholding for new participants to 6% of eligible earnings. Effective January 1, 2024, the Plan was amended to automatically escalate all employee contributions to 6% of eligible earnings.

Participant Investment Account Options

Investment account options available include various mutual funds and a personal choice retirement account (self-directed brokerage). Each participant has the option of directing contributions into any of the investment account options selected by the Plan and may change the allocation to the extent permitted by the individual agreements.

Participant Accounts

Each participant's account is credited with the participant's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon.

Payment of Benefits

Upon termination of service, an employee may elect to receive a lump-sum amount equal to the value of his or her account, a rollover to an eligible retirement plan, or a partial distribution limited to one per year. At December 31, 2024 and 2023, there were no plan assets allocated to accounts of terminated or retired participants who have elected to withdraw from the Plan but have not yet been paid.

Effective January 1, 2024, participants may take a hardship withdrawal up to \$3,500 and hardship withdrawals will be limited to three in a plan year.

Notes Receivable From Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000, or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years, except for loans for the purchase of a principal residence, through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan's interest in Master Trust income includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs.

The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities that the entity can access at the measurement level
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Recurring Measurements

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. Level 1 investments include mutual funds and self-directed brokerage accounts. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy.

Note 4. Interest in Master Trust

The Plan's assets are commingled in a Master Trust with the assets of another plan sponsored by the Company. Each participating retirement plan has a divided interest in the Master Trust. The assets of the Master Trust are held by Charles Schwab Trust Bank.

The value of the Plan's interest in the Master Trust is based on the beginning-of-year value of the Plan's interest in the Master Trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. Net assets, investment income, and administrative expenses relating to the Master Trust are allocated to the participating plans based upon each plan's relative interest in the assets held in the Master Trust.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$716,075 and \$592,371 of fees to the recordkeeper and trustee during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Certain plan investments are units of mutual funds managed by Charles Schwab Trust Bank, which is a trustee as defined by the plan agreement. Therefore, these transactions qualify as party-in-interest transactions.

Note 6. Tax Status

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code (IRC) of 1986, as amended. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and not subject to tax.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances, and the amounts reported in the accompanying statements of net assets available for benefits.

Note 8. Nonexempt Transaction

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. The Company has deemed \$226 as delinquent participant contributions as of December 31, 2023. The Company remitted all participant contributions to the Plan. The Company identified and fully corrected \$226 of the delinquent contributions and fully corrected the lost earnings through the Voluntary Fiduciary Correction Program (VFCP) in 2024.

Note 9. Subsequent Events

Effective January 1, 2025, participants turning 60, 61, 62, or 63 by December 31, 2025 can make catch-up contributions of up to \$11,250.

Subsequent events have been evaluated through June 16, 2025, which is the date the financial statements were available to be issued.
