Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Autarkic Holdings, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Autarkic Holdings, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a participant-directed defined contribution plan established on July 1, 1968, by Autarkic Holdings, Inc. (the “Company,” the “Employer,” or the “Plan Sponsor”). The Plan provides eligible employees who have completed at least one month of service and have reached 21 years of age, with a means to save for retirement. It also provides certain benefits in the event of death, disability, or other termination of employment. Fidelity Management Trust Company (“Fidelity” or the “Trustee”) is the Plan’s Trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has appointed the Administrative Committee to oversee the operation and administration of the Plan. Fidelity serves as the Plan’s directed trustee and asset custodian and an affiliate of Fidelity provides record-keeping services and manages participant accounts and participant related transactions.

Contributions

Participants may contribute up to 75% of pre-tax eligible compensation, as defined in the Plan, up to the maximum amount permitted by tax laws. The Plan contains an automatic enrollment feature. Participants that are subject to automatic enrollment will be notified approximately 30 days prior to when the Employer will begin to automatically deduct 3% from the participant’s pay on a pre-tax basis as a deferral contribution to the Plan. Participants may also elect to make Roth contributions, on an “after tax” basis, to the Plan and may contribute amounts representing distributions from other qualified plans (rollovers). Participants may stop or change this automatic contribution by following the instructions in the notice. The Plan provides for safe harbor contributions based on a percentage of a participant’s compensation. For the year ended December 31, 2024, the Company made safe harbor matching contributions in an amount equal to 100% of the first 3% of participants’ eligible compensation, and 50% of the next 2% of participants’ eligible compensation which totaled \$547,371. The total contributions of the Company and participants for any Plan year cannot exceed the lesser of (1) 100% of the participants’ compensation or (2) maximum allowable by the Internal Revenue Code (“IRC”).

The Plan also provides for discretionary, qualified non-elective contributions (“QNECs”) for all eligible participants which for the years ended December 31, 2024 and 2023 totaled \$400,604 and \$349,588, respectively.

Participant Accounts

Each participant’s account is credited or charged with the participant’s contribution and allocations of (i) employer’s 401(k) matching contributions and (ii) the participant’s share of earnings or losses on contributions and administrative expenses. Each participant directs all amounts credited into their account into one or more of the investment options available under the Plan. Accordingly, as a participant-directed plan, each participant’s investments determine their share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, rollovers and safe harbor matching contributions plus actual earnings thereon. Vesting in employer’s QNECs plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in employer QNEC contributions and earnings thereon after six years of credited service.

Investment Options

Participants direct the investment of their contributions, into various investment options offered by the Plan. Participants may change their contribution investment options daily and may transfer part or all of past investments to other investment options daily. Participants may also elect to change their percentage daily.

Notes Receivable from Participants

Participants may borrow from their vested fund account balance a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested interest of the participant in the Plan or \$50,000 reduced by the highest outstanding loan balance in a participant’s account during a twelve-month period. All loans from plans maintained by the Employer are considered for the purposes of determining the maximum amount of a participant’s loan. A participant may use up to 50% of their vested account balance as collateral for any loan. A participant may have no more than two loans outstanding at any time. All loans are required to be repaid through after-tax payroll deductions. However, if a repayment is not made by payroll deduction, it must be repaid in level payments on at least a quarterly basis within five (5) years from the date of the loan or up to ten (10) years for the purchase of a principal residence. The loans are secured by the balance in the participant’s account and bear interest at a fixed rate that is set at the date of the loan. Loans mature through November 2029 with fixed interest rates of 6.00%.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. However, if the participant is re-employed and fulfills certain requirements as defined by the Plan, the participant’s account will be reinstated. Unused forfeitures may first be used to reduce administrative costs of the Plan. Any remaining amounts will be used to reduce future employer matching contributions. The amount of forfeitures used to reduce employer matching contributions were \$27,081 for the year ended December 31, 2024.

Hardship and In-Service Withdrawals

Participants may apply to withdraw certain contributions to satisfy specific and heavy financial needs after first exhausting all other assets reasonably available including any in-service withdrawals available. The minimum hardship withdrawal is \$500. Participants who have reached age 73 or older may elect to receive distributions calculated in the same manner as Required Minimum Distributions. Participants may elect to withdraw all or a portion of their rollover contribution account balance. There is no limit on the number of withdrawals of this type. In-service withdrawals from specified accounts shall be available to participants that meet the following requirements: age 55 with 25 years of service for participants employed on or before June 19, 2003 from vested Profit Sharing. Participants that performed qualified military service for a period of 30 days or more may elect to withdraw certain contributions defined in the Plan during their active duty period. They will be suspended from making contributions for 6 months following the distribution.

Benefit Payments

Upon termination of service due to death, disability or retirement, as defined in the Plan, participants are entitled to a fully vested lump sum payment of their account balance. For termination of service due to other reasons, participants are entitled to the value of the vested interest in their account as a lump-sum distribution. Participant accounts not exceeding \$1,000 shall be paid in an immediate single, lump-sum payment. As of December 31, 2024, all employees who elected to withdraw from the Plan had been paid.

Expenses of the Plan

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Substantially all administrative expenses are paid by the Plan Sponsor. The Plan Sponsor is under no obligation to pay such expenses.

Deemed Distributions

When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. Deemed distributions on defaulted loans are recorded in the calendar quarter following the calendar quarter during which the loan was defaulted.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

All Plan investments are held by the Trustee. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4 for a discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as components of net appreciation or decline in fair market value of investments for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023 as the notes are collateralized by the participant's account balance. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. At December 31, 2024, there were no deemed distributions.

Participant and Employer Contributions

Participant and Employer contributions are included in additions to net assets during the period in which the Employer records the related liabilities.

Payment of Benefits

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through the date these financial statements were available for issuance, August 5, 2025.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in the fair value of the investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds and mutual funds: Valued at the daily closing prices as reported by the Fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – EXEMPT PARTY-IN-INTEREST

At December 31, 2024, certain Plan investments were managed by Fidelity and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to the Trustee were \$1,775 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 6 – TAX STATUS

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a Cash or Deferred Arrangement (“CODA”) sponsored by Fidelity Management Research Co. which received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, as to the Plan's qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and accordingly no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to tax examinations for years prior to 2021.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
