Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform the audits of the financial statements of The White Mountain School DC Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets in liquidation as of November 30, 2024 and December 31, 2023, and the related statement of changes in net assets in liquidation for the 11 month period ended November 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as November 30, 2024 and December 31, 2023, and for the 11 month period ended November 30, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of The White Mountain School DC Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Emphasis of Matter - Terminating Plan

As further discussed in Note 6 to the financial statements, the plan's sponsor, elected to terminate the plan as of June 30, 2024. In accordance with accounting principles generally accepted in the United States of America, the plan has changed its basis of accounting from the ongoing plan basis to the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Basis for Disclaimer of Opinion

As described in Note 10, the Plan has excluded from investments in the accompanying statements of net in liquidation, certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. If the identified contracts, as reported by the Custodian, were included, net assets in liquidation would increase by approximately \$3,432,500 and \$3,557,000 as of November 30, 2024 and December 31, 2023, respectively. Furthermore, investment income and distributions would increase approximately \$852,000 and \$719,000, respectively, for the 11 month period ended November 30, 2024. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Because of inadequacies in the Plan's prior year records, we were unable to perform sufficient auditing procedures with respect to individual participant account balances accumulated from inception of the Plan or to satisfy ourselves as to the basis on which participants' equity is stated as of November 30, 2024 and December 31, 2023, or the propriety of the distributions to participants who terminated and withdrew from the Plan during the 11 month period ended November 30, 2024.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the liquidation basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of The White Mountain School DC Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of The White Mountain School DC Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Significant Accounting Policies

Valuation of investments: The White Mountain School DC Retirement Plan (the "Plan") investments in registered investment companies and pooled separate accounts that are reported at fair value. Investments in fixed annuity contracts that are non-benefit responsive are reported at contract value which approximates fair value. Investments in fixed annuity contracts that are benefit responsive are reported at contract value. See Note 3 for discussion on fair value measurements.

The changes in the difference between its value and the cost of investments and realized gains and losses are reflected in the statement of changes in net assets in liquidation as realized and unrealized appreciation or depreciation, in the value of investments.

Accounting method: The Plan has prepared its financial statements on the liquidation basis of accounting as the Plan Sponsor has elected to terminate the Plan as discussed in Note 2. This basis of accounting is considered appropriate when liquidation of a Plan is imminent. Under this basis of accounting, assets are valued at the estimated amount of cash or other consideration that the Plan expects to collect in settling or disposing of those assets in carrying out its plan for liquidation, and liabilities are stated at their estimated settlement amounts.

Estimates and assumptions: The preparation of financial statements requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and changes therein, and the disclosure of contingent assets. Accordingly, actual results may differ from those estimates.

Payment of benefits: Benefits are recorded when paid.

Note 2. Description of the Plan

The following description of the Plan provides only general information. Further information about the Plan Document and benefit provisions is available from the Plan Administrator.

General: The Plan is a defined contribution plan qualifying under section 403(b) of the Internal Revenue Code (IRC). The Plan covers all employees of the Plan Sponsor, White Mountain School (the "School"). The Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The School is also the Plan Administrator. TIAA-CREF is the Plan's Custodian. The Plan was last restated effective October 1, 2017. Effective June 30, 2024, the Plan Sponsor elected to terminate the Plan with all assets being effectively distributed as of November 30, 2024.

Contributions: Employees are immediately eligible to enter into the Plan. Participants have the ability to make pre-tax or after-tax elective ("deferrals") upon entering the Plan. Employees can also rollover amounts representing distributions from other qualified benefit or contribution plans. Participants over the age of 50 are eligible to make catch-up contributions. Participants with fifteen years of service may make special long service catch-up contributions.

NOTES TO FINANCIAL STATEMENTS

With the exception of coaches and dance instructors, after three months of service, an employee becomes eligible to receive employer matching contributions. During 2023, the Plan sponsor reinstated the employer contributions. The Plan Sponsor provides a discretionary contribution where Participants who have three months of employment are eligible for the School's contributions of 3-5% (3% Employer contribution is made for employees who contribute less than 3%; and 5% Employer contribution is made for employees who contribute 3% or higher).

The entry date for employees becoming eligible for the match are the first day of each calendar month. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's deferral and allocations of (a) the school's contributions, if any, and (b) Plan earnings and charged with an allocation of administrative expenses.

Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account. Participants direct their account balances among various investment options.

Taxes: Participants are not taxed on their pre-tax deferrals, on the employer contributions allocated to their accounts, or on earnings thereon until these amounts are distributed. Roth elective deferrals are contributed on after-tax basis. Roth contributions and earnings thereon are not subject to tax upon distribution provided they meet IRS guidelines.

Vesting: Participants are vested immediately in their contributions and employer contributions plus actual earnings thereon.

Investment options: Upon enrollment in the Plan, a participant may choose to direct deferrals and School contributions to any combination of registered investment company, a pooled separate account, or fixed annuity contracts. Participants may change their investment options and transfer funds between investments daily. Transfers from the fixed annuity account are restricted in accordance with the payment provisions of the underlying insurance contracts.

Participant notes receivable: Participants may borrow from the Plan a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their account balance, subject to certain plan provisions. Note repayments (borrowings) are treated as a transfer to (from) the investment fund from (to) the notes receivable account. Note terms range from one to five years (ten years for the purchase of a primary residence). The notes are collateralized by the balance in the participant's account and bear interest at the Prime Rate plus 1% (8.75% at November 30, 2024). Principal and interest are paid ratably through payroll deductions. Participants may only have one outstanding note at any time.

Payment of benefits: On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account; roll over to a qualified plan or to an individual retirement account (IRA), Qualified Joint and Survivor Annuity or Single Life Annuity if over minimum of \$5,000; or receive monthly, quarterly, or annual installments. Participants also have the ability to take in-service withdrawals on vested balances. Hardship distributions are permitted on elective deferrals and any amounts that have been rolled over into the Plan. Individual agreements governing certain investment options in the Plan may further restrict distribution of benefits.

NOTES TO FINANCIAL STATEMENTS

Funding policy: Deferrals are withheld from the wages of eligible participants. These deferrals and the School discretionary contributions are remitted to the Plan Custodian each pay period. All contributions are invested based on the instructions provided by the participant.

Income tax status: The White Mountain School has adopted a volume submitter 403(b) plan agreement sponsored by TIAA. The Plan is required to operate in conformity with the IRC to maintain its tax-exempt status. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The Plan adopted the provisions of FASB ASC 740, Accounting for Uncertainty in Income Taxes. Accordingly, management has evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status, does not have any significant unrelated business income and had taken no uncertain tax positions that require adjustment or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the Federal authorities for years before 2021.

Note 3. Fair Value Measurements

The Fair Value Measurement of the FASB Accounting Standards (FASB ASC 820-10) provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs are other than quoted prices that are observable for the asset or liability. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTES TO FINANCIAL STATEMENTS

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies: Consist of mutual funds which are valued daily using market quotations or prices obtained from independent pricing sources. Investments in money market accounts are valued at amortized costs. Each account determines its unit value on a daily basis.

Pooled separate accounts: Valued daily using quoted prices which are based on the market value of the underlying real estate holdings. Real estate holdings are valued using external appraisals conducted by independent professionals.

Fixed non-benefit responsive annuity contracts: The non-benefit responsive portion of TIAA Traditional Annuity is valued at the accumulation of all cash contributions and interest credited to the Plan's contracts (contract value) which approximates fair value based on the assumption that the fair market value of a fixed annuity contract can be little more or little less than the value at which all purchases and settlements occur (contract value).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at November 30, 2024 and December 31, 2023.

As stated in Note 2, all plan assets were effectively distributed from the Plan as of November 30, 2024.

Realized and unrealized gains related to fixed annuity contracts are included in net realized appreciation in the fair value of investments on the accompanying statement of changes in net assets in liquidation.

Note 4. Guaranteed Annuity Contracts

Investments in the TIAA Traditional Annuity are in a guaranteed annuity contract. Interest credited to the investment includes a guaranteed rate plus additional amounts established on a year-by-year basis. The fully benefit responsive contract is included in the financial statements at contract value as reported to the Plan by TIAA-CREF. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

The investment provides for non-benefit responsive and fully benefit-responsive contracts. There are no reserves against contract value for credit risk of the contract issuer or otherwise. For the 11 month period ended November 30, 2024, the average yield and crediting interest rate for the non-benefit responsive and fully benefit-responsive contracts were approximately 3%. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting.

Note 5. Costs and Expenses

A majority of the costs and expenses associated with the operations of the Plan were paid by the participants for the 11 month period ended November 30, 2024.

Note 6. Plan Termination

The Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Effective June 30, 2024, the Plan Sponsor elected to terminate the Plan. As of November 30, 2024, the Plan effectively distributed all Plan assets.

Note 7. Transactions with Parties in Interest

The Plan Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged. The employees that provide these services also are contributing participants in the Plan. These transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. However, under the provisions of ERISA these transactions meet the criteria for exemption, are not considered prohibited transactions, and do not need to be reported in the supplementary schedules of Form 5500.

The Plan invests in fixed annuity contracts, registered investment companies, and pooled separate accounts managed by TIAA-CREF. TIAA-CREF acts as custodian for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Note 8. Risk and Uncertainties

The Plan provides for a combination of various investment options. Investments are exposed to various risks, such as interest rate, credit and market. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amount reported in the statements of net assets in liquidation and the statement of changes in net assets in liquidation.

Note 9. Information Certified by the Plan's Custodian

The Plan Administrator has elected the methods of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA-CREF have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

Note 10. Participants Separated Prior to 2009

On July 20, 2009, the DOL issued Field Assistance Bulletin (FAB) 2009-02 and subsequently supplemented it with FAB 2010-01. The FABs provide that for Form 5500 reporting, 403(b) plans subject to ERISA need not treat annuity contracts and custodial accounts as part of the Plan, provided; the contract or account was issued to a current or former employee before January 1, 2009, the employer ceased to have any obligation to make contributions, and all of the rights and benefits under the contract or account are legally enforceable against the insurer or custodian by the individual owner of the contract or account without any involvement of the employer.

The Plan Sponsor has elected to remove these participants and related earnings from the net assets in liquidation, the changes in net assets in liquidation and the related supplemental schedule.

Note 11. Subsequent Events

The Plan has evaluated subsequent events through July 20, 2025, the date which the financial statements were available to be issued. No other subsequent events were identified that would require disclosure in the financial statements for the 11 month period ended November 30, 2024.



