1. Description of Plan

The following description of Freebird Desert Mountain Company, LLC Group Health Benefit Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established March 1, 2023 and provides various healthcare benefits to eligible employees of Freebird Desert Mountain Company, LLC DBA Pella Windows and Doors Mountain West (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Substantially all employees of the Plan Sponsor are eligible to participate in the Plan. Dependent coverage is also available to eligible employees. Employees who undergo a qualifying event as stated in the Plan document may elect to continue coverage in the Plan and may continue to participate pursuant to the Consolidated Omnibus Budget Reconciliation Act (COBRA) for a maximum period of 36 months.

Contributions

Annually, the trust administrator determines the gross premium for each option and management determines the amount contributed by employees.

Stop-Loss Coverage

The Plan has stop loss coverage that provides reimbursement for claims in excess of \$80,000 and \$75,000 per individual and aggregate claims in excess of the accumulated attachment point in 2024 and 2023, respectively. The maximum aggregate benefit limit is \$1,000,000 in 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, claims incurred but not reported, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Claims Payable

Claims payable include the Plan's liability for claims incurred, but not reported. The Plan's liability for claims incurred, but not reported is estimated by the Plan's trust administrator, The Benecon Group, LLC, who takes into consideration prior claims experience and the expected time period from the date such claims are incurred to the date that the related claims are submitted and paid.

Administrative Expenses

Substantially all administrative expenses are paid by the Plan.

Cash

The Plan maintains its cash in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan believes it is not exposed to any significant risk on cash.

Subsequent Events

For purposes of the preparation of these financial statements in conformity with U.S. GAAP, management has considered transactions or events occurring through August 13, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Tax Status

The Plan Sponsor management and the Plan administrator believe that the Plan is currently designed and operated as a grantor trust in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in these financial statements.

4. Plan Termination

The Plan may be amended at any time and in any manner by the Plan Sponsor. While the Plan Sponsor intends to continue the Plan indefinitely, it reserves the right to terminate all or part of the Plan at any time and cancel all or part of the coverage and benefits under the Plan for current and future employees or retirees. In no event will the Plan Sponsor cause any portion of the Plan's assets to be used for purposes other than for the exclusive benefit of participants and their beneficiaries (including payment of reasonable expenses for administering the Plan), nor may any portion of the Plan's assets become the property of the Plan Sponsor unless provisions have been made for all of the Plan's liabilities, including incurred but not reported claims.

5. Party-In-Interest Transactions

During 2024, certain Plan benefits were managed by Employee Benefits International, Plan broker; The Benecon Group, LLC, the trust administrator; UMR, the claims administrator; and ConnectCare3, the patient advocate. The broker, trust administrator, claims administrator, and patient advocate are considered parties-in-interest. These transactions have been approved in advance by the Plan sponsor. The Plan made direct payments to Employee Benefits International, The Benecon Group, LLC, UMR, and ConnectCare3 of \$72,800, \$24,373, \$64,455, and \$7,950, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
