Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the TOMS 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by TOMS Shoes Inc. (the “Company”) on April 1, 2011. It covers substantially all full-time employees of the Company who are age of 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated on January 1, 2021 to bring plan into compliance with the legislative and regulatory changes as part of the six-year pre-approved plan restatement cycle. Employees must complete two months of service to be eligible to participate in the plan.

Contributions: Each year, participants may contribute pre-tax 401(k) or Roth 401(k) contributions up to 100 percent of pretax annual compensation, as defined in the Plan, not exceeding the maximum IRS limitation and subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The plan is a safe harbor plan and therefore, the Company contributed an amount equal to 100 percent of participant contributions up to the first three percent of the participant's compensation and 50 percent of the next two percent of compensation. The Company is authorized to make discretionary matching contributions and non-elective contributions. There were no non-elective contributions for the year ended December 31, 2024. Contributions are subject to certain limitations. New employees who do not decline enrollment are automatically enrolled in the Plan at five percent of their compensation and deferrals will increase at the rate of one percent, with a cap of ten percent, annually on April 1st each year.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) discretionary Company's contributions, and (b) net earnings and losses from participant investment options and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100 percent of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their voluntary contributions; the Company's safe harbor contributions; any non-elective contributions plus actual earnings thereon; and the remainder of their accounts, plus earnings thereon.

Payment of Benefits: On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals, with a minimum of \$1,000. In certain circumstances, participants may make “hardship withdrawals” as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates two percent above the prime rate. Principal and interest are paid through payroll deductions.

Administrative and Investment Management Expenses: Transaction fees such as loan initiations and distributions, the Plan's record keeping, and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation in fair value of investments reported by the Plan. All other expenses of the Plan are paid by the Company.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value and contract value, as further described in Note 6. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 – RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants become fully vested in employer contributions upon plan termination.

NOTE 4 – SELF-DIRECTED INVESTMENTS

Participants may elect to invest contributions and earnings into self-directed investments. The participants work directly with an individual broker of their choice first approved by the committee.

The broker executes investment transactions, collects interest and dividend income, and retains custody of the investment securities within the guidelines of ERISA. Charles Schwab acts as trustee for the Personal Choice Retirement Accounts (PCRA) self-directed investments that totaled \$414,627 and \$383,615 at December 31, 2024 and 2023, respectively.

NOTE 5 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

With the exception of information presented in Note 4, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, plan custodian, as of December 31, 2023 and the period from January 1, 2024 to June 30, 2024 and Transamerica Trust Company, plan custodian, and Transamerica Financial Life Insurance Company as of December 31, 2024 and the period from July 1, 2024 to December 31, 2024.

NOTE 6 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). The fair values of mutual fund investments are based upon the closing net asset value per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

Self-directed Brokerage Accounts: The fair values of self-directed brokerage accounts are determined based on the underlying assets. Mutual funds, common stocks, and money market mutual funds are determined by obtaining quoted prices from nationally recognized exchanges (Level 1 inputs) for identical assets on the measurement date. Other investments are based on quoted market prices in active markets on which the individual securities are traded.

Stable Value Fund: This type of investment is considered a deposit liability with no defined maturities and is fairly valued at contract value. That is, the contract value reported is also the fair value (Level 2 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

* The Plan offers an investment in the Stable Value Fund, which is a group annuity contract issued by Transamerica Financial Life Insurance Company. This investment is structured as a deposit liability with no defined maturities and is fully benefit-responsive. There are no stated maturities or underlying separately identifiable securities, and the investment does not have unfunded commitments. Participants may transact at contract value at any time, subject to plan rules. Transamerica establishes and guarantees a semiannual interest rate, credited daily, and there is no minimum or maximum guaranteed rate. Rates are declared at least 45 days prior to the start of each six-month crediting period. The investment is classified within the Level 2 category of the fair value hierarchy as defined by ASC 820, since its valuation is based on observable contract data and not quoted prices in active markets.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Notes receivable from participants also reflect party-in-interest transactions.

Transamerica was the recordkeeper as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The Plan holds certain investments managed by Transamerica. Transamerica is a service provider to the Plan, and therefore, these transactions and the Plan's payment of fees to Transamerica qualify as party-in-interest transactions.

NOTE 8 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through August 12, 2025, which is the date the financial statements were available to be issued.
