## **Note 1. Description of the Plan**

The following description of Practice Plus Retirement Plan (Plan) provides only general information. For a more complete description of the Plan's provisions, participants should refer to the plan document and *Summary Plan Description*, which are available from the plan administrator.

### **General**

The Plan is a defined contribution plan sponsored by Practice Plus (Company) for the benefit of substantially all of its employees.

Eligible employees may begin contributing immediately upon enrollment in the Plan. Participants become eligible to receive employer contributions on the first day of January or July after completing one year of service.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Milliman, Inc., serves as the recordkeeper of the Plan, while Charles Schwab Trust Bank serves as the Plan's custodian. Stephens Inc., serves as the Plan's investment adviser.

### **Contributions**

The Plan permits eligible employees, through a salary deferral election, to make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. Profit-sharing contributions are discretionary as determined by the Company. For the years ended December 31, 2024 and 2023, the Company has made profit-sharing contributions of 3.5% of each employee's eligible compensation. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

### **Participant Investment Account Options**

Participants direct the investment of their contributions as well as the Company's contribution, into various investment options offered by the Plan.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 8%.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of service. A participant is fully vested after six years in which they work 1,000 hours or more. The nonvested balance is forfeited upon termination of service.

***Payment of Benefits***

Upon termination of service, a participant may elect to receive either a lump-sum payment, direct transfer, or periodic payments in an amount equal to the value of their account.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,542 and \$1,148, respectively. These accounts will be used to reduce future employer contributions. During the plan years ended December 31, 2024 and 2023, employer contributions were reduced by \$72,124 and \$60,832, respectively, from forfeited nonvested accounts.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

**Note 3. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of

observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

**Recurring Measurements**

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. Level 1 investments include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy.

#### **Note 4. Related-Party Transactions and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$58,623 and \$47,146 of fees to the recordkeeper, custodian, and investment advisor during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Certain plan investments are units of mutual funds managed by Charles Schwab Trust Bank, which is the custodian, as defined by the plan agreement. Therefore, these transactions qualify as party-in-interest transactions.

#### **Note 5. Tax Status**

The Plan operates under an adoption agreement in connection with a volume submitter profit-sharing plan with CODA sponsored by Friday Eldredge & Clark (volume submitter plan). The volume submitter plan has obtained an opinion letter from the IRS dated March 31, 2014 stating that the volume submitter plan is acceptable under Section 401(a) of the Internal Revenue Code (IRC). The Plan obtained its latest determination letter on October 6, 2016, in which the IRS stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the IRC and, therefore, not subject to tax. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

#### **Note 6. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### **Note 7. Subsequent Events**

Effective January 1, 2025, participants turning 60, 61, 62, or 63 by December 31, 2025 can make catch-up contributions of up to \$11,250.

Subsequent events have been evaluated through June 16, 2025, which is the date the financial statements were available to be issued.
