Independent Auditor's Report

To the Plan Administrator
Educare of Washington, DC 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Educare of Washington, DC 403(b) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1: DESCRIPTION OF PLAN

The following description of the Educare of Washington, DC 403(b) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The Plan, originally effective September 10, 2012, is a defined contribution plan covering all eligible employees of Educare of Washington, DC (the "Plan Sponsor"). The Plan is intended to meet the requirements of Section 403(b) of the Internal Revenue Code (IRC) and is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's most recent restatement was January 1, 2019. The Plan Sponsor is a 501(c)(3) organization.

Eligibility - An eligible employee is any employee of the Plan Sponsor except for non-resident aliens. Eligible employees may begin to make elective deferrals to this Plan as soon as administratively feasible after their employment. Eligible employees are eligible for employer-match contributions and non-elective contributions after attaining 18 years of age and completing 1,000 hours of service in a 12-month period. Employees do not meet this requirement until the end of the 12-month period. Entry dates for employer contributions are the first of the month. Eligible employees must work 1,000 hours during the plan year and be employed on the last day of the plan year to receive annual employer contributions.

Contributions - Participants may contribute up to 100% of annual eligible compensation, as defined in the plan document. Participants may elect to contribute to the Plan on a pre-tax basis or to contribute Roth elective deferrals on an after-tax basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Additionally, certain eligible participants may make a special 403(b) catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Upon enrollment, participants may direct their contributions to the various investment options offered by the Plan. Participants may change their investment options and deferral percentages at any time. The Plan Sponsor may contribute a discretionary match or a non-elective contribution. For the years ended December 31, 2024 and 2023, the Plan Sponsor contributed match contributions equal to 100% of the participant's elective deferral not to exceed 1% of the eligible participant's salary and non-elective contributions of 2% of the eligible participant's salary.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of the Plan Sponsor's contribution, if any, investment results, and charged with an allocation of administrative expenses, as provided by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All accounts are self directed by the participants.

NOTE 1: DESCRIPTION OF PLAN - CONTINUED

Vesting - Participants are vested immediately in their voluntary contributions, rollover contributions, the Plan Sponsor's contributions, and actual earnings thereon.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced to the extent that the participant's highest outstanding loan balance during the preceding twelve-month period exceeds the current balance, or 50% of his/her vested account balance. Loan terms may not be greater than five years, or ten years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and accrue interest at the prime rate plus 2%. Principal and interest are paid ratably through payroll deductions. The maximum number of participant loans at any one time is limited to one. In the event of termination of employment, the loan becomes payable in full.

Payment of Benefits - Upon termination of service due to death, disability, severance of employment, or retirement (age 60), a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A participant who has reached age 59½ may elect to withdraw all, or a portion, of his or her vested account balance while still employed. As required under Section 401(a)(9) of the IRC, a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the year in which the participant reaches age 73, or (ii) the year in which the participant retires.

For any distribution not in excess of \$5,000, the participant shall be given the option to elect to have such distribution paid directly to an eligible retirement plan specified by him or her in a direct rollover or to receive the distribution directly. If neither option is selected, the plan administrator shall make such distribution in a direct rollover to an individual retirement plan designated by the plan administrator and shall provide written notice to the participant informing the participant that they have the option to transfer such amount into another individual retirement plan of his or her own choice. Effective January 1, 2024, the Plan adopted the provision of the SECURE 2.0 Act which increased the mandatory distribution limit from \$5,000 to \$7,000. The Plan will be amended as required.

Effective August 1, 2022, the Plan permits qualified birth or adoption distributions as a separate distribution event. The participant may receive a distribution up to \$5,000 during the one year period on the date on which the participant's child is born or on which the legal adoption by the participant of an eligible adoptee is finalized. An eligible adoptee is any individual (other than a child of the participant's spouse) who has not attained age 18 or is physically or mentally incapable of self-support. The \$5,000 maximum is an aggregate amount of such distributions from all plans maintained by the employer.

Effective January 1, 2024, the Plan permits penalty-free withdrawals for an individual experiencing domestic abuse, subject to the requirements of the SECURE 2.0 Act. The Plan will be amended as required.

NOTE 1: DESCRIPTION OF PLAN - CONTINUED

Hardship Withdrawals - Participants may withdraw their pre-tax and Roth elective deferrals contribution account balances in the form of a hardship to satisfy an immediate and heavy financial need as defined by the Plan. The participant must first exhaust all other assets reasonably available prior to obtaining a hardship withdrawal. The hardship distribution cannot be in excess of the need. Effective January 1, 2024, the Plan adopted the provision of the SECURE 2.0 Act to allow earnings on contributions to be eligible for hardship withdrawal. The Plan will be amended as required.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefit payments to participants, or their beneficiaries, are recorded when paid.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Costs associated with participant-initiated transactions are paid by the respective participants' accounts and are included in administrative expenses. Some administrative expenses are paid from the annual operating expenses of the Plan's designated investment alternatives, which are netted against the investment earnings for the relevant participant-directed investments.

Subsequent Events - The Plan Sponsor's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The Plan Sponsor has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 3: FAIR VALUE MEASUREMENTS - CONTINUED

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds, held by the Plan, are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds, held by the Plan, are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan Sponsor has not considered normal plan operations such as participant and employer contributions or benefits paid to participants as party-in-interest transactions that require separate disclosure. Certain plan investments are shares of registered investment companies (mutual funds). Fees paid during the year for certain professional services are substantially absorbed by the Plan Sponsor. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

NOTE 7: TAX STATUS

The Plan has adopted a volume submitter 403(b) plan, which obtained an advisory letter on March 31, 2017, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC and, therefore, the related trust was tax exempt. Although there are certain amendments applicable to the Plan, the Plan Sponsor believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and that the related trust is tax exempt.

NOTE 7: TAX STATUS - CONTINUED

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or the IRS. The Plan Sponsor has analyzed the positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's federal Form 5500 is subject to examination by the IRS and DOL, generally for three years after it is filed.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in shares of registered investment companies that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9: COMMITMENTS AND CONTINGENCIES

In the normal course of business, there may be various commitments and contingencies outstanding, which are not reflected in these financial statements. In the opinion of the Plan Sponsor, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.
