### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Keystone Food Products, Inc. ### (1) Description of Plan

The following description of the Keystone Food Products, Inc. Hourly Employee 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible hourly employees of Keystone Food Products, Inc. (the Company) who have completed 90 days of service or 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees are responsible for the oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

#### **Contributions**

Each year, participants may contribute up to 100% of their annual compensation, as defined by the Plan. Participants may elect to have their deferrals be either pre-tax or after-tax (Roth) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are limited to amounts allowable under the Internal Revenue Code (IRC). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company is required to contribute amounts under a collective bargaining agreement equal to \$.95 an hour up to 40 hours per week effective March 1, 2016. In accordance with the collective bargaining agreement, the rate increased \$.05 per hour each year until March 1, 2020. The Company agreed to a new collective bargaining agreement on May 20, 2020, which continued the rate increase of \$.05 per hour each year until February 29, 2024. The Company agreed to an extension of the agreement until February 28, 2025. In addition, the Company, at its sole discretion, may elect to make a discretionary profit sharing contribution to the Plan. No discretionary profit sharing contribution was made to the Plan for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions, as well as allocation of the Company's profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### (1) Description of Plan, Continued

##### *Vesting*

Participants are immediately vested in their contributions and the Company's contributions plus actual earnings thereon.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past 12 months or 50% of their vested account balance. Loans must be repaid within five years. The loans are secured by the balance in the participants' accounts and bear interest ranging from 4.25% to 9.50% as of year end, which is commensurate with local prevailing rates determined by the plan administrator. Principal and interest are paid through payroll deductions.

##### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant or survivor may elect to receive a lump-sum amount equal to the value of the participant's interest in his or her account or installments over a period not to exceed the joint life expectancy of the participant and his beneficiary. In-service withdrawals may be made by participants or their beneficiaries who have incurred a hardship, as defined by the plan.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### (2) Summary of Significant Accounting Policies, Continued

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan trustees determine the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### *Contributions*

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Fees incurred by the Plan related to the administration of the Plan or associated with the investment of plan assets may be paid by the Plan or by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Plan has evaluated subsequent events through August 14, 2025, the date the financial statements were available to be issued.

#### (3) Financial Information Certified by Qualified Institutions

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company and Empower Annuity Insurance Company of America (collectively "Empower"), qualified institutions.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### (4) Fair Value Measurements, Continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end investments that are registered with the Securities and Exchange Commission. Registered investment companies are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

#### (5) Guaranteed Investment Contract

The Plan has a benefit-responsive guaranteed investment contract with Empower. Empower maintains the contribution in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.25%. The interest rate is reviewed on an annual basis for resetting.

#### (5) Guaranteed Investment Contract, Continued

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan, or (4) the failure of prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not have a defined maturity specified in the contract. The contract can be terminated at any time at the election of the Company. Distributions will be made in accordance with the Contract.

#### (6) Related Party Transactions and Party-In-Interest Transactions

The Plan's investments include shares of registered investment companies and a guaranteed investment contract managed by Empower. Empower is a custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments.

#### (7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### (8) Tax Status

The Plan adopted a non-standard form of a prototype plan sponsored by CCH Incorporated. The Internal Revenue Service (IRS) has determined and informed CCH Incorporated by a letter dated June 30, 2020, that the non-standard prototype plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the prototype plan is qualified and the related trust is tax exempt.

#### **(8) Tax Status, Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the participants' account balances and amounts reported in the statement of net assets available for benefits.
