Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit



NOTE 1 DESCRIPTION OF PLAN

The following description of the Quantech Services, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on September 1, 1999. The Plan is a defined contribution savings and profit-sharing plan pursuant to the provisions of Section 401(k) of the Internal Revenue Code (the Code) and established to provide retirement benefits for employees of Quantech Services, Inc. (the Company) who are at least 21 years of age. All employees who have met eligibility requirements may participate except for those who are covered by a collective bargaining agreement, nonresident aliens, and limited employees on contract. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make pre-tax deferral contributions up to 90% of eligible compensation, as defined in the Plan, up to the maximum allowed by the Code. Effective April 1, 2022, eligible employees are permitted to make Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, up to the maximum allowed by the Code. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 3% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. The Company contributes a safe harbor matching contribution based on 100% of employee deferrals up to 4% of eligible compensation. The Company may also make a discretionary profit-sharing contribution determined on an annual basis. Participants must be employed at year-end and perform 1,000 hours of service during the Plan year in order to qualify for the discretionary profit-sharing contribution. For the year ended December 31, 2024, the Company did not make any discretionary profit-sharing contributions. All contributions are subject to certain limitations imposed by the Plan and the Code.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Employer contributions, investment income and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan, to a self-directed brokerage account, or digital assets account, all of which are held at Fidelity Management Trust Company (Fidelity). These funds include a variety of investment options with various objectives and degrees of financial risk.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions, rollover and employer safe harbor matching contributions, including the earnings on those amounts. Vesting in the Company's discretionary profit-sharing portion of their accounts is based on years of continuous service. Participants are fully vested in Employer discretionary profit-sharing contributions upon the completion of six years of service. Participants are also fully vested upon reaching normal retirement age, death, or total disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Participants may only have one loan outstanding at a time. Loan terms range from one to five years, except for loans to purchase a primary residence which may be offered over a term up to ten years. The loans are secured by the balance in the participant's account. Participant loans bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator (between 3.25% and 8.5% for the year ended December 31, 2024). Generally, principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions are typically paid in a lump sum unless the participant elects an alternative form as allowed by the Plan. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$1,000, then the Plan administrator may distribute the balance without consent of the participant. If the participant's balance exceeds \$1,000 but is less than \$5,000, then the Plan administrator may transfer the balance to an individual retirement account without consent of the participant.

In addition, a participant may elect to withdraw all or part of his or her account after attaining age 59½. Upon financial hardship, a participant is entitled to the value of his or her deferral accounts, which is payable in a lump-sum distribution.

Forfeited Accounts

A participant who leaves the Company forfeits the nonvested portion of his or her account balance. There was no balance in the forfeiture account as of December 31, 2024 and 2023.

Forfeitures may first be used to pay administrative expenses, while any remaining amounts may be used to reduce future Employer contributions to the Plan. During the year ended December 31, 2024, forfeitures totaling \$3,037 were used to reduce Employer contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis and any related fees are expensed as incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023. If a participant ceases to make the loan repayments and the Plan administrator deems the participant loan to be in default, then the participant loan balance is reduced and a benefit payment is recorded. Unpaid loans are treated as a taxable distribution to the participant.

Payment of Benefits

Benefits to participants are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan holds various investments which, in general, are exposed to various risks, such as interest rate, credit, liquidity and overall market volatility. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through August 7, 2025, the date the financial statements were available to be issued, and no subsequent events have been noted which would require adjustment to or disclosure in the financial statements.

NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE

Information presented in the accompanying statements and schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024 for investments related to money market, mutual funds and self-directed brokerage accounts, notes receivable from participants, investment income and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by Fidelity Management Trust Company, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Self-Directed Brokerage Accounts: Self-directed brokerage accounts include money market funds, mutual funds and common stock which are valued at the quoted price of shares held by the Plan at year-end.

Money Market and Mutual Funds: Money market and mutual funds are valued at the quoted price of shares held by the Plan at year-end.

Digital Assets: Digital assets include bitcoin, which is valued utilizing the Fidelity Bitcoin Index PR, which establishes a single price for bitcoin by calculating a volume-weighted median price based on prices from eligible exchanges.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments consist of shares of mutual funds managed by Fidelity Management Research Company (FMRC). The trustee is an affiliate of FMRC, and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Other parties-in-interest include recordkeepers and professional service firms who provide services to the Plan. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions.

NOTE 6 TAX STATUS

The trustee received a favorable opinion letter from the Internal Revenue Service (IRS) for its volume submitter defined contribution plan document. The Plan has been organized as a prototype plan and is intended to satisfy the tax qualification requirements under Section 401(a) of the Code; therefore, the funds of the Plan are intended to be exempt from federal income taxes under the applicable sections of the Code. The Plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account balance.

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Quantech Services, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Quantech Services, Inc. 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 

NOTE 1 DESCRIPTION OF PLAN

The following description of the Quantech Services, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on September 1, 1999. The Plan is a defined contribution savings and profit-sharing plan pursuant to the provisions of Section 401(k) of the Internal Revenue Code (the Code) and established to provide retirement benefits for employees of Quantech Services, Inc. (the Company) who are at least 21 years of age. All employees who have met eligibility requirements may participate except for those who are covered by a collective bargaining agreement, nonresident aliens, and limited employees on contract. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make pre-tax deferral contributions up to 90% of eligible compensation, as defined in the Plan, up to the maximum allowed by the Code. Effective April 1, 2022, eligible employees are permitted to make Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, up to the maximum allowed by the Code. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 3% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. The Company contributes a safe harbor matching contribution based on 100% of employee deferrals up to 4% of eligible compensation. The Company may also make a discretionary profit-sharing contribution determined on an annual basis. Participants must be employed at year-end and perform 1,000 hours of service during the Plan year in order to qualify for the discretionary profit-sharing contribution. For the year ended December 31, 2024, the Company did not make any discretionary profit-sharing contributions. All contributions are subject to certain limitations imposed by the Plan and the Code.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Employer contributions, investment income and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan, to a self-directed brokerage account, or digital assets account, all of which are held at Fidelity Management Trust Company (Fidelity). These funds include a variety of investment options with various objectives and degrees of financial risk.

Vesting

Participants are immediately vested in their voluntary contributions, rollover and employer safe harbor matching contributions, including the earnings on those amounts. Vesting in the Company's discretionary profit-sharing portion of their accounts is based on years of continuous service. Participants are fully vested in Employer discretionary profit-sharing contributions upon the completion of six years of service. Participants are also fully vested upon reaching normal retirement age, death, or total disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Participants may only have one loan outstanding at a time. Loan terms range from one to five years, except for loans to purchase a primary residence which may be offered over a term up to ten years. The loans are secured by the balance in the participant's account. Participant loans bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator (between 3.25% and 8.5% for the year ended December 31, 2024). Generally, principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions are typically paid in a lump sum unless the participant elects an alternative form as allowed by the Plan. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$1,000, then the Plan administrator may distribute the balance without consent of the participant. If the participant's balance exceeds \$1,000 but is less than \$5,000, then the Plan administrator may transfer the balance to an individual retirement account without consent of the participant.

In addition, a participant may elect to withdraw all or part of his or her account after attaining age 59½. Upon financial hardship, a participant is entitled to the value of his or her deferral accounts, which is payable in a lump-sum distribution.

Forfeited Accounts

A participant who leaves the Company forfeits the nonvested portion of his or her account balance. There was no balance in the forfeiture account as of December 31, 2024 and 2023.

Forfeitures may first be used to pay administrative expenses, while any remaining amounts may be used to reduce future Employer contributions to the Plan. During the year ended December 31, 2024, forfeitures totaling \$3,037 were used to reduce Employer contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis and any related fees are expensed as incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023. If a participant ceases to make the loan repayments and the Plan administrator deems the participant loan to be in default, then the participant loan balance is reduced and a benefit payment is recorded. Unpaid loans are treated as a taxable distribution to the participant.

Payment of Benefits

Benefits to participants are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan holds various investments which, in general, are exposed to various risks, such as interest rate, credit, liquidity and overall market volatility. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through August 7, 2025, the date the financial statements were available to be issued, and no subsequent events have been noted which would require adjustment to or disclosure in the financial statements.

NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE

Information presented in the accompanying statements and schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024 for investments related to money market, mutual funds and self-directed brokerage accounts, notes receivable from participants, investment income and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by Fidelity Management Trust Company, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Self-Directed Brokerage Accounts: Self-directed brokerage accounts include money market funds, mutual funds and common stock which are valued at the quoted price of shares held by the Plan at year-end.

Money Market and Mutual Funds: Money market and mutual funds are valued at the quoted price of shares held by the Plan at year-end.

Digital Assets: Digital assets include bitcoin, which is valued utilizing the Fidelity Bitcoin Index PR, which establishes a single price for bitcoin by calculating a volume-weighted median price based on prices from eligible exchanges.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 TAX STATUS

The trustee received a favorable opinion letter from the Internal Revenue Service (IRS) for its volume submitter defined contribution plan document. The Plan has been organized as a prototype plan and is intended to satisfy the tax qualification requirements under Section 401(a) of the Code; therefore, the funds of the Plan are intended to be exempt from federal income taxes under the applicable sections of the Code. The Plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account balance.
