Independent Auditor's Report

Opinion

We have audited the accompanying financial statements of Louisiana Clerks of Court Insurance Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1-Plan Description

The following description of the Louisiana Clerks of Court Insurance Trust's (LCCIT) adopted health care benefit plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

A. General

The Plan provides health benefits to all participating parish clerk of court employees, retirees and their dependents who elect to be covered under the Plan and who meet the eligibility requirements. The Plan and related Trust were established on July 1, 1998 by the Louisiana Clerks of Court Association (LCCA). The Plan was restated effective July 1, 2007. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and Section 501(c)(9) of the Internal Revenue Code (IRC). During 2024 and 2023, Gallagher Benefit Services, Inc. (Gallagher) was the Plan's employee benefit consultant.

B. Benefits

The Plan provides accident, hospital, medical, surgical, prescription drug, dental, vision, medical supplement, disability, and life insurance benefits covering full-time active and retired employees of a participating parish, which includes the LCCA office. A full-time employee works at least 30 hours per week and is on the regular payroll of the participating parish and has greater than 30 days of continuous employment. The Plan also covers eligible dependents of participating employees, retirees, and survivors, as well as providing continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

C. Self-insured Benefits

All Plan benefits, other than vision, medical supplement, and life insurance, are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the general assets of the Plan. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

D. Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). See Note 6 for additional information.

E. Contributions

The Plan agreement provides that participating parishes and their employees make minimum contributions to the Plan of not less than an amount sufficient to provide the payment of anticipated benefits during such year, plus an amount sufficient to pay premium or other charges under any reinsurance policy, and an amount sufficient to cover the cost of legal, accounting, actuarial, and administrative services which may be required by the Plan. The Plan shall determine amounts required to be contributed by employees to extend coverage to eligible dependents of the employees and qualified COBRA beneficiaries.

E. Contributions (Continued)

During 2024 and 2023, participating parishes had the option to choose between the following medical and prescription drug coverage levels and monthly contribution rates by participant level for active and retired participants. Option 1 is a high deductible health plan, and Option 2 is a PPO plan.

During 2024 and 2023, COBRA participant contribution rates were an additional 2% of the active and retired participant rates.

F. Termination of the Plan

Although it has not expressed any intention to do so, the plan sponsor has the right under the Plan to modify the benefits provided to, and contributions required of participants; to discontinue its contributions at any time; and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the plan sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2-Summary of Significant Accounting Policies

A. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Cash and Cash Equivalents

Cash and cash equivalents consist of demand deposits with financial institutions, and other highly liquid investments with original maturities of three months or less.

D. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

E. Recognition of Contributions

Contributions related to insurance premiums are billed monthly and are recognized as revenue over the period in which the Plan is obligated to provide benefits to insured participants. The portion of premiums not earned at the end of the year and premiums collected in advance are recorded as deferred income.

The Plan uses the direct write-off method of recognizing uncollectible accounts receivable. Under this method, a bad debt expense is recorded in the year the account is determined to be uncollectible. Accounting principles generally accepted in the United States of America require that the allowance method be used to recognize bad debts; however, the effect of using the direct write-off method is not materially different from the results that would have been obtained under the allowance method. For the years ended December 31, 2024 and 2023, the Plan did not recognize any expense for uncollectible accounts.

F. Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are included in accounts payable in the accompanying statements of net assets available for benefits. These payments are recorded as health care benefits paid for participants in the accompanying statement of changes in net assets available for benefits.

G. Claims Incurred but not Reported

Plan obligations at December 31, 2024 and 2023, for claims incurred but not reported (IBNR) are based on estimates of the ultimate cost of claims that have been reported but not settled and of claims that have been incurred but not reported. The estimation process considers, among other matters, the cost of known claims over time, inflation, and incurred but not reported claims. These estimates may change based on, among other things, changes in claims history or receipt of additional information relevant to assessing the claims. Accordingly, the Plan may be required to increase or decrease its reserve levels.

H. Leases

Under ASC Topic 842, *Leases*, the Plan determines if an arrangement is a lease at inception primarily based on the determination of the party responsible for directing the use of an underlying asset within a contract. Thereafter, the Plan performs an analysis to classify leases as either operating or finance leases. An operating lease right-of-use asset represents the Plan's right to use an underlying asset for the lease term, and lease liability represents the Plan's obligation to make lease payments arising from a lease. Operating lease right-of-use assets and liabilities are recognized at the lease commencement date based on the present value of lease payments over the lease term.

In determining the present value of committed lease payments, the Plan uses its implicit rate in the lease as the discount rate when readily determinable; if the implicit rate is not available, the Plan uses its incremental borrowing rate based on the information available at the lease commencement date. If leases include payments of operating expenses that are dependent and may be revised based on the landlord's estimate, these variable payments are excluded from the lease payments used to determine the operating lease right-of-use asset and liability. Lease terms may include options to extend or terminate the lease when it is reasonably certain the Plan will exercise such options. Lease expense is recognized on a straight-line basis over the expected lease term.

The Plan elected to not apply the recognition of Topic 842 to short-term leases with terms of 12 months or less which do not include an option to purchase the underlying asset. The Plan elected to account for lease and non-lease components as a single lease component.

Note 3-Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023.

Government agency bonds: Valued using pricing models maximizing the use of observable inputs for similar securities.

Government bonds: Valued using pricing models maximizing the use of observable inputs for similar securities.

Investment in LAMP: Louisiana Asset Management Pool (LAMP) is a governmental external investment pool administered by LAMP, Inc., a non-profit corporation organized under the laws of the state of Louisiana. Only entities having contracted to participate in LAMP have an investment interest in its pool of assets. The primary objective of LAMP is to provide a safe environment for the placement of public funds in short-term, high-quality investments. LAMP's permissible investments are set forth in Louisiana Revised Statutes 33:2955 and are further limited in accordance with investment guidelines promulgated by its board of directors. The investments in LAMP are stated at fair value. The fair value is determined on a weekly basis by LAMP, and the value of the position in the external investment pool is the same as the net asset value of the pool shares. LAMP is rated AAAM by Standard and Poor's. LAMP, Inc. is subject to the regulatory oversight of the Louisiana state treasurer and the board of directors. LAMP is not registered with the SEC as an investment company.

Note 5-Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, administrative service providers, the actuary, and professional fees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. See Note 7 for additional information.

Note 6-Stop-Loss Reinsurance

The stop-loss reinsurance agreement provided coverage for specific losses in excess of \$205,000 and \$200,000 per covered person during the years ended December 31, 2024 and 2023. During 2024, the specific stop loss was subject to an annual aggregating specific deductible (corridor) of \$475,000, up to an unlimited specific lifetime maximum. Additionally, the reinsurance agreement provides \$1 million of aggregate excess of loss coverage that reimburses the Plan for qualified health care costs in excess of a variable attachment point. This attachment amount is calculated at the end of the plan year based on the number of covered lives by level of coverage multiplied by monthly rates specified in the agreement.

Premiums ceded under the reinsurance agreement during 2024 were \$553,113. The Plan did not recognize any reinsurance recoveries for excess losses during 2024. At December 31, 2024 and 2023, reinsurance recoverables were \$0 for health claims paid.

Note 7-Administrative Services Agreement

The Plan has an Administrative Services Agreement with Gallagher. Under the terms of the agreement, Gallagher provides services necessary to carry on the functions of providing the applicable employee benefits insurance coverage on behalf of the Plan in compliance with applicable state and local laws, administrative rules and regulations, and policies of the Plan. The administrative services provided by Gallagher include contribution billing, contribution collections, sales and marketing, accounting, claims handling, and troubleshooting as necessary for the individual member's insurance coverage or programs. Total compensation paid to Gallagher in 2024 was \$290,000 and reduced by commissions received from life and disability insurance products in the amount of \$61,189.

Blue Cross Blue Shield of Louisiana (BCBS) performs claims administration services for LCCIT. Under the agreement, BCBS provides claims processing, adjudication, regulatory reporting, and monthly reporting of claim activity to Gallagher. During 2024, the Plan incurred \$459,830 in claims administration fees, which are included in administrative expenses on the statement of changes in net assets available for benefits.

These transactions are considered to be party-in-interest transactions under ERISA.

Note 8-Operating Lease

The Plan leases a building on a month-to-month basis from a related party. See Note 13 for additional information on the lease.

For the year ended December 31, 2024, short-term lease expense amounted to \$10,800 and is included in administrative expenses on the statement of changes in net assets available for benefits.

Note 9-Risk and Uncertainties

The Plan invests in investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Note 10-Concentration of Credit Risk

The Plan's financial instruments exposed to concentrations of credit risk consist primarily of its cash, cash equivalents, and investments. The Plan maintains its cash and cash equivalents at a financial institution, which are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor. Any remaining balance not covered by FDIC insurance is collateralized by securities pledged under a tri-party collateral agreement. The Plan believes it is not exposed to any significant credit risk on cash, cash equivalents, or investments.

Note 11-Tax Status

The Trust established under the Plan to hold the Plan’s assets is intended to qualify pursuant to Section 501(c)(9) of the IRC, and accordingly, the Trust’s net investment income is exempt from income taxes. LCCIT has not obtained a favorable tax determination letter for the Plan from the Internal Revenue Service (IRS). However, LCCIT believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, LCCIT believes that the Plan was qualified and tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 13-Related Party Transactions

LCCIT's Board of Trustees includes three trustees from the Louisiana Clerks of Court Association ("Association"). The members of LCCIT elect eight Clerks from the member districts to serve on the Board of Directors. The Chairman of LCCIT also appoints one retiree to serve on the Board. LCCIT, the Association, and the Louisiana Clerks' of Court Retirement and Relief Fund ("Retirement Fund") share employees and office space.

The Retirement Fund owns a building, which is also occupied by the Association and LCCIT. Rent expense totaling \$10,800 for the year ended December 31, 2024 is included in administrative expenses on the statement of changes in net assets available for benefits. There is no formal lease between the related parties.

LCCIT shares equipment and other office expenses with the Association and the Retirement Fund. Most of the expenses, including the salaries of employees of all three funds, are paid out of the Association. LCCIT reimbursed the Association \$101,400 for shared expenses for the year ended December 31, 2024, which is included in administrative expenses on the statement of changes in net assets available for benefits.

Note 14-Subsequent Events

Management has evaluated subsequent events for the Plan through August 8, 2025, the date the financial statements were available to be issued. As a result, the management noted no subsequent events that required adjustment to, or disclosure in, these financial statements.
