## Independent Auditors' Report

To the Board of Trustees  
School Year Abroad 403(b) DC Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the School Year Abroad 403(b) DC Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ### **Responsibilities of Management for the Financial Statements**

## Notes to Financial Statements

As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

---

### 1. Description of Plan:

The following brief description of the School Year Abroad 403(b) DC Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General – The Plan is a defined contribution plan covering all employees of School Year Abroad (the “School”) excluding non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – During the year ended December 31, 2024, the School made non-elective contributions to participants who were 21 years of age and had been credited with 12 consecutive months of service. Non-elective contributions were 8% of eligible compensation, as defined by the plan document.

Eligible employees may make elective deferrals as soon as administratively feasible on or after the employee’s first day of employment. Participants may make elective deferrals up to one hundred percent (100%) of annual pre-tax compensation, limited to the provisions established by the Internal Revenue Code (the “Code”), (\$23,000 in 2024). Participants who are 50 years old or older can make additional “catch-up” contributions, up to \$7,500 in the year ended December 31, 2024. Participants may make rollover contributions into the Plan from qualified sources.

Participant Accounts – Each participant’s account is credited with its respective contribution, its allocation of the School’s non-elective contribution and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds, group annuity contracts and a pooled separate account as investment options for participants.

Vesting – Participants are immediately vested in their contributions, rollover contributions, the School’s contributions and their allocation of Plan earnings.

Payment of Benefits – Participants may not make withdrawals from their Participant’s Elective Account except for:

- (1) Normal retirement - age 59½;
- (2) Total and permanent disability;
- (3) Death; or
- (4) Termination of employment

The provisions of the plan document also provide for hardship and qualified reservist distributions, if they are made from a participant’s elective deferral or rollover source funds.

Distributions are paid to participants in a lump sum, partial payments, installment payments or through an annuity contract.

Forfeitures – Participants are at all times 100% vested in their accounts, resulting in no forfeitures in the Plan.

### 1. **Description of Plan (continued):**

Notes Receivable from Participants – At the discretion of the Plan, participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of (i) 50% of a participant's vested account balance as of the date the loan is made or (ii) \$50,000 reduced by the participant's then outstanding loan balances, if any. Loans are secured by the participant's account and bear a fixed interest rate that will be set at the prevailing rate a loan would be given to the participant in their area. Loan terms are not to exceed 5 years, except for the purpose of acquiring a primary residence in which case the loan term is not to exceed 10 years. Loans are to be repaid through salary reductions consistent with the payroll practices of the School or through payments made directly to TIAA and CREF by participants.

The TDA Plan offered plan loans to participants in which participants would borrow directly from TIAA and CREF. Participants could borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans bear interest at the rate determined under TIAA and CREF's loan policy. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended to 10 years. Principal and interest is paid ratably, directly by the participant. Plan loans were issued directly from the funds owned by TIAA and CREF and the loan proceeds are not removed from a participant's account balance. However, a portion of the participant's account balance is reserved, or held as collateral, to cover the outstanding loan amount owed to TIAA and CREF for the period of time the loan is outstanding. There were no outstanding participants loans as of December 31, 2024 and 2023.

### 2. **Significant Accounting Policies:**

Basis of Accounting – The accounting records of the Plan are maintained on the accrual basis, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported accounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. The fully-benefit-responsive group annuity contract held by the Plan is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants and the non-elective contributions from the Employer are recorded in the year in which the employee contributions are withheld.

Payment of Benefits – Benefits are recorded when paid.

### 2. **Significant Accounting Policies (continued):**

Operating Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events – In preparing these financial statements, management has evaluated subsequent events through August 4, 2025 the date the financial statements were available to be issued.

### 3. **Plan Termination:**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested and would be entitled to the full value of their account.

### 4. **Risks and Uncertainties:**

The Plan provides for various investment options in registered investment companies. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participant's accounts and the amounts reported in the statements of net assets available for benefits.

### 5. **Information Prepared and Certified by Custodian:**

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. TIAA and CREF served as the Plan's custodian. They have provided the Plan administrator with certifications as to the completeness and accuracy of investment balances and transactions, supplemental schedule, interest and dividend income, realized gains (losses) on the sale of investments and unrealized appreciation (depreciation) of investments in accordance with the Department of Labor Regulations.

### 6. **Tax Status:**

The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter on the Plan should the IRS open such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

### 6. Tax Status (continued):

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Investments at Contract Value:

Participants may direct their contributions to TIAA Traditional Annuities. These are traditional investment contracts between TIAA and each participant invested in one of the annuities. One of these contracts meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contracts held by the Plan participants are guaranteed investment contracts. TIAA is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

Interest is at the effective annual rate of 3% from the first day of the month in which the premium is received to the annuity starting date or the date death benefits begin, and then at the effective annual rate of 2.5% thereafter, plus an annually established discretionary rate.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contraction obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

### 8. Fair Value Measurements:

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment contracts: Following guidance provided by TIAA; management has determined that contract value approximates fair value for its guaranteed investment contracts that are not fully benefit responsive. Non-fully benefit responsive TIAA Traditional Annuity account balances are reported at fair value. Fair value represents the accumulation of contributions made under the contract, plus guaranteed and additional interest, less funds used to pay benefits and administrative expenses of the contract.

The conclusion that contract value approximates fair value for the TIAA Traditional Annuity is supported by two approaches: (1) the theoretical transfer of assets owned by a pension plan and (2) a quantitative model based on assumptions of future interest rates and related discounted cash flows.

The first approach considers transactions in the TIAA Traditional Annuity to occur in a theoretical marketplace given the number of plans and participants served by TIAA. It recognizes participants with a number of investment choices willingly transact at contract value on a daily basis in the TIAA Traditional Annuity. When participants change employers, they continue to willingly invest at contract value in the TIAA Traditional Annuity if it is offered in their new plan. Lastly, when distributable events occur, participants settle their contracts with a cash payout based on the contract value.

For the second approach, TIAA has studied its data and found a strong correlation between the blended return on TIAA Traditional Annuity contracts compared to the 10-year risk-free rate derived from U.S. Treasury yields and average AAA corporate credit spreads. Differences in the credit spreads from corporate bonds are assumed to represent the overall liquidity of the TIAA Traditional Annuity, and those associated U.S. Treasury yields represent a credit spread for a highly rated insurance company. Thus, the interest rate used to discount future cash flows under a TIAA Traditional Annuity contract would approximate the contract's crediting rate and the present value would, therefore, approximate current contract value.

Because participants transact at contract value, the fair value approaches and assumptions related to the TIAA Traditional Annuity are only reviewed annually for financial reporting purposes. In determining the reasonableness of the fair value methodology, the Audit Committee reviews the crediting rates on existing contracts held by the Plan, current economic conditions and rates of return, the financial status of TIAA and similar factors that could impact the above approaches.

Pooled separate accounts: Pooled separate accounts are valued at NAV as a practical expedient to estimate fair value. NAV is reported by the investment manager of the fund based on the fair value of the underlying assets and liabilities at the measurement date. Pursuant to ASU 2015-07, investments which use NAV as a practical expedient to measure fair value are not included in the fair value hierarchy. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The pooled separate account held by the Plan has no unfunded commitments, redemptions are allowed daily and there is no redemption notice period for participants or the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
