Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dania Entertainment Center, LLC 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1—Description of the Plan

The following description of the Dania Entertainment Center, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan, established in December 2019, is a defined contribution plan covering substantially all employees of Dania Entertainment Center, LLC (the “Company” or the “Plan Sponsor”) who are age 21 or older and have completed 60 days of service. Effective January 1, 2024, the Plan the eligibility service completion requirements were amended from 60 days of services to 6 months. Plan entry dates are the first day of each month subsequent to meeting qualifying requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. Participant accounts are administrated by Reliance Trust Company, the qualified institution.

Contributions – Participants may make salary deferral contributions, as defined by the Plan, subject to the limitations of the Internal Revenue Code (“IRC”). Participants may designate a portion of their contributions as Roth 401(k) contributions. The Plan allows participants who have attained the age of 50 before the end of the Plan year to make catch-up contributions of up to \$7,500 per the IRC limits. Participants may also contribute amounts representing distributions from other qualified defined benefit and contribution plans.

The Company makes safe harbor matches equal to 100% of the participant’s elective deferral contribution up to 3% of participant’s eligible compensation, plus 50% of the participant’s elective deferral contribution over 3% up to 5% of the participant’s eligible compensation. In addition to the safe harbor contribution, the Company may elect to make discretionary-matching contributions, which are allocated to eligible active participants based on a non-integrated formula, as defined in the Plan Agreement. The Company did not make discretionary contributions during the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contributions, if any, (b) Plan earnings (losses) and charged with an allocation of, (c) forfeitures, and (d) any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Upon enrollment in the Plan, a participant may direct employee and Plan Sponsor contributions in any of the investment options offered by the Plan.

Vesting – Participants are immediately vested in their deferral contributions, safe harbor matching contributions plus actual earnings or losses thereon. The discretionary-matching contributions plus actual earnings or losses thereon become vested according to the following schedule for years of service:

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest that is similar to rates charged by persons in the business of lending money for loans which would be made under similar circumstances and must be based on appropriate regional factors unless the Plan is administered on a national basis. Loans must be fully repaid through payroll deductions within five years unless the loan is used for the purchase of the primary residence which may be repaid within a period of no more than 30 years. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount, equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants are allowed in-service withdrawals of their participants' vested interest in his or her account upon attainment of retirement age or in the event of a financial hardship. Upon termination of employment, a participant is entitled to the entire participant account balance, which includes all of the vested Plan Sponsor's contributions allocated to the participant's account and all gains or losses attributable thereto. Participants should refer to the Plan documents for a full description of the distribution methods offered by the Plan.

Hardship Distribution – Hardship distributions are permitted if the distribution is due to expenses incurred or necessary for medical care described in the IRC Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, or any other condition which the Commissioner of the Internal Revenue Service ("IRS") deems an immediate and financial need of the participant.

Forfeitures – Forfeitures may be used to pay administrative expenses of the Plan or to reduce Plan Sponsor discretionary-matching contributions made after the forfeitures are determined. There were no forfeitures outstanding as of December 31, 2024 or 2023.

Note 2—Summary of significant accounting policies

Basis of Presentation – The Plan's financial statements are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value. A fair value hierarchy exists which requires an entity to maximize the use of observable inputs when measuring fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when they have been processed and paid by the Plan.

Administrative Expenses – Administrative expenses are paid by either the Company on behalf of the Plan or from Plan assets. There is no guarantee the Company will continue to pay the Plan's expenses. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan.

Fair Value Measurement – Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Three levels of inputs may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are the descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy, if applicable:

Mutual Funds – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Common Collective Trust – This investment is a public investment vehicle valued using NAV as a practical expedient to estimate fair value provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. In accordance with Accounting Standards Codification ("ASC") Subtopic 820-10, this investment has not been classified under the fair value hierarchy.

The Plan believes its valuation method is appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5—Party-in-interest transactions

The Plan's investments are managed by the qualified institution. These transactions qualify as exempt party-in-interest transactions. Fees paid to the recordkeeper amounted to \$17,957 for the Plan year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7—Tax status

On October 6, 2020, the IRS stated the prototype plan adopted by the Plan, as then designed, qualifies under Section 401 of the IRC. The Plan has not received a determination letter specific to the Plan itself. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Risks and uncertainties

The Plan provides for various investment options in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 9—Subsequent events

Plan management has evaluated all events subsequent to the statement of net assets available for benefits date of December 31, 2024 through August 4, 2025, which is the date these financial statements were available to be issued.
