Note 1 - Plan Description

The following description of John A. Biewer Company, Inc. 401(k) Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of John A. Biewer Company, Inc. and its subsidiaries and affiliates (collectively, the "Company") who qualify under the Plan. All employees who have attained the age of 18 and have worked for the Company for three months are eligible to participate in the Plan. Upon satisfying the eligibility requirements, participation in the Plan may begin on the first day of the month following eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 1, 2023, the Plan was amended to add Biewer Forest Management South, Inc. as a participating employer.

Contributions

Participants are eligible to make elective contributions to the Plan subject to limitations established by the Internal Revenue Code (IRC). The plan administrator may reduce the amount of allowable contributions so as not to exceed certain tax limits. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company, at the discretion of its board of directors, may make discretionary matching contributions to the Plan. Discretionary contributions for the years ended December 31, 2024 and 2023 were 25 percent of participant contributions up to a maximum of 5 percent of compensation. In addition, in a separate discretionary matching contribution, the Company matched 110 percent of participant contributions made on the profit-sharing bonus payment made during the year.

Vesting

Plan participants' rights to their individual contributions and earnings thereon are fully vested and nonforfeitable.

Company discretionary matching contributions vest ratably over five years.

Participant Accounts

Each participant's account is credited with an amount equal to that participant's deferred compensation, any employer contributions, an allocation of the Plan's earnings and expenses, and an allocation of plan forfeitures. Participants can invest their account balances among various investment options offered by the Plan. The benefit to which a participant is entitled is based on the value of his or her vested account.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive the following from all available vested accounts:

- A lump-sum amount equal to the value of his or her account
- Periodic payments
- Direct transfer to another plan that satisfies the requirement of Internal Revenue Code Section 401(a)

Participant Notes Receivable

The Plan permits participants to borrow against their account balances. The notes receivable must be no more than the lesser of \$50,000 or 50 percent of a participant's vested account balance, reduced by any other outstanding notes receivable. Notes receivable are collateralized by the balance in the participant's account, bear interest at market rates, and can be repaid through payroll deductions.

Note 1 - Plan Description (Continued)

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$67,011 and \$31,096, respectively.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In the event that the Plan terminates, participants will become 100 percent vested in their account balances, and the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Charles Schwab Trust Bank (Charles Schwab) or its affiliates. Charles Schwab is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

In addition, various administrative costs are paid by the Company that also qualify as party-in-interest transactions.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Stable Value Fund

As of December 31, 2024 and 2023, the Plan holds the Reliance NY Life Anchor Series 1 investment, a stable value fund. The fund has certain limitations on withdrawals and exchanges as follows:

- Participant directed - Withdrawals made in order to accommodate distributions to participants or transfers to noncompeting investments may be made on any business day. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur.

The custodian may defer completing any withdrawal in cases when the completion might immediately adversely affect the investment. The custodian shall make payments available as quickly as cash flows and prudent portfolio management permit.

Note 2 - Summary of Significant Accounting Policies (Continued)

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 7, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Charles Schwab Trust Bank (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value. The following tables present information about the Plan's assets measured at fair value on a recurring basis at December 31, 2024 and 2023.

Note 5 - Fair Value Measurements (Continued)

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
