Opinion on the 2024 Financial Statements

NOTE 1 — DESCRIPTION OF PLAN

The following description of the Gonzalez Companies, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan Sponsor, Gonzalez Companies was acquired by Trilon Group, LLC on December 13, 2022. On May 23, 2023, Trilon Group, LLC approved merger of the Plan into The Trilon Group Retirement Savings Plan (the Trilon Plan), effective January 1, 2024. The title of these assets transferred to the Trilon Plan on January 1, 2024. Assets were physically transferred on January 17, 2024. Effective January 1, 2024, the fixed annuity contract is held by Empower, as Custodian for the Trilon Plan, until the earlier of (a) the withdrawal of funds by the remaining participants or (b) three years from termination of the contract. As a result of the merger and transfer of assets effective January 1, 2024, the Plan did not have any contributions, expenses or investment income on January 1, 2024.

The Plan is a defined contribution plan covering substantially all employees of Gonzalez Companies, LLC (the Company) who are at least 21 years old. Employees are eligible to participate on the first day of the calendar month coinciding with or next following the date after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Empower Retirement provides recordkeeping services to the Plan. Empower is the custodian of the Plan's investments. The Company is the Plan Administrator and has overall responsibility for the operation and administration of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance. Certain members of management serve as the Plan's trustees.

Investment Options

Participants of the Plan elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and additional matching contributions plus actual earnings thereon. Vesting in the Company discretionary additional employer matching portion of their accounts is based on years of service. Participant accounts attributable to additional employer matching contributions plus actual earnings thereon are subject to a six-year graded vesting schedule.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate as of the date of loan origination. Principal and interest is paid ratably through monthly payroll deductions.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to pay plan expenses, or used to reduce any Company contribution and no forfeitures were used to pay administrative expenses or reduce Company contributions. There were no unallocated forfeitures as of January 1, 2024 and December 31, 2023.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Subsequent Events

Subsequent events were evaluated through July 31, 2025, which is the date the financial statements were available to be issued.

NOTE 3 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 3 — FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

Pooled Separate Accounts: Valued at NAV of the units in the fund, which is based on estimated market value of the underlying investments less its liabilities.

NOTE 4 — FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America (EAICA). EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity investment contract. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The group annuity investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In the event there is an employer-initiated event, such as but not limited to a merger, acquisition or partial plan termination, a book value payment is made over a period of 12 or 36 months, depending on market conditions. As disclosed in Note 1, the Plan merged with Trilon Plan in January 2024, and all assets are titled to the Trilon Plan effective January 1, 2024.

NOTE 5 — INFORMATION CERTIFIED BY THE CUSTODIAN

Information regarding investments and notes receivable held at December 31, 2023, was obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodian.

NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of a mutual fund and a group annuity contract managed by Empower Annuity Insurance Company of America and Empower Retirement, LLC, who are the custodians as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

NOTE 7 — TAX STATUS

As this Plan is a pre-approved defined contribution plan, the Internal Revenue Service issued a letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this Plan will be considered to have a plan qualified under code Section 401(a) provided all the terms are not more favorable for officers, owners or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement.

NOTE 8 — RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
