Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of Grady-White Boats, Inc. Retirement Savings Plan (the "Plan") provides only general information for the Plan sponsored by Grady-White Boats, Inc. (the "Company"). Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on January 1, 2001 as a defined contribution plan. The Plan covers all Grady-White Boats, Inc. and Pamlico Investments, LLC employees who are at least 18 years of age. Effective December 4, 2023, employees of Eddie and Jo Allison Foundation are also permitted to participate in the Plan. Temporary employees who are at least 21 years of age and have completed at least 1,000 hours of service in a one-year period are also eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Employees are automatically enrolled with a 6% pre-tax deferral election immediately upon meeting eligibility requirements. Participants may contribute a percentage of their pre-tax annual compensation, not to exceed the maximum allowed by the Internal Revenue Service ("IRS"). Participants may also elect to defer a percentage of their compensation to be treated as a Roth contribution. Additionally, there is an automatic escalation feature of 1% pre-tax deferral increase each year until 10% pre-tax deferral of compensation is reached. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also permits rollover contributions from other qualifying retirement plans.

The Company may make a discretionary employer match. During 2024, the Company made a discretionary employer matching contribution at a rate of 100% of the first 6% of employee elective contributions. The Company may make additional matching contributions. There were no additional matching contributions made during 2024. The Company may also make an additional discretionary contribution based on employees meeting certain criteria. During the year ended December 31, 2024, the Company made an additional discretionary contribution of \$640,672.

Participant Accounts

Employee contributions, employer contributions, and rollover contributions activity are maintained separately in each participant's account. Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investments daily. Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the compensation deferral portion of their investment account as well as the rollover portion of their investment account plus actual earnings thereon. to the Plan. Vesting in the Company's discretionary matching and profit sharing contributions is based on the years of continuous service. Participants are fully vested after completing three years of credited service.

Forfeitures

At December 31, 2024, forfeited accounts totaled \$3,784. Forfeitures can be used to pay administrative expenses or to reduce the employer contribution. During the year ended December 31, 2024, the Plan used \$158,004 of forfeited accounts to reduce employer contributions.

Payment of Benefits

Generally, a participant becomes eligible to receive benefits on their normal retirement age (65), death, disability or termination of employment. Participants can receive their account balance in a lump sum amount or installment payments. If the vested balance is less than \$5,000, a lump sum distribution is made. Early retirement is permitted for participants who have attained age 59½. Effective August 12, 2024, the Plan was amended to allow partial withdrawals.

Notes Receivable from Participants

Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance during the twelve-month period ending on the day before the loan is made. All loans must be for a hardship purpose. A participant can only have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate remains fixed throughout the duration of the loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 and 2023 were \$246,736 and \$314,854, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on upon the terms of the plan document.

Investment Valuation and Income Recognition

Investments are comprised of mutual funds and a collective investment trust fund. Investments in mutual funds are valued at quoted market prices established in an active market which represent the net asset value of shares held by the plan at year end. See Note 7 for discussion of the fair value of the collective investment trust fund.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in value of investments are allocated to the participant accounts based on participant holdings in each fund.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participant and distributions) are charged directly to the participant's account.

3. Federal Income Taxes

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. The plan administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

5. Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, and was not subject to audit for the years ended December 31:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

- Level 2 Inputs are based on significant other observable inputs such as:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no Level 2 or 3 investments in the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

7. Collective Investment Trust Fund

The Plan invests in the Galliard Stable Return Fund C (the “Fund”). The Fund is managed by Galliard Capital Management, LLC and trustee by SEI Trust Company. The Fund seeks to provide investors with a moderate level of stable income without principal volatility.

The Fund primarily invests in investment contracts, including traditional guaranteed investment contracts (“GICs”) and security-backed contracts issued by insurance companies and other financial institutions. The Fund also invests in the Short Term Investment Fund II, which invests in highly liquid assets, and uses the investment for daily liquidity needs.

The net asset value (“NAV”) of the Fund is calculated daily, and net investment income and realized and unrealized gains on investments are reinvested and reflected in the NAV of the Fund. Units of the Fund are issued and redeemed at the current NAV. Redemptions by participating plans occur at NAV following the 12-month notice period. There were no unfunded commitments.

8. Risks and Uncertainties

The Plan invests in various investment securities as directed by its participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

9. Party-in-Interest Transactions

Plan investments are managed by Fidelity, the trustee as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity and other parties-in-interest for contract administration, advisory and professional services amounted to \$11,954 for the year ended December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

10. Prohibited Transactions

During 2024, the Company failed to deposit \$4,154 of participant deferrals within the required timeframe as stated by the Department of Labor (“DOL”). The DOL considers late deposits to be a prohibited transaction. The Company calculated and deposited lost earnings in 2025.

11. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 23, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 (“SECURE Act 2.0”) that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE 2.0 Act are effective at various dates through 2026, with the plan amendment for the adoption of SECURE 2.0 Act due by December 31, 2026.
