Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Connell Foley LLP Employees 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of the Plan

The following description of the Connell Foley LLP Employees 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all partners and eligible employees of Connell Foley LLP (the "Firm" or "Employer"). Eligibility is based on the attainment of age 18 and the completion of ninety days of service. A participant becomes eligible to receive the Employer contribution upon completion of one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may contribute a percentage of their pretax annual compensation each year, as defined in the Plan agreement, subject to dollar limits in effect as provided by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Employer may make matching and profit sharing contributions equal to a discretionary percentage, to be determined by the Firm, of the participants' election deferrals or compensation. Participants direct the investment of all contributions into various investment options offered by the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rates are determined by the Plan administrator. The loans plus interest must be repaid within five years, which may be extended to ten years for the purchase of a principal residence.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions and earnings thereon vest at 20% per year beginning in year two, with full vesting after six years.

Participant Accounts

Each participant's account is credited with the participant's contribution and earnings thereon. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$78,107 and \$120,505. These accounts will be used to reduce future Employer contributions. In 2024, Employer contributions were reduced by \$124,359 from forfeited non-vested accounts.

1. Description of the Plan (continued)

Plan Credit Account

The Plan and John Hancock Trust Company LLC (the “trustee”) have entered into a revenue sharing arrangement whereby a portion of the revenue earned by the trustee from certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Firm created the Plan Credit Account under the Plan. The Plan Credit Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record keep the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Plan Credit Account balance was \$91,614 and \$57,081 at December 31, 2024 and 2023. During 2024, \$42,770 of the Plan Credit Account was used to pay recordkeeping costs incurred by the Plan and \$25,269 was reallocated to participant accounts.

Payment of Benefits

Upon a participant’s attainment of age 59½, hardship as defined in the Plan, or upon termination of service including termination of employment, termination of service due to death, disability or retirement, a participant may elect to receive the value of the participant’s vested interest in his or her account.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, the Plan's investments in mutual funds were valued at fair value using level 1 inputs.

Investment Valuation and Income Recognition

Investments are reported at fair value based on quoted market prices except for its investment in a pooled separate account which is valued at contract value. The mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price and are deemed to be actively traded.

Investment contracts held by a defined contribution plan are reported at contract value, which is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a pooled separate account. Contract value for the pooled separate account is based on the net asset value of the fund as reported by the investment advisor.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in interest and dividend income which is reinvested. Realized gains and losses on investments are recognized upon the sale of the related investments, and unrealized appreciation or depreciation is recognized at year end when the carrying values of the related investments are adjusted to their estimated fair value.

Expenses

Certain expenses of maintaining the Plan are paid by the Firm and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 29, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivables disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends, and notes receivable from participants interest activity for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, LLC, a qualified institution.

4. Investment in Pooled Separate Account Group Annuity Contract

The Plan invests in a fully benefit-responsive stable value fund with New York Life Trust Company (“New York Life”). New York Life maintains the contributions in a pooled separate account group annuity contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the pooled separate account group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the stable value fund. Contract value, as reported to the Plan by New York Life, represents contributions made under the pooled separate account group annuity contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events which would limit the Plan’s ability to transact at contract value with participants is remote.

4. Investment in Pooled Separate Account Group Annuity Contract (*continued*)

The pooled separate account group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (AA+ as of December 2024), Moody's Investors Service (Aaa as of December 2024), A.M. Best (A++ as of December 2024), and Fitch Ratings (AAA as of December 2024).

The New York Life NYL Insurance Anchor Account III represents approximately 9% and 11% of net assets available for benefits as of December 31, 2024 and 2023.

5. Party-in-Interest Transactions

Certain administrative functions are performed by the partners and employees of the Firm, which is a party-in-interest. No such partner or employee receives compensation from the Plan. Certain administrative expenses for the Plan are paid directly by the Firm. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer perform administrative services related to the Plan; the Employer pays the salaries of these individuals, and no costs are charged to the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

7. Tax Status

The IRS has determined and informed the Firm by a letter dated September 14, 2022, the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

8. Risks and Uncertainties

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
