Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pleasant View Gardens, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Notes to the Financial Statements December 31, 2024 and 2023

Note 1 Description of Plan

The following description of the Pleasant View Gardens, Inc. 401(K) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Pleasant View Gardens, Inc. There are certain age and service conditions under the Plan, with different service requirements, depending on the type of contribution. Employees enter the Plan and are eligible to make elective deferrals on the first day of the month following reaching the age of 21 and completed 90 days of service. The Company will match contributions to employees who have reached age 21 and have completed at least 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Each year, participants may contribute up to Internal Revenue Service dollar limitations as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers thirty-eight funds as investment options for participants.

The Company contributes 40% of the portion of participants 401(K) contributions up to 5% of eligible compensation. The Company may make discretionary non-elective contributions in an amount determined by the Board of Directors for each plan year. There were no such contributions made by the Company in 2024.

Participant’s Individual Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings, and charged with an allocation of administrative and investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contribution plus actual earnings thereon. Vesting in the Company’s contribution portion of their account is based on years of service. A participant is 100% vested after six years of credited service.

Notes to the Financial Statements December 31, 2024 and 2023

Note 1 Description of Plan (Continued)

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at commercial bank rates, determined at the time of the loan. Loans currently outstanding bear interest at rates ranging from 3.25% to 8.50%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service, death, disability or upon reaching normal retirement age, a participant or beneficiary may elect to receive the value of their vested interest as a lump-sum distribution. Financial hardship withdrawals are permitted pending submission of verification to the Plan Administrator warranting the financial hardship.

Funding Policy

The Company remits employee deferrals and Company matching contributions to the Plan on a bi-weekly basis.

Forfeitures

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan.

Unallocated forfeitures at December 31, 2024 and 2023 were \$5,596 and \$1,965, respectively. These amounts will be used to pay administrative expenses or reduce future employer contributions.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America except for benefit payments which are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Note 2 Summary of Significant Accounting Policies (Continued)

Contributions

Participant contributions are recorded when the Sponsor makes payroll deductions from eligible Plan participants. Employer contributions are accrued in the period in which they become obligations of the Sponsor.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses are paid by the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 3 Fair Value Measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, Fair Value Measurements, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023.

Following is a description of the valuation methodology used for investment assets measured at fair value.

Pooled Separate Accounts: Valued based on the daily net asset value (“NAV”) of the units held by the Plan at year end, which is used as a practical expedient to approximate fair value. Investments in pooled separate accounts represent a unit of account whose per unit value is the result of the accumulated values of the underlying investments determined at the fair value (NAV). The pooled separate accounts are comprised of mutual funds. Certain of the Plan’s assets are held in target date accounts based on a participant’s anticipated year of retirement, focusing on delivering consistent risk-adjusted returns throughout a participant’s retirement investment horizon. The remaining pooled separate account strategies are identified by the name of the investment.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 Information Prepared and Certified by Trustee

The Plan administrator has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Note 5 Party-in-Interest Transactions

All investments of the Plan are managed by the Plan’s trustee, John Hancock Life Insurance Company. Transactions involving these investments are considered party-in-interest transactions. These transactions are, however, considered exempt under ERISA Section 408 and related regulations.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

Note 6 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will be 100% vested in their accounts.

Note 7 Tax Status

The Plan Sponsor has adopted a pre-approved plan, in which the IRS stated that the restated pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since its most recent restatement and reliance on the opinion letter. However, the Plan Administrator believes that the Plan is currently being operated in accordance with IRC requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would be sustained upon examination by federal, state and/or local taxing authorities. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 9 Subsequent Events

Management has evaluated subsequent events through May 28, 2025, the date that the financial statements were available for issuance, for disclosure and/or recognition in the financial statements.
