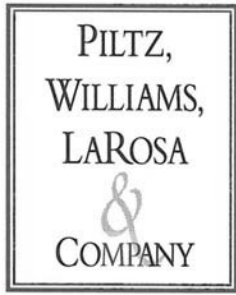

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of CCB and FEB 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of CCB and FEB 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).



**Note A – Description of Plan**

The following description of the CCB and FEB 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all employees of Capital City Beverages, Inc. (Company) and F.E.B. Distributing Co., Inc. who are age 21 or older. There is no minimum service requirement for eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

Effective November 15, 2023 (Plan Merger Date), the FEB Distributing Company, Inc. 401(k) Plan merged with and into the Capital City Beverages, Inc. 401(k) Profit Sharing Plan to become the CCB and FEB 401(k) Profit Sharing Plan. Capital City Beverages, Inc. remains the Plan Sponsor, while FEB Distributing Company, Inc. has become a participating employer with the Plan. Accordingly, the FEB Distributing Company, Inc. 401(k) Plan transferred \$3,528,778 into the Plan during 2023.

**Regulatory matters** – The Secure 2.0 Act of 2022 was signed into law December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans. Plan management is adopting any mandatory provisions as they become applicable and evaluating those provisions deemed discretionary.

**Contributions** – Each year, participants may contribute up to 100% of pretax eligible compensation as defined in the Plan, subject to Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, funds of funds, bond funds, and money markets as investment options for participants. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in the appropriate target date retirement fund. The Company contributes (determined annually) 50% of the participant's elective deferral contribution up to 6% of compensation. The matching contribution is invested as the participant directs.

**Participant accounts** – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are immediately vested in their elective deferral contributions, rollover contributions, qualified matching contributions, qualified nonelective contributions, and actual earnings thereon. Vesting in employer matching contributions and employer nonelective contributions is based on years of service. A participant is 100% vested after five years of service. Notwithstanding years of service, 100% vesting also occurs upon reaching normal retirement age, as defined by the Plan, or death.

**Payment of benefits** – Upon retirement, termination of employment with the Company, death, or disability, participants or their beneficiaries will receive the vested balance of their accounts in either a lump sum payment or other distribution elected by the participant. A participant may withdraw a portion of their account in the event of financial hardship, as defined in the Plan.

**Forfeited accounts** – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8 and \$1,246, respectively. These accounts will be used to reduce future employer contributions and to pay Plan expenses. During the years ended 2024 and 2023, \$27,428 and \$20,243 of these funds were used to pay employer match, respectively.

**Note B – Summary of Accounting Policies**

**Basis of accounting** – The financial statements of the Plan are prepared using the accrual basis of accounting.

**Investment valuation and income recognition** – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan’s valuation policies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits** – Benefits are recorded when paid.

**Administrative expenses** – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses, including record keeper and advisory fees, are allocated among participant accounts.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Note D – Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

**Level 1 Fair Value Measurements**

Registered investment companies are valued at the daily closing price as reported by the fund, which represent the NAV of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money markets are valued at historical cost, which approximates fair value.

**Note E – Income Tax Status**

The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified and the related trust is tax-exempt.

**Note F – Related Parties**

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company, the trustee, of the Plan; and, therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity Management Trust Company for the years ended December 31, 2024 and 2023 totaled \$35,080 and \$14,212, respectively.

Investment consultant and advisory fees for the Plan are paid to investment consultants and advisors by the Plan. For the year ended December 31, 2024, these fees paid by the Plan totaled \$18,367.

Members of management of the Plan sponsor, are participating in the Plan. However, there are no transactions with these individuals other than their participation in the Plan. The Plan sponsor is absorbing part of the administrative cost of the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note G – Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note H – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note I – Subsequent Events**

Management evaluated subsequent events through August 6, 2025, the date on which the financial statements were available to be issued.
