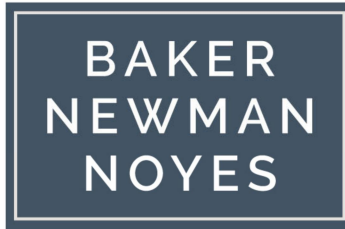

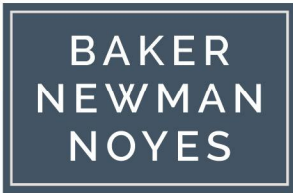

## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants  
Machias Savings Bank 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Machias Savings Bank 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Description of Plan

The following description of the Machias Savings Bank 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a 401(k) plan sponsored by Machias Savings Bank (the Company). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Plan was amended effective September 1, 2023. The amendment did not have a significant impact on the Plan's operation.

#### Eligibility and Participation

Effective September 1, 2023, employees are eligible for participation in the Plan on the first day of the month following the completion of 90 days of service and the attainment of age 18. Prior to September 1, 2023, employees were eligible for participation in the Plan on the first day of each plan quarter coinciding with or following the completion of 1,000 hours of service and the attainment of age 18.

#### Contributions

Participants may elect to contribute pre-tax or post-tax dollars to the Plan from their compensation up to the Internal Revenue Service (IRS) limitation.

On behalf of each participant who elects to contribute to the Plan, the Company will make a safe harbor matching contribution of 100% of the first 3% of a participant's compensation that is deferred and an additional 50% of the next 2% of compensation a participant defers.

The Company may also make a supplemental discretionary employer contribution to each participant who was a participant in the Company's defined benefit plan as of May 31, 2007, is non-highly compensated (as defined), credited with at least 1,000 hours of service and is employed on the last day of the year. The amount of the contribution for each eligible participant varies based on age and length of service with the amounts ranging from 2% to 20% of compensation. Supplemental discretionary employer contributions for 2024 and 2023 were \$120,413 and \$110,298, respectively.

The Company may also contribute a discretionary matching contribution equal to a percentage of the eligible participant's elective deferrals. The amount of the discretionary matching contribution, if any, is determined by action of the Company's Board of Directors. Employer discretionary matching contributions are subject to the following limitations:

1. Employer matching contributions may not be made with respect to elective deferrals that in the aggregate exceed six percent (6%) of the participant's compensation;
2. The rate of employer matching contributions may not increase as the rate of elective deferrals increases;
3. At any rate of elective deferrals, the rate of employer matching contributions that would apply with respect to any highly compensated employee who is an eligible employee is no greater than the rate of employer matching contributions that would apply with respect to a non-highly compensated employee who is an eligible employee and who has the same rate of elective deferrals;

4. Discretionary employer matching contributions may not be made on behalf of any participant that, in the aggregate, could exceed a dollar amount equal to four percent (4%) of the participant's compensation.

There were no employer discretionary matching contributions in 2024 and 2023.

At the participant's option, contributions may be invested in any of the available investment options. Participants should review each investment's prospectus to determine its objectives.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution on their behalf and an allocation of plan earnings and expenses based on account balances.

#### Benefits

Upon death, retirement or disability, the full amount credited to the participant's accounts shall become fully vested. In the event of termination of employment for any other reason, participants will receive the vested amount of their accounts. A participant may also be entitled to a hardship withdrawal or in-service distribution determined in accordance with the Plan's provisions.

#### Vesting

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions. Participants vest in discretionary employer contributions as follows:

Participants who completed at least 1 hour of service on or after January 1, 2007, are 100% vested in discretionary matching employer contributions made on their behalf.

Forfeitures are used to reduce company contributions.

#### Administrative Expenses

Administrative expenses for the Plan are paid by the Plan Sponsor to the extent they are not paid by the Plan.

### 1. **Description of Plan (Continued)**

#### *Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### *Notes Receivable from Participants*

The minimum amount a participant may borrow from their account is \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one outstanding note at any time. Note terms range from one to five years or up to 15 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at fixed rates equal to the Prime Rate at the date of origination. Principal and interest is paid ratably through payroll deductions.

### 2. **Summary of Significant Accounting Policies**

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis.

#### *Investments and Investment Income*

The Plan's investments in mutual funds and money market funds are stated at fair value based upon quoted market prices which represent the net asset value of shares held by the Plan. Investment in the collective trust is stated at fair value based on net asset value (NAV). NAV has been determined based on the unit value of the trust. Unit value is determined by dividing the fund's net assets based on the fair value of the underlying investments by its units outstanding at each valuation date. Certain employer initiated events may reduce the reported value of the investment in the collective trust. These events include discontinued operations, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of the Plan or other events. Such events are not expected to be probable to occur.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions to the Plan are made by both participants and the employer. Participant contributions are recorded in the period in which payroll deductions are made. Employer contributions are recorded in the year of related eligible participant service.

##### *Benefits*

Benefit payments are recorded when paid.

##### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements, the reported amounts of changes in net assets available for benefits during the reporting period and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Risks and Uncertainties*

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

##### *Subsequent Events*

For the purposes of recognition and disclosure in these financial statements, management of the Plan has evaluated subsequent events through July 29, 2025, which is the date these financial statements were available to be issued.

#### 3. **Tax Status**

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

The Plan Administrator received a favorable tax determination letter from the IRS dated June 30, 2020. The Plan has been amended subsequent to the receipt of the tax determination letter. In the opinion of the Administrator, the Plan has been operated within the applicable sections of the Internal Revenue Code (the Code) upon which the favorable determination was based and remains qualified under the Code and applicable regulations.

U.S. GAAP requires plan management to evaluate tax positions taken by a plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 4. **Related Party Transactions**

The Plan is responsible for administrative fees to the extent they are not paid by the Plan Sponsor. Administrative fees consist of amounts paid to the third-party administrator for various administrative services. These transactions qualify as party-in-interest transactions. Various plan investments are in Vanguard mutual funds, which qualify as party-in-interest, as Vanguard serves as plan recordkeeper. Vanguard has retained Ascensus, LLC to provide these services on their behalf. Additionally, fees paid by the Plan for investment management services are paid indirectly by plan participants as a reduction of the return earned on each fund. The Plan has paid administrative expenses of \$57,695 and \$49,054 for the years ended December 31, 2024 and 2023, respectively.

#### 5. **Information Certified by the Custodian**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator has determined that the custodian meets the requirements of a qualified institution as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Ascensus, LLC (as agent for Ascensus Trust Company), the Plan's custodian, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule. The Plan's investments and related income and transactions, and notes receivable from participants, and related income and transactions, were certified by Ascensus, LLC (as agent for Ascensus Trust Company) as of December 31, 2024 and 2023, and for the years then ended, as complete and accurate.

#### 6. **Investments and Fair Value Measurements**

The Plan follows a framework for measuring fair value under generally accepted accounting principles. The framework applies to all financial instruments that are being measured and reported on a fair value basis.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In determining fair value, the Plan uses various methods including market, income and cost approaches. Based on these approaches, the Plan often utilizes certain assumptions that market participants would use in pricing the asset or liability, including assumptions about risk and the risks inherent in the inputs to the valuation technique. These inputs can be readily observable, market corroborated, or generally unobservable inputs. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide the following information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – Valuations based on quoted prices in active markets for identical assets or liabilities. Valuations are obtained from readily available pricing sources for market transactions involving assets or liabilities.

**6. Investments and Fair Value Measurements (Continued)**

Level 2 – Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or similar assets or liabilities.

Level 3 – Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques, and not based on market exchange, dealer, or broker traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities.

In determining the appropriate levels, the Plan performs an analysis of the assets and liabilities that are subject to fair value measurement. At each reporting period, all assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.



