## **INDEPENDENT AUDITOR'S REPORT**

To the Retirement Plan Committee of  
Chicago Cubs Associates Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Chicago Cubs Associates Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**1. DESCRIPTION OF PLAN**

The following description of the Chicago Cubs Associates Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2010, and is available to eligible employees of Chicago Cubs Baseball Club, LLC, Marquee Sports & Entertainment, LLC dba Marquee 360, Marquee Development Services, LLC, and Chicago Cubs Charities (collectively, with Wrigley Field Premium Ticket Services, LLC, Wrigley Field Enterprises, LLC, Hickory Street Capital, LLC, and Northside Entertainment Holdings, LLC, the Company). Effective June 17, 2023, the Plan was amended to include Chicago Cubs Charities as a participating employer in the Plan. Any Chicago Cubs Charities employees who were previously employed by Chicago Cubs Baseball Club and eligible to participate in the Plan continue to be eligible participants in the Plan. The Plan is a defined contribution plan covering substantially all US non-union full-time, qualifying union full-time, and qualifying part-time employees of the Company who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan is designed as a qualified cash deferred arrangement pursuant to Section 401(k) of the Internal Revenue Code (IRC), and provides the following contributions:

Salary Deferral

Participants may contribute up to 85% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Non-union and qualifying union full-time employees are eligible for the Plan upon reaching the minimum age of 21. Qualifying part-time employees are eligible upon reaching the minimum age of 21 and having worked 1,000 hours of service in one calendar year or 500 hours of service in each of two consecutive calendar years.

Employees have an entry date into the Plan on the first of the subsequent month after meeting eligibility requirements.

Salary Deferral (Continued)

The Plan includes an auto enrollment provision whereby newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participant Rollovers

Participants may rollover balances from other qualified defined benefit or defined contribution plans.

Employer Discretionary Matching Contribution

The Company makes discretionary matching contributions of 50% of a qualifying participant's deferral up to 5% (maximum of 2.5%) of eligible compensation. Effective March 27, 2023, the Plan was amended to change the employer discretionary matching contribution calculation period from each payroll period to each plan year. For the years ended December 31, 2024 and 2023, the Company's matching contribution was \$1,323,969 and \$1,304,415, respectively.

Employer Discretionary Profit Sharing Contribution

The Company may contribute a discretionary profit sharing contribution to employees upon completion of 1,000 hours of service, one year of employment, and attainment of age 21. For the years ended December 31, 2024 and 2023, the Company's discretionary profit sharing contribution was \$4,297,271 and \$4,129,005, respectively.

Contributions are subject to certain limitations as mandated by the IRC.

Investment Options

Participants may direct all their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings or losses and charged with the participant's benefit payments and an allocation of administrative expenses. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are vested immediately in their contributions and the Company's discretionary matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution plus actual earnings thereon is based on the following table:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their account balance, less defaulted loans (if any). Participants can have only two loans outstanding at any time. The loans are secured by the balance in the participants' accounts and bear interest at the prime rate plus 1%, using the prime rate in effect at the beginning of the month that the loan was initiated. Loan terms range from one to five years unless the loan is for the purchase of a participant's primary residence, in which case the loan term may not exceed ten years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in the participant's account. Participants who have attained age 59½ have the right to withdraw all or a portion of their salary deferrals or rollover accounts. A participant that terminates employment and has an account balance less than \$7,000 (increased from \$5,000 prior to 2024 as a result of the SECURE 2.0 Act of 2022) will receive a distribution of their vested aggregate account balance without the consent of the participant. If the distribution is less than \$1,000, the distribution will be made in the form of lump sum cash. If the distribution is greater than \$1,000, but less than \$7,000 (increased from \$5,000 prior to 2024 as a result of the SECURE 2.0 Act of 2022), the Plan will pay the distribution in an automatic direct rollover to an individual retirement account (IRA). Under certain conditions participants may request a hardship distribution if certain criteria are met.

Forfeited Accounts

During 2024 and 2023, forfeitures of \$170,847 and \$0, respectively, were used to reduce the Company's contributions. Additionally, during 2024 and 2023, forfeitures of \$47,891 and \$52,068, respectively, were used to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, the balance of forfeited accounts held by the Plan totaled \$41,626 and \$95,145, respectively. These amounts will be used in accordance with the applicable plan provisions.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the Trustee. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest less amounts defaulted (if any). Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Loan administration and distribution fees are charged directly to the participant's account and are included in administrative expenses. The Plan also pays certain investment advisory and plan administration fees from plan assets. Certain investment-related expenses are included in net appreciation in fair value of investments.

In addition, the Company is eligible for expense reduction credits from Fidelity Management Trust Company (the Trustee). Total credits received from the Trustee and used to offset expenses during the years ended December 31, 2024 and 2023 were \$3,449 and \$3,932, respectively, and are recorded as other income.

Recently Adopted Accounting Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans. Plan management adopted mandatory provisions and continues to evaluate the impact of the optional provisions of SECURE 2.0 while awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor (DOL). The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations. Through December 31, 2024, the application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Recently Adopted Accounting Standards (Continued)

Effective January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13, *Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*. The ASU addresses how the credit risk associated with certain financial instruments, including contribution receivables, is to be measured and recognized. The ASU was adopted on a prospective basis and did not have an impact on the Plan's financial statements.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**3. FAIR VALUE MEASUREMENTS (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Investments are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Collective trust:* This investment is valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV is a readily determinable fair value and is the basis for current transactions. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trusts in order to ensure the securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held investments in registered investment companies with an aggregate fair value of \$110,800,827 and \$91,403,408 at December 31, 2024 and 2023, respectively, and a collective trust with an aggregate fair value \$1,722,681 and \$2,528,402 at December 31, 2024 and 2023, respectively. All investments used Level 1 inputs to calculate their respective fair values.

**4. CERTIFICATION OF FINANCIAL INFORMATION**

The financial data included in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023 and supplemental schedule of assets (held at end of year) as of December 31, 2024, has been certified as complete and accurate by the Trustee, a qualified institution. The following certified information was obtained by management and agreed to or derived from information certified by the Trustee as complete and accurate, and has not been audited by the independent auditors for the Plan: investments at fair value, notes receivable from participants, net appreciation in fair value of investments, interest and dividend income, other income, and interest on notes receivable from participants.

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer discretionary profit sharing contributions and earnings thereon, and any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**6. TAX STATUS**

The plan sponsor adopted a non-standardized pre-approved plan document, which received an opinion letter dated June 30, 2020, in which the IRS stated that the non-standardized pre-approved plan document was in compliance with applicable requirements of the IRC. The Plan has not received a determination letter specific to the Plan itself and has been amended since adopting the non-standardized pre-approved plan document; however, the plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by an affiliate of the Trustee; therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative expenses were paid by the Plan or the Company. The Plan issues loans to participants, which are secured by the vested balance in the participant's accounts and qualify as party-in-interest transactions. Employees of the Company provide administrative services to the Plan for which no fees are charged.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through July 24, 2025, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.
