Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Carter-Jones Companies 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Notes to Financial Statements

1. Description of the Plan

The following description of the Carter-Jones Companies 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit-sharing plan established in 1994 to provide retirement benefits to employees of the Carter-Jones Companies (the Companies, Employer, or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Administration

The Plan is administered by the Companies or persons appointed by the Companies. Charles Schwab Trust Bank, trustee of the Plan, receives and holds Plan assets and makes distributions to participants in accordance with the Plan document. Findley, Inc. provides recordkeeping services to the Plan.

Effective January 1, 2021, the Plan was restated, with no changes to the structure of the Plan. Effective January 1, 2022, the Plan was amended to allow in-plan Roth rollover contributions.

Eligibility

All employees of the Companies who have completed six months of service and are age 18 or older are eligible to participate in the Plan.

Participant Contributions

Participants may contribute a voluntary percentage or dollar amount of pre-tax annual compensation, as defined by the Plan. In addition, employees may make rollover deposits to the Plan from other qualified plans or certain individual retirement accounts. The Plan also permits participants to make Roth deferral contributions. The Plan also allows in-plan Roth rollover contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Employer Contributions

The Companies may make a discretionary matching contribution for all employees in the Plan. In 2024 and 2023, the Companies matched up to 1.5% of base compensation (as defined) contributed to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's discretionary contributions, and an allocation of earnings and losses thereon. Allocations are based

on the provisions of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, participant rollover contributions, and earnings or losses thereon. Employer discretionary contributions and related earnings or losses thereon vest in accordance with the following schedule:

Upon death or disability, the participant (or their beneficiary in case of their death) becomes 100% vested in the Plan. Upon reaching normal retirement age or after five years of service in the Plan, the participant becomes 100% vested in the Plan.

Forfeitures

Forfeitures are retained in the Plan and will first be used to pay administrative expenses. Any remaining amounts will be used to reduce future Employer contributions payable under the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$259,900 and \$174,624, respectively. Forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023 were \$65,839 and \$42,290, respectively.

Payment of Benefits

The benefit to which a participant is entitled equals the value of the participant's vested interest in his or her account. Upon death, disability, retirement, or termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum distribution or in installments, in accordance with Plan provisions. With respect to distributions, if the vested balance is equal to or less than \$5,000, the vested balance will be automatically paid in a lump sum. If the vested balance is over \$5,000, the participant must consent to any distribution; however, the Plan administrator will commence distribution of the vested balance without consent at the time that payments must begin under applicable federal law.

Notes Receivable from Participants

Loans are permitted to be made to active participants. The notes receivable documenting the loans are secured by the participant's vested account balance and must be for a minimum of \$1,000, up to the lesser of ½ of the participant's vested account balance at the time of the loan or \$50,000. Participants may only have one loan outstanding under the Plan at any time. The loans are repayable over one to five years, unless used to acquire a principal residence, and bear interest at the prime rate plus 1% as of the loan date (prior to April 1, 2017, interest was fixed at 9.50%). Interest rates ranged from 8.50% to 9.50% on loans outstanding at December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Significant items subject to such estimates and assumptions include the fair value of investments (see Note 3).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative Expenses

Administrative expenses may be paid by the Employer. However, the Plan may pay transaction fees, which are charged directly to the specific participant generating the transaction.

Payment of Benefits

Benefits are recorded when paid.

Evaluation of Subsequent Events

The Plan has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements, and has determined no events have occurred through that date that require adjustment to or disclosure in the financial statements.

3. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820 (ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methods and assumptions used by the Plan to estimate the fair value of its investments. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common Collective Trusts - The fair value of participation units held in common collective trusts is based on the net asset value (NAV) reported by the fund managers as a practical expedient as of the financial statement dates and recent transaction prices. The investment objective of the common collective trusts is to provide preservation of capital and provide relatively stable returns consistent with a low-risk profile. The collective trust provides for daily redemptions by the Plan at reported NAV per share, with no advance-notice requirement. There were no unfunded commitments as of December 31, 2024 or 2023.

Mutual Funds - Investments in registered investment companies are valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, notes receivable from participants, and cash, as reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest on notes receivable from participants, as reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

- Investment information included in the supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

6. Tax Status of the Plan

The Plan uses a pre-approved plan document sponsored by Findley, Inc. Findley, Inc. received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the pre-approved plan document, as then-designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transactions with Parties-in-Interest

The participants have been identified as parties-in-interest. Therefore, participant loans qualify as party-in-interest transactions, which are exempt from the prohibited rules under ERISA. Certain Plan investments are managed by Charles Schwab Trust Bank, the trustee of the Plan, and these transactions qualify as exempt party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. The Plan made direct payments to the trustee for the years ended December 31, 2024 and 2023 in the amounts of \$65,839 and \$42,290, respectively. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. All other fees incurred due to Plan operations are paid by the Plan Sponsor annually.
