Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Provider Care Group Safe Harbor 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a multiple-employer defined contribution plan, established January 1, 2016, covering all eligible employees of certain affiliates of HCA Physician Services, Inc. (the Company), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Participants are eligible to participate on the first day of the month following two months of continuous employment and upon attaining age 18.

The Plan covered all eligible employees of the participating employers (Employers) as defined in the plan agreement. The following companies and all of their wholly-owned subsidiary companies are Employers: Capital Area Providers, Capital Area Cardiology, Capital Area Neurosurgeons, Capital Area Primary Care Providers, Capital Area Specialty Providers, Methodist Cardiology Physicians, Methodist Physicians Alliance, Texas Institute of Medicine and Surgery, Golden State Providers, a Medical Corporation, Capital Area CareNow Physician Associates, Methodist CareNow Physician Associates, Capital Area Multispecialty Providers, Charlotte Urgent Care Providers, P.C., Kansas IPS Medical Services, P.A. (added as an Employer effective May 2024), KS-I Medical Services, P.A. (added as an Employer effective May 2024), EHRA Medical Services of Kansas, P.A. (added as an Employer effective May 2024), Hospital Based Medical Services of Tennessee-I, P.C. (added as an Employer effective May 2024), Tennessee HB Medical Services, P.C., Tennessee IPS Medical Services, P.C. (added as an Employer effective May 2024), Texas IPS Medical Services, P.A. (added as an Employer effective May 2024), TX Radiology Medical Services, P.A. (added as an Employer effective May 2024), TX-I Medical Services, P.A. (added as an Employer effective May 2024) and EHRA Medical Services of Texas, P.A. (added as an Employer effective May 2024).

Effective January 1, 2016, the Company assumed sponsorship of the THN & LPN Physicians 401(k) Plan & Trust (THN & LPN Plan), and the Plan Administration Committee of HCA Inc. assumed the role of plan administrator. In connection with these changes, the THN & LPN Plan was spun off into two separate plans, the Provider Care Group Mirror 401(k) Plan (Mirror Plan) and the Plan.

General (continued)

The assets of the THN & LPN Plan were transferred into the Provider Care Group 401(k) Plan Group Investment Trust (Group Trust). Also, to facilitate the Company's on-going oversight of the plans, the Northern Trust Company (Trustee) was appointed as the trustee of the Group Trust, and Northwest Plan Services (Recordkeeper) was retained as the recordkeeper for the Mirror Plan and the Plan.

Contributions and Vesting

Participants may defer from 1% to 50% of eligible salary to the Plan, subject to Internal Revenue Code (the Code) limitations. Participants who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions, subject to Code limitations. Participants may also contribute amounts representing distributions from other qualified plans.

All new hires will be automatically enrolled in the Plan upon reaching eligibility. They will be enrolled with a contribution rate of 3% of eligible pay, and the contribution rate will be automatically increased by 1% (up to a maximum of 15%) in January of each year. Participants are required to go to his or her online account in order to opt out of automatic enrollment, change election percentages, or opt out of automatic contribution increases.

The Plan provides that each year the Company will make matching contributions based on a percentage of the participant's pre-tax contributions. The Company will provide a 100% match on contributions up to 3% of the participant's eligible pay and 50% match on contributions between 3% and 5% of the participant's eligible pay.

Company and participant contributions may not exceed the maximum amount deductible for federal income tax purposes.

Participants are fully and immediately vested in their contributions and their matching contributions under safe harbor provision plus actual earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Employers' contributions. The participant directs the investment of his or her account to any of the available investment options available under the Plan. Each participant's account is credited/charged with Plan earnings/losses and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The

Participant Accounts (continued)

benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Benefit Payments

On termination of service due to retirement, death or permanent disability a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. After reaching age 59½, active participants may elect to receive a distribution of all or any portion, of the balance in their accounts. In addition, Plan participants may take a withdrawal from the Plan in the event of a financial hardship and are limited to the participant's elective account balance.

Administrative Expenses

Fees related to the administration of transaction expenses, recordkeeping and investment management services are charged directly to the participant's account are included in administrative expenses. Expenses paid by the Company are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan, subject to the provisions of ERISA. Upon termination of the Plan, each participant would be fully vested in the value of his/her account after payment of any accrued expenses and liabilities of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States.

Valuation of Investments and Income Recognition

The Plan's investments are held in a Group Trust and are stated at fair value (see Note 4 – Fair Value Measurements). The fair value of participation units owned by the Group Trust in the collective trust pools are based on net asset value (NAV) on the last business day of the Plan year.

2. Summary of Significant Accounting Policies (continued)

Valuation of Investments and Income Recognition (continued)

Purchase and sales of investments are recorded on a trade date basis. Investment earnings are recorded on the accrual basis. Net appreciation (depreciation) includes the Group Trust's unrealized gains and losses on investments held at year end as well as the realized gains and losses on investments sold during the year.

Contributions

Participant contributions and matching Company contributions are recorded in the year in which the participant compensation is earned.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. Interest in Group Trust

All of the Plan's investments are in the Group Trust, which was established for the investment of the assets of the Plan and the Mirror 401(k) Plan. The Group Trust includes several Group Trust Investment Accounts (or Investment Pools). At December 31, 2024 and 2023, the Plan's interest in the net assets of the Group Trust was approximately 48.76% and 49.56%, respectively. Investment income and administrative expenses relating to the Group Trust are allocated based upon each plan's share of selected investments and the related income (loss) and expenses on those investments. The following tables present the net assets of the Group Trust and the Plan's interest in those balances at December 31, 2024 and 2023:

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.
- Level 3 – Unobservable inputs for the assets or liabilities (i.e., supported by little or no market activity).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

Following is a description of the valuation methodologies used for major categories of assets measured at fair value by the Plan.

Common/collective trusts: These investments are traded in an active market and are classified within Level 1 of the fair value hierarchy. This category includes investments in equity and debt securities held to replicate the performance of a specific equity or bond market index. The fair value of investments in common/collective trusts are based on the value per unit as published daily by the investment manager, and represent the NAV of units held by the Plan at year end.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, liquidity, overall market volatility and global events. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Income Tax Status

The Plan has received its most recent determination letter from the Internal Revenue Service (the IRS) dated June 25, 2018, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to the determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an

uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Transactions With Parties-In-Interest

Parties-in-interest are defined under U.S. Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments are managed by the Trustee. These transactions qualify as parties-in-interest transactions.

8. Subsequent Events

The Plan evaluated all events or transactions that occurred after December 31, 2024, through August 12, 2025, the date these financial statements were available to be issued.

In July 2025, a plan-to-plan transfer related to the 2024 acquisition of a hospital-based physician staffing entity by HCA Healthcare, Inc. occurred. As a result of this transfer, net assets of approximately \$110 million will be transferred into the Plan. This information has not been audited by independent accountants and is provided for informational purposes.
