Note 1 - Description of Plan

The following description of the Allied Telesis 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for complete information regarding the Plan's definitions, benefits, eligibility, and other matters.

General - The Plan is a defined contribution plan that was established effective January 1, 1990, for the benefit of employees of Allied Telesis, Inc. and Allied Telesis Capital Corporation (collectively referred to as the "Employer"). All employees are eligible to participate in the Plan except leased employees, nonresident aliens, employees covered by a collective bargaining agreement with the Employer, and reclassified employees. Eligible employees may enter the Plan on the first day of the month after their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - Participants may elect to defer up to 100% of their eligible compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes a provision whereby all newly eligible employees are automatically enrolled at a 4% deferral rate unless they elect a different deferral rate or elect not to participate in the Plan. Automatically enrolled participants will have their deferral rate increase 1% each year, up to a maximum of 10%, unless otherwise elected. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Employer may make discretionary matching contributions up to 4% of eligible compensation. During the year ended December 31, 2024, employees of Allied Telesis, Inc. received employer matching contributions equal to 25% of employee deferrals up to 4% of eligible compensation. During the year ended December 31, 2024, employees of Allied Telesis Capital Corporation received employer matching contributions equal to 100% of employee deferrals up to 3% of eligible compensation.

Effective January 1, 2025, the discretionary matching contribution was changed to 50% of elective deferrals, up to 4% of eligible compensation for both Allied Telesis, Inc. and Allied Telesis Capital Corporation.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions and employer matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in salary deferral and employer matching contributions plus actual earnings thereon.

Notes Receivable From Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Note 1 - Continued

Payment of Benefits - Upon termination of service, retirement, death, disability, or certain financial hardships, a participant or beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment. Participants may also elect to receive in-service withdrawals from balances rolled into the plan.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Reclassification - Certain prior year amounts have been reclassified for consistency with the current period presentation.

Subsequent Events - The Plan's management has evaluated subsequent events through August 12, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - The funds are valued at the NAV provided by the fund's trustee. The funds do not have a readily determinable fair value; however, NAV is calculated in a manner consistent with the measurement principles applicable to investment companies under U.S. GAAP. Therefore, NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. For the Great Gray Trust Franklin Growth Fund, if the Plan initiates a redemption of more than \$1 million of the collective trust, the issuer reserves the right to require five business days' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. For the Putnam Large Cap Value, the Plan must give a withdrawal notice no later than five business days prior to the date of the withdrawal. Under unusual circumstances, the withdrawal may be suspended or payments deferred if such action is necessary to avoid a materially adverse impact on other participating plans.

Self-Directed Brokerage Accounts - Accounts primarily consist of a money market fund, mutual funds, common stock, cash and cash equivalents, and unit trust investments that are valued on the basis of readily determinable market prices. Unit trust investments are valued at NAV which is used as a practical expedient to estimate fair value.

Note 4 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Party-in-Interest Transactions

Certain Plan investments are managed by Schwab and its affiliates. Schwab is the trustee for the Plan and, therefore, transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax Status

The Employer adopted a Schwab Retirement Plan Services pre-approved plan document. Schwab received an approval letter from the IRS dated September 21, 2020 which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
