## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of the  
Win IT America Inc 401(K) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Win IT America 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Win IT America Inc 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### (a) GENERAL

The Plan is a defined contribution and savings plan for employees of Win IT America Inc. (the Company or the Plan Sponsor). The Plan covers substantially all eligible employees except for residents of Puerto Rico and non-resident aliens, as defined by the Plan Agreement, provided they are 21 years of age and have completed 3 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan initially became effective on January 1, 2020 and was most recently amended and restated effective June 1, 2022 as part of the Cycle 3 Restatement to bring the Plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37.

#### (b) CONTRIBUTIONS

A participant may elect to contribute up to 90% of eligible compensation, subject to Internal Revenue Service (IRS) regulation limitations, not to exceed \$23,000 for the year ended December 31, 2024. Participants who have attained the age of 50 by the Plan year-end may also make catch-up contributions of \$7,500 during the year ended December 31, 2024. Eligible participants are auto enrolled into the Plan at 4%. The Plan contains an automatic enrollment feature where employees are enrolled in the Plan on the first day of the month coinciding with or following the date the employee meets the eligibility requirements. The automatic enrollment is at 4% of compensation unless the employee makes an alternative deferral request. The Plan Sponsor may make a discretionary matching contribution equal to 100% of the first 4% of participant contributions, as well as discretionary profit-sharing contributions. During the year ended December 31, 2024, discretionary matching contributions were equal to \$339,917. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

#### (c) PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions and Plan earnings. Allocations are based on participant compensation. The benefit to which a participant is entitled is the participant's vested account balance. The Plan does not allow for employer matching contributions. Forfeitures of terminated participants' non-vested accounts are used to reduce employer contributions or Plan expenses for the Plan year. Forfeitures of \$95,937 were used to reduce employer contributions for the year ended December 31, 2024. Available forfeitures were \$489 and \$8,888 as of December 31, 2024 and 2023, respectively.

#### (d) VESTING

Participants are immediately vested in their voluntary contributions plus earnings thereon, and vest in employer discretionary matching and profit-sharing contributions according to the following schedule: 40% after 2 years of service, and 15% every year thereafter, with 100% vesting after 6 years of service.

#### (e) PAYMENT OF BENEFITS

On termination of service, a participant may elect to receive a single lump-sum payment of the vested interest of his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Payment of benefits will begin as soon as administratively feasible following the date of termination.

#### (f) ADMINISTRATIVE EXPENSES

The Company incurs certain expenses in administering the Plan, which are not passed on as expenses of the Plan. Transaction and investment fund expenses are paid by the participants.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### (a) BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual method of accounting.

#### (b) USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported revenues and expenses during the period. Although the Plan Administrator believes its estimates are appropriate, changes in assumptions utilized in preparing such estimates could cause these estimates to change sometime in the future.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

#### (c) RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments, including mutual funds and common/collective trusts. Investment instruments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment instruments, it is reasonably possible that changes in the values of investment instruments will occur in the near term and that such changes could materially affect amounts reported in the financial statements.

#### (d) INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### (e) SUBSEQUENT EVENTS

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of December 31, 2024, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through August 12, 2025, the date these financial statements were available to be issued. No material events or transactions were noted to have occurred.

### NOTE 3 - INVESTMENTS

The Plan's funds were maintained by Reliance Trust Company (Reliance) as of December 31, 2024, the custodian of the Plan. The funds are credited with contributions and actual earnings on the underlying investments and charged for Plan withdrawals. The Plan's funds in the financial statements as of December 31, 2024 are the values as reported to the Plan by Reliance Trust.

The Plan's independent auditor did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the statements of net assets available for benefits and changes in net assets available for benefits and the supplementary schedule of assets (held at end of year).

Participants may change their investment options at their discretion.

#### **NOTE 4 - FAIR VALUE MEASUREMENT**

The Plan adopts a fair value measurement accounting standard (the Standard) for those assets that are re-measured and reported at fair value at each reporting period. This standard establishes a single authoritative definition of fair value, sets out a framework for measuring fair value based on inputs used, and requires additional disclosures about fair value measurements. This standard applies to fair value measurements already required or permitted by existing standards.

The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at net asset value:

- **Mutual Funds:** Valued at the closing price reported on the active market on which the funds are traded.
- **Collective Investment Trusts:** Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV is based on the value of the underlying assets owned by the fund, less its liabilities, and then divided by the number of shares outstanding. There are no redemption restrictions or unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5 - TAX STATUS

The Plan obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income tax has been recorded in the Plan's financial statements.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

#### **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
