Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Arvig Enterprises, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Arvig Enterprises, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Arvig Enterprises, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Arvig Enterprises, Inc. 401(k)'s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Note 1 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements of Arvig Enterprises, Inc. 401(k) Plan (the Plan) have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those amounts.

Investment valuation – The investments are reported at fair value. The Plan's trustee, Fidelity Management Trust Company (FMTC), certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Plan administration fees cover day-to-day expenses of the Plan. In some cases, these costs are covered by investment fees that are deducted directly from investment returns. In other cases, these costs are either paid by the Plan or passed through to participants.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through August 18, 2025, which is the date the financial statements were available to be issued.

Arvig Enterprises, Inc. 401(k) Plan Notes to Financial Statements

Note 2 – Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan document, as amended, for a more complete description of the Plan's provisions.

General – The Plan is a participant-directed, defined-contribution profit sharing plan covering substantially all employees of Arvig Enterprises, Inc., AEI Construction, Inc., AEIS Construction, Inc., All State Communications, Inc., Time Communications, Inc., Security Plus Alarms, Inc., and CD Communications, Inc. that is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Arvig Enterprises, Inc. (the Company) is the Plan's sponsor.

Employee participation – Each employee becomes a participant in the Plan after satisfying the following requirements:

1. Attained the age of 20½ years.
2. Eligibility to enter the Plan starts on their hire date.
3. The employee is not:
 - a resident of Puerto Rico;
 - covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations;
 - a leased employee;
 - a non-resident alien with no income from a United States source;
 - an individual who is a signatory to a contract, letter of agreement, or other document that acknowledges status as an independent contractor not entitled to benefits under the Plan, and not otherwise classified by the employer as a common law employee and the employer does not withhold income taxes, file Form W-2 (or any replacement form), or remit Social Security payments to the Federal Government for the employee, even if the employee is later adjudicated to be a common law employee.

Participants become eligible to receive employer matching contributions the first day of the next month following their hire date.

Contributions – Each year, participants may contribute up to the lesser of 90% of pretax annual compensation or limits established by the IRS, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to make Roth contributions utilizing after-tax contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, collective trusts, self-directed brokerage accounts, and a money market fund as investment options for participants.

All newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the participant, deferrals are automatically increased annually by 1%, up to a maximum auto-deferral of 15%.

Arvig Enterprises, Inc. 401(k) Plan Notes to Financial Statements

The Company may elect to make discretionary contributions to the Plan from its current and accumulated profits. Participants must be employed on the last day of the Plan year to be eligible for employer discretionary contributions. The Company made no discretionary contributions to the Plan during the years ended December 31, 2024 and 2023.

During 2024 and 2023, the safe harbor matching contribution equaled 100% of the first 1% of employee elective deferrals and 50% of the next 3% of deferrals up to 4%.

Effective November 23, 2021, participants employed by All State Communications, Inc. and Time Communications, Inc. became eligible for employer matching contributions equaling 37.5% of the first 4% of employee elective deferrals for a total available match of 1.5%.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contribution, the employer’s contribution, and allocations of Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

Vesting – Participants are fully vested in salary deferrals and safe harbor nonelective employer contributions, and earnings thereon. In general, vesting in Company contributions is based on years of service, as defined, starting with 20% after two years with increases in increments of 20% per year until fully vested after six years.

Notes receivable from participants – Participants may borrow from their fund accounts between a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance of the participant’s account and bear fixed interest at a rate not less than 1% above the prime rate of interest most recently published in the Money Rates section of the Wall Street Journal. The maximum loan term is five years unless the loan qualifies as a home loan, in which case the term of the loan is not to exceed ten years. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the interest rates on outstanding loans ranged from 4.25% to 9.50% with various maturities through October 2034.

Payment of benefits – A participant’s account balance may be withdrawn under any of the following circumstances:

- Retirement at the normal retirement age of 65
- Death (accumulated Plan benefits are paid to a designated beneficiary)
- Minimum required distributions
- Termination of employment
- Permanent and total disability
- Financial hardship (immediate and heavy financial need of participant), which meets certain qualifications of the IRS. Only the vested portion of each account balance may be withdrawn

The Plan allows for in-service distributions for participants who have attained the age of 59½. Distribution of benefits are in the form of a lump-sum payment.

Arvig Enterprises, Inc. 401(k) Plan Notes to Financial Statements

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the Plan and may be used to pay Plan administrative expenses, with any remaining amount used to reduce future Company contributions.

Forfeiture accounts are not considered allocable until the participant’s break-in-service period, five consecutive one-year breaks, has fully lapsed because an employee can re-enter the Plan during this period and have their account reinstated. Forfeited nonvested account balances amounted to \$188,004 and \$56,314, respectively, as of December 31, 2024 and 2023. Forfeitures of \$30,605 and \$88,337 during 2024 and 2023, respectively, were used to reduce employer matching contributions.

Note 3 – Information Prepared and Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, FMTC, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest, dividends, and interest income from notes receivable from participants reflected on the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments reflected on the schedule of assets (held at end of year).

Note 4 – Income Tax Status

The Plan document is a prototype standardized defined contribution plan that received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan’s tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Arvig Enterprises, Inc. 401(k) Plan Notes to Financial Statements

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Self-Directed Brokerage Accounts – Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Collective Trusts – Units held in collective trusts (CT) are valued using the net asset value practical expedient (NAV practical expedient) as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

Collective trusts, which are measured at NAV as a practical expedient, can be redeemed daily and have no redemption notice period. There are no unfunded commitments associated with the collective trusts and money market funds held by the Plan at December 31, 2024 and 2023.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
