Independent Auditors' Report

NOTES TO FINANCIAL STATEMENTS

GASSER CHAIR CO., INC. 401(k) PROFIT SHARING PLAN

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of Gasser Chair Co., Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined-contribution plan covering all full-time employees of Gasser Chair Co., Inc. (the Company) who are at least 18 years of age, have completed 1,000 hours and have completed one year of service for eligibility purposes. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Amendment - Effective June 8, 2023, the Company restated the Plan to allow elective deferral contributions to be made as Roth contributions. Participants must designate how much they would like to contribute as an after-tax Roth contribution, but may continue designating all contributions as normal pre-tax contributions if they choose.

Contributions - Under the Plan's provisions, each participant may contribute an amount up to the elective deferral dollar limit and the Section 415 limitation of the Internal Revenue Code. Participants may also roll over amounts representing distributions from other qualified defined-benefit or contribution plans. The Company may elect to make safe harbor and/or discretionary contributions to the Plan at the option of the Company's Board of Directors. Upon enrollment in the Plan, a participant may direct employee and employer contributions to any of the available investment options. Participants may change their investment options at their discretion. All of the balances of the Plan represent participant-directed investments.

Participant accounts - Allocations of the Company's contribution and Plan earnings are based on each participant's earnings or account balances, as defined. In addition to the above-mentioned allocations, under the Plan's provisions, each participant's account is credited with the participant's contribution. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

Vesting - Vesting in participants' accounts relating to the Company discretionary contribution is based on years of continuous service. A participant is 100% vested in the Company contribution after six years of credited service. Participants are immediately vested in their deferrals and contributions rolled over from other qualified defined-benefit or contribution plans, the Company safe harbor contribution, plus actual earnings thereon.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Notes receivable from participants - Participants may borrow from their account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. In addition, each participant is limited to two loans outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at fixed rates which are determined by adding 1% to the prime interest rate at the time of the loans. The participant has the option to repay principal and interest ratably through payroll deductions based on payroll frequency or quarterly payments.

Payment of benefits - Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may only receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited accounts - For the years ended December 31, 2024 and 2023, forfeited accounts totaled \$0 and \$3,079, respectively. Forfeitures may be used to pay administrative expenses and/or reduce future Company contributions. During the years ended December 31, 2024 and 2023, Plan expenses in the amount of \$0 and \$1,820, respectively, were paid from the forfeiture account.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates and subsequent events - The Plan Administrator makes estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates. In preparing the financial statements, including estimates and disclosures, Plan management has considered the effects of subsequent events through August 7, 2025—the date the financial statements were available to be issued.

Allowance for credit losses - The Plan is exposed to credit losses primarily through employer contributions receivable. However, the Plan has not experienced credit loss since inception and, accordingly, has not estimated an allowance for credit losses.

Investment valuation and income recognition - The Plan's investments are stated at fair value as of December 31, 2024 and 2023. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants and the measurement date. See NOTE D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's realized gains and losses on investments sold, as well as held, during the year. Dividends are recorded on the ex-dividend date and are included in net appreciation (depreciation) in fair value of investments.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent participant loans are reclassified as distributions based upon the terms set forth in the Plan document.

NOTE C - PARTICIPANT CONTRIBUTIONS RECEIVABLE

For the year ended December 31, 2024, the Plan sponsor erroneously miscalculated participant deferrals in the amount of \$1,370. The amounts, along with any calculated lost earnings, were subsequently deposited into the Plan in accordance with the Plan's policies and applicable Department of Labor (DOL) regulations.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.
- Level 2 inputs consist of significant observable inputs other than quoted prices for identical assets.
- Level 3 inputs consist of significant unobservable inputs that are not corroborated by market data and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were available to the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE E - INVESTMENTS

Unaudited information certified by the Plan custodian - The December 31, 2024 and 2023, statements of net assets available for benefits, the investment activities included on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the accompanying notes to financial statements were prepared in part or entirely from information certified by John Hancock Life Insurance Co. (U.S.A.) in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information certified includes assets of \$9,050,491 and \$9,041,473 at December 31, 2024 and 2023, respectively, and related investment income of \$900,740 and \$1,143,540 for the years ended December 31, 2024 and 2023, respectively.

NOTE F - EXCESS PARTICIPANT CONTRIBUTIONS PAYABLE

The Plan Sponsor erroneously remitted participant contributions in excess of actual payroll withholdings. Excess contributions amounting to \$1,455 are recorded as a liability on the accompanying statements of net assets available for benefits as a reduction of participant directed contributions for the year ended December 31, 2024. The Plan reimbursed these excess contributions after the year end.

NOTE G - ADMINISTRATION OF PLAN ASSETS, EXPENSES AND RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are shares of mutual funds managed by John Hancock Life Insurance Co. (U.S.A.). John Hancock Life Insurance Co. (U.S.A.) is the custodian; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. For the years ended December 31, 2024 and 2023, these administrative expenses were paid directly by Gasser Chair Co., Inc. Participant loan fees and distribution fees are paid by the respective participants.

Investment-related expenses are included in net appreciation in fair value of investments.

NOTE H - TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the determination letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE J - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.
