## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
The Associated: Jewish Community Federation of Baltimore 401(k) Thrift Plan

### SCOPE AND NATURE OF THE ERISA SECTION 103 (A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of The Associated: Jewish Community Federation of Baltimore 401(k) Thrift Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### OPINION

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

**NOTE 1**    **DESCRIPTION OF PLAN**

The following brief description of The Associated: Jewish Community Federation of Baltimore 401(k) Thrift Plan (Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Plan Documents for more complete information.

**GENERAL**

The Plan is a defined contribution plan offered to employees of The Associated: Jewish Community Federation of Baltimore, Inc. (Company) and the employees of its constituent agencies. Employees normally scheduled to work 1,000 hours or more per year are automatically enrolled in the Plan at a 2% pre-tax deferral rate on the first of the month following completion of the eligibility requirements of 30 days of service and being 19 years old, unless they otherwise elect not to participate. Temporary and leased employees are not eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS**

Each year, participants may contribute up to 100% of their annual compensation as defined in the Plan, subject to certain annual limitations in the Internal Revenue Code. Participants may designate some or all of their own contributions as Roth 401(k) contributions. Such contributions and any activity related to those amounts are accounted for separately from the participants' pre-tax contributions. In addition, participants may rollover distributions received from other plans.

Each year, the Company and its constituent agencies match 100% of a participant's salary-deferred contribution up to a maximum of 4% of compensation for eligible participants. The Company also may make a discretionary contribution, as determined separately by the Company and each constituent agency.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, the Company's matching and discretionary contributions, and an allocation of any Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow against the balance in their account, up to the lesser of 50% of their vested balance or \$50,000. Loan terms require amortization of principal and interest over a

period not to exceed five years. Loans used to acquire a principal residence may extend beyond a five-year term. The loans bear interest at the prime rate plus 1%. Loans are repaid through payroll deductions and may be repaid in full at any time.

**VESTING**

Participants are immediately vested in their voluntary contributions and employer-matching contributions plus actual earnings thereon. A participant is fully vested in employer discretionary contributions after three years of credited service, retirement, disability (as defined by the Plan), or death.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct employee contributions into various investment options offered by the Plan. If an investment option is not selected, contributions are defaulted to the target date funds. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

**PAYMENT OF BENEFITS**

Benefits are payable as soon as practicable following normal retirement, disability, death, or termination of employment, subject to specific benefit payment requirements in the Plan Documents.

**FORFEITED ACCOUNTS**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,741 and \$1,629, respectively. These accounts were used to reduce future Company contributions and Plan expenses in accordance with the Plan Documents. In 2023, Plan expenses were reduced by \$2,293, from forfeited non-vested accounts. There were no reductions in 2024.

**ADMINISTRATIVE EXPENSES**

Substantially all administrative expenses are paid by the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**ACCOUNTING STANDARDS CODIFICATION**

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by

the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

**BASIS OF ACCOUNTING**

The accompanying financial statements are prepared on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with GAAP in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**VALUATION OF INVESTMENTS**

Investments are reported at fair value except for fully benefit-responsive investment contracts. See Note 4 for a discussion of fair value measurements.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Documents.

**RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through July 31, 2025, the date the financial statements were available to be issued.

**NOTE 3** INFORMATION CERTIFIED BY THE CUSTODIANS

The Plan's investments were held by the Custodians, State Street Bank and Trust Company and Transamerica Financial Life Insurance Company, at December 31, 2024 and 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Custodians. The information was not audited by the Plan's independent auditors. As of December 31, 2024 and 2023, certified investment information consisted of the following:

**NOTE 4** VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the Codification are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5**    **INVESTMENTS IN GROUP ANNUITY CONTRACT**

The Plan has investments in the New York Life Anchor and Transamerica Financial Life Insurance Company group annuity contracts, which are fully benefit responsive investment contracts and, therefore, are reported at contract value. Contract value, as reported to the Plan by New York Life Anchor and Transamerica Financial Life Insurance Company, represents contributions made under the funds, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with issuer. Such events include the following: (a) amendments to the Plan Documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include: (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuers are probable of occurring.

The contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity dates.

**NOTE 6**    **PLAN TERMINATION**

Although it did not express any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the value of the interests of all participants and beneficiaries shall be determined and distributed to them in a lump sum.

**NOTE 7**    **RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Custodians of the Plan. The Plan pays recordkeeping, investment management, and accounting fees to parties in interest. The Plan paid approximately \$137,000 and \$124,000 to parties in interest for the years ended December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest

transactions and are exempt from the prohibited transaction rules of ERISA. In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation (depreciation) in fair value of investments.

**NOTE 8**    **TAX STATUS**

The Plan obtained its latest determination letter in June 2020, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.
