Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Goodwill Industries Employee Retirement and Incentive Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Goodwill Industries Employee Retirement and Incentive Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Goodwill Industries Employee Retirement and Incentive Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Goodwill Industries Employee Retirement and Incentive Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A - Description of Plan:

The following description of the Employee Retirement and Incentive Plan of Goodwill Industries of The Columbia Willamette provides only general information. This Plan agreement was adopted effective January 1, 1995, participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- 1) General - The Plan is a defined contribution plan covering employees who are age 21 with 1,000 hours of service in 12 months. It is subject to the Employee Retirement Income Securities Act of 1974 (ERISA).
- 2) Contributions - Employees may elect to make voluntary after tax contributions of up to 10% of their gross salary. Employer contributions consist of a base contribution of at least 3% and not more than 7% of total compensation, plus an additional contribution of at least 3% and not more than 4.3% of compensation in excess of 20% of the social security taxable wage base. There is also a discretionary match on the first 2% of TSA salary deferrals.

The Plan permits the Organization to designate one or more investment options as the Plan's "Qualified Default Investment Alternative" within the meaning of Section 624 of the Pension Protection Act of 2006 and regulations issued thereunder. The Organization designated the T. Rowe Price Target Date funds as the default investment option under the Plan. Notice regarding the Organization's designation of these funds as the Plan's default investment option was provided to Plan participants.

Participants direct the investment allocation of all contributions.

- 3) Participant Accounts - Each participant's account is credited with the participant's contribution, the employer matching contribution, and an allocation of (a) the Organization's contribution, (b) Plan earnings, (c) forfeitures of terminated participants' non-vested accounts, and (d) an allocation of administrative expenses that paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
- 4) Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based upon years of continuous service. A participants' vesting will be 20% after 2 years of service and 20% each succeeding year.
- 5) Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at a reasonable fixed rate established by the plan administrator. Interest rates range from 5.25% to 10.50%. Principal and interest is paid ratably through bi-weekly payroll deductions.

- 6) Rollovers – A participant may elect to have any portion of an eligible rollover distribution paid directly to an eligible retirement plan in a direct rollover.
- 7) Payment of Benefits - Upon retirement, disability or termination of service, the vested amounts in an account may be paid in a lump sum, in installments, or through an annuity.
- 8) Forfeited Accounts - At December 31, 2024 forfeited non-vested accounts totaled \$466,321. These accounts will be reallocated to eligible participants.
- 9) Administrative Expenses – Certain administrative expenses of the Plan are paid by the Organization. Participants are responsible for fees associated with transactions such as loan originations, account maintenance, distributions and withdrawals.
- 10) Plan Termination – Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon plan termination, participants would become 100% vested in their account balances.

NOTE B - Summary of Significant Accounting Policies:

Basis of Accounting

The financial statements of the Plan have been prepared on a modified cash basis of accounting. The modified cash basis of accounting is based on the recording of cash and changes therein, and only recognizes revenues, expenses, assets, and liabilities resulting from cash transactions, adjusted for modifications that have substantial support in generally accepted accounting principles. Only cash and items that involve the receipt or disbursement of cash during the period are recognized, except for the following modification:

- (1) Investments are reflected at fair value.

As a result of the use of this modified cash basis of accounting, certain transactions are not recorded in the financial statements. Accounts receivable and employer contributions that have not been collected in cash are not accrued as revenue or receivables.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Net Assets Available for Benefits presents the contract value of the investment contracts. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

NOTE B – Summary of Significant Accounting Policies (Continued):

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

The contracts also include investments in pooled separate accounts, which were stated at fair value as determined by the Standard at December 31, 2024 and 2023, based on the quoted market values of the underlying assets in the separate accounts.

Certain events limit the ability of the Plan to transact at contract value with The Standard. Such events include the following: termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Standard may terminate the contract with 30 days advance written notice to the Organization for reasonable cause, which includes the Organization's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by The Standard, a market value adjustment may apply.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

Contributions from employees are recorded in the period in which the Company makes the payroll deductions from participant earnings.

Payment of Benefits

Benefits are recorded when paid.

management and agreed to or derived from information certified as complete and accurate by The Standard (the trustee of the Plan).

In accordance with ASC No. 820, the Plan classifies its investments into Level 1, which refers to securities traded in an active market, level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available or Level 1 securities where there is a contractual restriction, and Level 3, which refers to securities not traded in an active market and for which no significant observable market inputs are available.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Guaranteed Interest Fund: This fund is valued at contract value. The fund is fully benefit-responsive; therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fund. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the fund value for credit risk of the fund issuer or otherwise. The valuation technique used to determine the fair value is the income approach in conjunction with the cost of capital method. The parameters used for discounting in the calculation were estimated using the perspective of the principal market for the contracts under consideration. The principal market consists of other insurance carriers with similar contracts on their books. There are no reserves against the fund value for credit risk of the fund issuer or otherwise.

Pooled Separate Accounts: These accounts are valued on a net unit value basis as determined by the Standard on the last business day of the Plan year. The fair values of these investments are determined by reference to the respective fund's underlying assets, with the Standard specifying the source(s) to use for underlying investment asset prices. The investments underlying the Plan's pooled separate accounts primarily include domestic and international equities and domestic fixed income securities. The net assets value price of the pooled separate accounts is not quoted on any market; however, the unit price is based on the underlying investments which are traded in an active market.

The preceding methods may produce a fair value calculation that may be indicative of net realized value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although the plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

NOTE D - Tax Status (Continued):

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE E – Risks and Uncertainties:

The Plan's investments, in general, are subject to various risks, such as interest rate, credit, and overall market volatility risk. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions and may be affected by shifts in the market's perception of issuers and changes in interest rates. Forced liquidation, although not expected at this time, may affect the estimated value of such investments. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE F – Party-in-Interest Transactions:

The Plan invests in various Standard Insurance Company separate accounts. These investments are considered party-in-interest transactions because Standard Insurance Company serves as trustee of the Plan. The Plan's management has approved these *Subsequent Events* investment options.

NOTE G – Subsequent Events:

The sponsor of the Plan amended and restated the Plan effective January 1, 2025. The amendment increases the base contribution to not more than 8% of total compensation and increases the discretionary match on TSA salary deferrals to 3%.

The Plan has evaluated subsequent events through August 18, 2025, the date the financial statements were available to be issued.
