INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the

Opinion

We have audited the financial statements of Michigan Beverage Collective, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of Michigan Beverage Collective as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). MICHIGAN BEVERAGE COLLECTIVE NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Michigan Beverage Collective (the Plan), provides only general information. Participants should refer to the plan document and trust agreement for complete information.

General

The Plan provides group insurance to participating members of the Michigan Beverage Collective (the Employers or Members), their employees, and eligible dependents and beneficiaries. The group benefits may include medical, prescription drug, dental, vision, and short-term disability benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As of June 20, 2024, the plan now allows non-alcoholic beverage distributors to be members of the plan.

Experience-Rated Contracts

Certain insurance contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid, and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.

Premium Stabilization Reserve

The Plan is required to maintain a premium stabilization reserve with an insurance company, which can be drawn against to reduce future premium payments when premiums paid to the insurance company exceed the total of claims paid and other charges. The premium stabilization reserve has been included as an asset of the Plan until such amounts are used to pay premiums. The reserve is nonforfeitable should the insurance contract terminate. If total claims paid exceed premiums paid, the insurance company has the availability to recoup the balance owed. See Note 3 for disclosures related to the rate stabilization reserve.

Contributions

The participating employers make premium contributions. Employers have the discretion to require their employees to contribute a portion of the premium. The Plan also collects premiums for COBRA coverage from eligible participants. COBRA contributions totaled approximately \$35,600 and \$83,800 in 2024 and 2023, respectively.

Plan Termination

In the event of termination, all monies remaining in the Plan after the payment of all unpaid expenses and obligations of the Plan will be used for continuance on behalf of the Plan beneficiaries of one or more of the benefits of the character contemplated within the trust agreement until such monies have been exhausted. These benefits may not disproportionately benefit officers, shareholders, or highly compensated employees of participating employers. In lieu of termination provisions as set forth in the trust agreement, the Trustees, upon the written direction of the Board of Directors of the Association, may, after all other obligations of the Plan have been satisfied, deliver any surplus money and property in the Plan to any other successor trustee that would provide benefits for plan beneficiaries.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Payment of Benefits

Premiums paid by the Members are recorded as premium payments in the accompanying statements of changes in net assets available for benefits and benefit obligations.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Members, as provided by the Plan Document. Expenses that are paid directly by the Members are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits and benefit obligations.

Financial Instruments

The Plan is required to disclose significant concentrations of credit risk regardless of the degree of such risk. Although the Plan's cash balances may exceed federally insured limits at certain times during the year, they are, in the opinion of management, subject to minimal risk. The Plan's investments and insurance reserves are considered to be of minimal risk.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein and benefit payables. Actual results could differ from those estimates.

Uncertain Tax Positions

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan evaluates events and transactions that occur after year end for potential recognition or disclosure in the financial statements. These subsequent events have been considered through May 19, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - AGREEMENTS WITH UNDERWRITERS

Michigan Beverage Collective has entered into experience-rated contracts with Blue Cross/Blue Shield of Michigan (BCBSM), Blue Care Network, The Hartford, and Vision Service Plan to provide for member benefits.

Under the contracts the liability for claims incurred but not reported is retained on the books of the underwriters.

The agreements with BCBSM Blue Care Network provides for the accumulated underwriting results of all prior rating periods to be debited or credited to a Rate Stabilization Reserve (RSR), which is to be refunded to Michigan Beverage Collective (positive balance) or recouped by BCBSM and Blue Care Network (negative balance), in accordance with the provisions of the agreement. In addition to the underwriting gain or loss, the RSR is charged or credited for other factors such as rate recoupments and credits, investment income and other miscellaneous items. In the event of contract termination, the recovery or payment of the RSR balance is subject to certain limitations.

NOTE 5 - FEDERAL INCOME TAX

The Plan is exempt from federal income taxes under Section 501(c)(9) of the Internal Revenue Code, except for taxes that may arise from unrelated business income. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan may invest in various investment securities, but currently does not. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
