## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Butternut Mountain Farm 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE A DESCRIPTION OF PLAN

The following description of the Butternut Mountain Farm 401(k) Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering employees of the Company who have completed three months of service. Entry dates are January 1 and July 1. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally adopted January 1, 2012.

Contributions

The employer may elect to make Qualified Nonelective and profit sharing match contributions as described in the Adoption Agreement. The amount of such contribution, if any, to the Plan for each plan year, will be determined by the Employer as described in the Plan document, subject to IRS dollar limitations.

The company contributes a safe harbor contribution equal to 3% of the participant's compensation. The profit sharing contributions are discretionary and vary by class of employee.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Participants are vested in employer profit sharing contributions at a rate of 20% per year starting after one year of service. Participants are fully vested upon death or total and permanent disability.

Participant Loans

Participant loans are not permitted per the Adoption Agreement.

Payment of Benefits

On termination of service due to death or disability, a participant may elect to receive a lump sum in the same plan year in which the forfeiture occurs in the amount equal to the value of the participant's vested interest in their account, or annual installments.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation

The Plan's investments are stated at fair value (except for fully-benefit responsive investment contracts, which are valued at contract value). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment contracts held by a defined contribution plan are required to be reported at fair value.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Allowance for Doubtful Accounts

The plan considers allowance for doubtful accounts to be amounts that would not be collectible by the plan. There is no allowance for doubtful accounts at December 31, 2024 and 2023.

NOTE D FAIR VALUE MEASUREMENTS

Fair value measurements establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under described below:

Basis of Fair Value Measurement

Level 1- Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities

Level 2- Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly. (market approach)

Level 3- Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at December 31, 2024, and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table presents by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024, and 2023. As required by ASC Topic 820, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

NOTE E INVESTMENT CONTRACT WITH INSURANCE COMPANY

The plan has a benefit responsive investment contract with Talcott Resolution Life Insurance Company. Talcott Resolution Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the plan. The interest crediting rate is based on the earnings of the underlying assets, as stated in the contract.

As described in Note B, because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the plan by Talcott Resolution Life Insurance Company, represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses.

NOTE F PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan at any time to terminate the Plan subject to the provisions of ERISA.

NOTE G TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

NOTE G TAX STATUS (continued)

Consideration has been given to uncertain tax positions. The federal income tax returns for the years ended after December 31, 2024, and 2023, remain open for potential examination by the Department of Labor, generally for three years or, in cases of fraud or concealment, six years after the date they were filed.

NOTE H RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE I ADMINISTRATIVE EXPENSES/PARTY IN INTEREST TRANSACTIONS

Certain plan investments are managed by Talcott Resolution Life Insurance Company, the custodian of the plan. Talcott Resolution receives commissions for their services and therefore, these transactions qualify as party in interest transactions. Talcott Resolution Life Insurance Company received \$19,989 of commissions during the year ended December 31, 2024.

The plan sponsor provides administrative services to the plan at no cost. Some administrative expenses were paid by the plan. During the year ended December 31, 2024, the plan paid the following for third party administrative fees:
