### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of John Brown University Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ## Notes to Financial Statements

December 31, 2024 and 2023

### 1. DESCRIPTION OF PLAN:

The following description of the John Brown University Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution plan covering all eligible employees of John Brown University (the University). Other than student employees, non-resident aliens, employees who work less than 20 hours a week, and collective bargaining employees, all employees are eligible to make elective deferrals to the Plan. To become eligible for the employer matching and nondiscretionary contributions, participants must have one year of service, reach the age of 21, and work more than 1,000 hours during a 12-month period. Certain employees defined by the Plan document are eligible immediately for the employer match without meeting the listed requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The cabinet and board of trustees are responsible for oversight of the Plan, and the employee benefits committee determines the Plan's investment offerings and monitors investment performance.

#### CONTRIBUTIONS

Each year, participants may contribute up to a maximum of 100 percent of their annual compensation, as defined in the Plan and subject to the annual limits of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year or have at least 15 years of service with the University are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

During the year ended December 31, 2024, the University contributed 3% of eligible compensation for any participant who met or exceeded a 3% participant deferral contribution. In addition, the University contributed a nonelective contribution of 4% of eligible compensation to all eligible participants, regardless if the participant elected any deferral contributions.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the University's contribution and (b) Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### VESTING

Participants are vested immediately in their contributions and in the University's contribution portion of their accounts and actual earnings thereon.

1. DESCRIPTION OF PLAN, continued:

### PLAN LOANS

Participants may borrow from TIAA at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the USA Today published prime rate. Beginning April 1, 2019, Plan loans are no longer allowed to be issued by the Plan document. As of December 31, 2024 and 2023, loans totaling \$4,815 and \$8,042, respectively, are secured by participant accounts. These loans are payable by the participants to TIAA and are therefore not assets of the Plan.

### NOTES RECEIVABLE FROM PARTICIPANTS

Effective April 1, 2019, participants may apply for a loan from their participant account. The total of the loans that a participant has outstanding is limited to the lesser of \$50,000 or 50 percent of the participant's account balance. The notes are secured by the balance in the participant's account. Participant loans bear interest at a rate determined by the Plan administrator (currently Prime plus 1.00%). Each loan shall be amortized in level payments, not less frequently than quarterly, over a maximum of 5 years (with certain exceptions for loans used to acquire a principal residence). Principal and interest are paid ratably through payroll deductions.

### PAYMENT OF BENEFITS

Upon termination of service due to death, disability, or retirement, participants with vested account balances greater than \$5,000 generally receive payments in the form of a lifetime annuity or, if married, as a joint and survivor annuity. Other forms of payment are available, providing that the participant and spouse, if married, waive the annuity form of payment. Terminated participants with vested account balances of \$5,000 or less may receive a single lump-sum payment. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes.

2. SIGNIFICANT ACCOUNTING POLICIES:

### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. SIGNIFICANT ACCOUNTING POLICIES, continued:

#### INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### PAYMENT OF BENEFITS

Benefits are recorded when paid.

#### ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the University. Expenses that are paid by the University are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Administrative fees also include plan servicing fees from the recordkeeper. Investment related expenses are included in net appreciation of fair value of investments.

#### RECLASSIFICATION

Certain amounts in the prior year financial statements and disclosures have been reclassified to conform to current year presentation.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF). TIAA Trust, N.A. is the custodian of the portion of Plan assets invested in mutual fund shares and has authorized TIAA to certify investments held by TIAA Trust, N.A. TIAA and CREF are issuers of the remaining assets in the Plan.

4. FAIR VALUE MEASUREMENTS:

The *Fair Value Measurements and Disclosure* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

4. FAIR VALUE MEASUREMENTS, continued:

The fair value of mutual funds is based on quoted prices in active markets for identical assets. Variable annuity contracts are valued at the net asset value (NAV) of units held by the Plan at year end based on the fair value of the underlying investments. NAV is a readily determinable fair value which is published daily and is the basis for current transactions. Non benefit-responsive fixed annuity contracts are not actively traded, and significant other observable inputs are not available. Therefore, the fair value of the fixed annuity contracts is determined using an income approach by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. These contracts have liquidity restrictions and are non-benefit responsive. The fair value of the pooled separate account units is principally derived from the market value of the underlying real estate holdings or other real estate-related investments.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY:

The Plan has fully benefit-responsive guaranteed investment contracts with TIAA. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts that are fully benefit-responsive at December 31, 2024 and 2023, was \$217,346 and \$212,306, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity date.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by TIAA. The prototype plan document has obtained an opinion letter from the Internal Revenue Service dated August 8, 2017, in which it states that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

8. PARTIES-IN-INTEREST:

Certain investments for the Plan are funds managed by TIAA. TIAA is the issuer of some contracts and recordkeeper for the Plan; therefore, these transactions qualify as party-in-interest transactions. TIAA receives revenue from mutual fund service providers for services TIAA provides to the funds. This revenue is used to offset certain amounts owed to TIAA for its administrative services to the Plan and is reflected as other income of \$19,811 in the statement of changes in net assets available for benefits.

Direct fees of \$71,555 and indirect fees of \$112,322 were paid to TIAA by the Plan for the recordkeeping and investment management services for the year ended December 31, 2024. In addition, \$39,638 of direct fees were paid to other parties-in-interest for advisory services. Indirect fees are included in net appreciation of fair value of investments.

9. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. SUBSEQUENT EVENTS:

Subsequent events were evaluated through August 13, 2025, which is the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
