Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements (Continued)

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events considered in the aggregate, which raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matters

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Bobby Rahal Automotive Group 401(k) Plan, (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) profit-sharing plan covering all eligible employees of Team Rahal of Mechanicsburg, Inc., who have attained the age of twenty-one and completed one year of service of at least 1,000 hours. Eligible employees begin to participate on the first day of the quarter following completion of the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended and restated effective July 1, 2021 to merge the following plans into the Plan: Team Rahal, Inc. DBA Bobby Rahal Honda 401(k) Plan, Team Rahal of Silver Spring DBA Bobby Rahal Acura 401(k) Plan, Team Rahal of Lewistown, LLC DBA Bobby Rahal of Lewistown 401(k) Plan, Bobby Rahal Honda Plan B 401(k) Plan, Team Rahal of Warrendale, Inc. DBA Bobby Rahal Volvo Jaguar Land Rover 401(k) Plan, Team Rahal of Pittsburgh, Inc. 401(k) Plan, Team Rahal of South Hills 401(k) Plan, Team Rahal of Steel City, Inc. 401(k) Plan, Team Rahal of State College, Inc. DBA Bobby Rahal Honda of State College 401(k) Plan, and Team Rahal of Canonsburg, LLC dba Jaguar Land Rover S Hills 401(k) Plan. The sponsors of these plans became participating employers in the Plan.

The Plan was amended to change the name of the Plan to Bobby Rahal Automotive Group 401(k) Plan effective July 1, 2021. In addition, the service requirement was changed from one year of service of at least 1,000 hours to one year of service with no hours requirement.

The Plan was amended and restated effective December 2, 2021, to add Team Rahal of McMurray, LLC as a participating employer.

Effective January 1, 2023, the plan document was amended to adjust the service requirement for plan eligibility to six months.

Contributions: Each year, participants may contribute any percentage of compensation up to the maximum amount allowed by law. Contributions are subject to certain annual limitations imposed by the Internal Revenue Code. Participants who attain age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at four percent of eligible compensation and their contributions invested in a designated target fund until changed by the participant. The Company's matching contribution is discretionary. During 2024, the Company contributed matching on pre-tax contributions at 50 percent of the first four percent of compensation that a participant contributed to the Plan. Non-elective amounts may also be contributed at the discretion of the Company. There were no such non-elective contributions for the Plan year ended December 31, 2024. Plan contributions are subject to IRS limitations.

Note 1. Description of the Plan (Continued)

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Corporation's contribution, (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options: Participants may direct the investment of contributions into various investment options offered by the Plan. Participants may change their investment allocation at any time.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance during the past 12 months or any existing loan balances on the date a new loan is made, whichever is greater. Participants may have a maximum of two loans outstanding at a time. Loan terms are for a period of up to five years except for the purchase of a primary residence. Interest rates on the participant loans are set at the prime rate plus one percent. Loans are secured by the vested balance in a participant's account. Loan repayments must be paid directly to the Plan through payroll withholdings.

Payment of Benefits: A participant shall be entitled to receive the balance held in his or her account upon reaching normal retirement at age 65, death, disability, or termination of employment. Participant benefits will be made in a lump sum or in installments. Distributions may be deferred until the participant reaches the age of 73, if the value of the distribution is not less than \$5,000; however, the Plan document stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches age 73. In-service distributions are available to participants after reaching the age of 59-1/2. Hardship withdrawals are also permitted subject to limitations as to amounts and types of contributions that may be withdrawn.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company match and non-elective contributions is based on years of continuous service. A participant is 20 percent vested after two years of service is completed and vests an additional 20 percent per year until full vesting after six years.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,495 and \$4, respectively. Forfeitures represent unallocated profit-sharing contributions resulting from the termination of participants with less than fully vested rights under the Plan. Forfeitures of participant's non-vested accounts are used to reduce matching contributions or to pay administrative expenses. During 2024, forfeitures of \$74,963 were used to reduce matching contributions.

Administrative Expenses: All significant costs to administer the Plan are paid by the Plan if not paid by the Company. Any expenses paid by the Company are not reflected in the accompanying financial statements.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments in registered investment companies and collective investment trusts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms on the Plan document surrounding defaulted loans.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through August 15, 2025, the date the financial statements were available to be issued. See Note 9.

Note 3. Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Empower Trust Company, LLC (the Trustee of the Plan).

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.
- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, which are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The Plan's investments, consisting of registered investment companies and collective investment trusts, are held by Empower Trust Company, LLC. The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Shares of registered investment companies (mutual funds) are valued at the daily closing prices as reported by the funds. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts: The Plan invests in various collective investment trusts offered separately by State Street Global Advisors, Empower Trust Company, LLC, Great Gray Collective Trust (previously named Wilmington Trust) and Northern Trust Investments, Inc. The collective investment trusts are valued based upon the net asset value (NAV) per unit times the number of units held by the Plan at year-end. Net asset value is used as a practical expedient to estimate fair value because it is unlikely that the trust would sell the investment for an amount different than the reported net asset value.

Collective Investment Trusts: (Continued): The units of each share class of the collective trusts are valued daily based on the closing market prices of the underlying investments. The NAV per unit is computed by dividing the total assets of the trust, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trust and included in the determination of unit values.

Empower Trust Company, LLC (“Empower”), formerly Great West Trust Company LLC, offers a stable value option with the Drive Income Fund. Empower, as Trustee, determines the value of Fund units daily, before taking into account purchases or redemptions of units as follows: 1) The Trustee determines the value of the Fund by applying the current crediting rate in accordance with valuation rules established by the Trustee, 2) the Trustee subtracts from the value of Fund assets any ordinary or extraordinary expenses, costs, charges or other liabilities incurred or accrued by the fund through the date of the calculation to determine the net value of fund assets and 3) the Trustee divides the result by the total number of units of the fund in existence as of the valuation date to arrive at the net asset value of the units.

Empower offers a balanced fund with the Drive Balanced Fund: Empower determines the value of Fund units daily, before taking into account purchases or redemptions of units with the following procedures: 1) The Trustee determines the value of the Fund in accordance with valuation rules established by the Trustee and relies on the value or price last reported to the Trustee or manager of the underlying investments in accordance with the valuation policies and procedures of the underlying investment, 2) the Trustee subtracts from the value of Fund assets any ordinary or extraordinary expenses, costs, charges or other liabilities incurred or accrued by the fund through the date of the calculation to determine the net value of fund assets, and 3) the Trustee divides the result by the total number of units of the fund in existence as of the valuation date to arrive at the net asset value of the units.

Great Gray Collective Investment Trust Funds sub-advised by MFS Institutional Advisors, Inc. offers MFS Mid Cap Value Fund CIT whose objective is capital appreciation. Purchases or sales are executed at NAV typically determined as of the close of trading on the trade date. The fair value of the collective investment trusts is based on the fair value of the collective trust’s underlying investments as reported by the fund manager to the Trustee, net of accrued account level fees. Great Gray also offers a T. Rowe Price Retirement Blend Select Trust Series with each fund seeking to provide the highest total return over time consistent with capital and income growth based on expected retirement dates.

Northern Trust Investments Collective Investment Trust Funds offers a variety of collective investments trusts, including international, fixed income and domestic funds. Purchases or sales are executed at NAV typically determined as of the close of trading on the trade date. The fair value of the collective investment trusts is based on the fair value of the collective trust’s underlying investments as reported by the fund manager to the Trustee, net of accrued account level fees.

State Street Global Advisors (SSGA) provides investment management services through several bank maintained collective trust funds. Purchases or sales are executed at NAV for each series fund typically determined as of the close of trading on the trade date. The fair value of the collective investment trusts is based on the fair value of the collective trust’s underlying investments as reported by the fund manager to the Trustee, net of accrued account level fees. The underlying investments vary with each fund series.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party and Party-in-Interest Transactions

Certain Plan investments in collective investment trusts are managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the current Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the plan paid certain expenses related to plan operations and investment activity to various service providers. The transactions qualify as exempt party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts

Note 7. Tax Status

The Plan adopted a non-standardized prototype plan and trust sponsored Empower Retirement LLC. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated November 11, 2022, as to the Plan's qualified status. Although the Plan has since been amended, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Note 9. Subsequent Events

On March 25, 2025, the Plan's loan policy was updated to allow for participants to continue to make loan repayments following termination of service.

On April 3, 2025, the Company sold three affiliate dealerships, Team Rahal of Warrendale, Inc., Team Rahal of Canonsburg, LLC, and Team Rahal of McMurray, LLC. This affected approximately 180 employees and resulted in distributions from the plan of approximately \$2,550,00 occurring in April 2025.
