Opinion

NOTES TO THE FINANCIAL STATEMENTS

(1) Plan Description

The following description of Emery Sapp Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for complete information.

General Information

Emery Sapp & Sons, Inc. established the Plan as of January 1, 1998. As of January 1, 1999, the Plan was amended to transfer Plan sponsorship to Emery Sapp Construction, Inc. (the “Company”). From its inception through 2010, the Plan operated, in relevant part, as a leveraged employee stock ownership plan (“ESOP”). During 2010, the remaining stock acquisition loan was paid in full. During 2012, stock was acquired with a loan causing the Plan to become leveraged. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the “Code”), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by an administrative board of directors.

During 2012, the Plan purchased common shares of the Company using the proceeds from a loan with the Company (see Note 8) and holds the stock in a trust established under the Plan. The borrowings will be repaid over a period of twenty years by Company contributions to the trust fund. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the Code.

The borrowings are collateralized by the unallocated shares of stock and are guaranteed by the Company. The lender has no rights against the shares once they are allocated under the ESOP. Accordingly, the financial statements present separately the assets and liabilities and changes therein pertaining to:

- (a) the accounts of employees with rights in allocated shares (“Allocated”) and
- (b) shares not yet allocated to employees (“Unallocated”).

Effective July 15, 2024, The Plan has a transfer agreement with the Emery Sapp 401(k) Plan, where any elective diversification or mandatory diversification from the ESOP will be immediately transferred from the ESOP to the Emery Sapp 401(k) Plan. Under this agreement, the investments in registered investment companies was transferred during 2024.

Eligible Participants

Employees are generally eligible to participate in the Plan at an entry date coinciding with, or immediately preceding, the later of: (a) the date on which the employee completes 1,000 hours of service (irrespective of whether such hours of service are completed in one or more Plan years) and (b) the date on which the employee attains age 18.

NOTES TO THE FINANCIAL STATEMENTS

(1) Plan Description (Continued)

Participant Accounts and Forfeitures

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Employer contributions and Plan forfeitures are generally allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures of terminated non-vested account balances allocated to remaining participants at December 31, 2024 and 2023 totaled \$4,367,910 and \$4,447,872, respectively. Plan earnings related to the investments in sponsor company common stock are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

In relation to the investments in the registered investment companies, each participant's account is credited with (a) Plan earnings and appreciation and (b) the participant's share of forfeited accounts of former employees. Each participant's account is charged with (a) any withdrawals or distributions, (b) Plan losses and depreciation, and (c) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement and Terminations

In the case of normal retirement or retirement due to permanent disability, participants will receive the value of their vested benefits, in accordance with the provisions of the Plan, either in a lump-sum distribution or in installments payable over a period of time.

In the event that a participant dies before retirement, the beneficiary will receive the value of the participant's vested benefits in a lump-sum distribution.

In the case of termination of an employee, the participant will be mandatorily diversified from the Company stock at a diversification date designated in accordance with the provisions of the Plan. The Plan allows for the administrative committee to designate the diversification date and fully diversify terminated employees at that date.

In-Service Distributions

The Plan allows for in-service distributions upon the attainment of age 59 1/2 and completion of 13 years of service and only from funds in which the participant is 100% vested. Distributions are made in cash for investments in registered investment companies and/or in the form of Company shares. Pursuant to the plan agreement, either the Company or the Plan is obligated to immediately repurchase participant shares in the Company which have been distributed under the terms of the Plan.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account only in certain instances.

(1) Plan Description (Continued)

Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, participants will become fully vested, and the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the trust shall pay all liabilities and expenses of the trust fund and distribute the remaining assets of the trust fund in kind or liquidate them and distribute the net proceeds in cash to persons who were participants on the date when the Plan was terminated in the proportion which the total of the participant's account is to the total accounts outstanding.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. For Company contributions made to the Plan after December 31, 2010 and earnings thereon, participants are not vested until after three years of service, at which point, they become 100% vested.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The fair value of the Plan's other financial instruments approximates their carrying amounts, either because the expected collection or payment period is relatively short or because the terms are similar to market trends. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Risk

Participants in the Plan assume all adverse investment risk connected with any decrease in value of plan assets, and such assets are the sole source of payments under the Plan.

Operating and Administrative Expenses

The expenses of maintaining the Plan are paid by the Plan unless the Company elects to pay part of the expenses. The fees of the independent auditor issuing the accompanying report were paid by the Company.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

(3) Transactions with Parties-In-Interest

Certain administrative functions are performed by officers and employees of the Company. These officers and employees also participate in the Plan. No such officer or employee receives compensation from the Plan.

(4) Administration of Plan Assets

The Plan's assets, which consist principally of the Company's common shares, are held by Benefit Trust Company, the trustee of the Plan. Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income, and makes distributions to participants. For the year ending December 31, 2023, all investments in registered investment company funds were held and managed by the John Hancock Life Insurance Company.

(5) Fair Value Measurements

Under the Fair Value Measurements and Disclosures topic of the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”), a guideline is provided for measuring fair value under generally accepted accounting principles. The topic establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs include quoted prices in active markets for similar assets, quoted prices in inactive markets for similar assets, or inputs that are observable or can be corroborated by observable market data or other means for substantially the full term of the asset; and Level 3 inputs have the lowest priority and are based on prices or valuation techniques that are unobservable and not corroborated by market data. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when an active market comparable is not available and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair values of registered investment companies are based on quoted market prices.

Level 3 Fair Value Measurements

The sponsor company common stock is not actively traded, and significant other observable inputs are not available. Thus, the fair value of the stock is determined by an annual, independent appraisal. This appraisal was based on a combination of the market and income valuation approaches consistent with prior years. The appraiser considered historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums.

Management determines the fair value measurement policies and procedures. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

(7) Dividend Receivable

At December 31, 2024 and 2023, the Company declared a dividend of \$50 per allocated share, for a total dividend receivable of \$20,500,000 and \$20,102,747, respectively, recorded on the accompanying statements of net assets available for benefits. The dividend was paid subsequent to year-end.

(8) Loan Payable

In December 2012, the Plan entered into an installment loan payable with the Company for \$286,297. Payments of \$18,252, including interest at 2.40%, are due yearly, with final payment due in December 2032. The amount due at December 31, 2024 and 2023 was \$131,283 and \$145,992, respectively. The plan sponsor has guaranteed the loan and 2,308.7377 and 2,597.3300 of unallocated shares at December 31, 2024 and 2023, respectively, serve as collateral for the loan. Shares are released from collateral and allocated to participant accounts when principal and interest payments are made. This resulted in 288.5923 shares being released and allocated for the years ending December 31, 2024 and 2023.

(9) Employer Contributions

The Company's minimum obligation is to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, is equal to the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan.

(10) Internal Revenue Service Status

The Internal Revenue Service has determined and informed the plan administrator by a letter dated October 11, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan accounts for any uncertain tax positions in accordance with the Income Taxes topic of the FASB ASC. The topic prescribes a recognition threshold and measurement process for financial statement recognition of uncertain tax positions taken or expected to be taken in an annual return/report of an employee benefit plan. In evaluating the Plan's tax position, interpretations and tax planning strategies are considered. The Plan believes its tax-exempt status is appropriate based on current facts and circumstances.

(11) Risks and Uncertainties

The Plan invests in various securities. The underlying investments may include corporate debt instruments and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
