For funding, no preretirement mortality is assumed. The postretirement funding mortality follows the IRS 2024 Static Mortality Table with combined tables for annuitants and non-annuitants, as prescribed by Treasury regulation section 1.430(h)(3)-1.

MINIMUM FUNDING METHOD

The funding target and target normal cost for minimum funding calculations are determined using the traditional unit credit cost method as prescribed by Treasury regulation section 1.430(d)-1. The liability under the unit credit cost method is the value of the accrued pension benefit using service and pay as of the valuation date. The sum of the present value of the accrued benefits for all participants is the ERISA funding target. The normal cost is the present value of the benefits earned during the year. The target normal cost is the sum of the normal costs for all participants and the assumed administrative expenses.

Changes in Method from Prior Year and Rationale for Changes

For this 2024 Plan Year, the valuation software has changed. Prior to the change, the enrolled actuary compared the prior year Funding Target, Target Normal Cost, and Actuarial Value of Assets using the old software and the new software. There was less than 2% difference in the values produced by the old software and the new software. This change meets the requirements for automatic approval under the provisions of IRS Revenue Procedure 2017-56.





NORMAL RETIREMENT AGE

VESTING

Each participant is 100% vested in his or her Cash Balance Account upon completion of three years of service, attainment of Normal Retirement Age, disability, or death.

STATUTORY LIMITS

For 2024, the maximum compensation limit under IRC section 401(a)(17) is \$345,000, and the maximum benefit payable under IRC section 415(b) is \$275,000.

For this 2024 Plan Year, the valuation software has changed. Prior to the change, the enrolled actuary compared the prior year Funding Target, Target Normal Cost, and Actuarial Value of Assets using the old software and the new software. There was less than 2% difference in the values produced by the old software and the new software.
