**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of SC Holdings, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the SC Holdings, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the plan provisions.

General - SC Holdings, Inc. (the Sponsor, or Company) established the Plan effective April 2013. The Plan is a leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

In April 2013, the Plan purchased 100% of the Company's stock immediately after redemption of the stock by the Company's former stockholder. The Plan acquired the 500,000 shares of common stock in exchange for a \$500,000 note payable to the Company and holds the common stock in a trust established under the Plan. The Company has since contributed an additional 31,311 shares of common stock through December 31, 2024, including 11,635 shares contributed during the year ended December 31, 2024. Sponsor common stock outstanding, net of cumulative repurchases of 46,311 shares of common stock in settlement of distributions to participants, totals 485,000 at December 31, 2024.

As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC. Shares vest ratably after two years of service, with full vesting upon six years of service.

Stock acquired through issuance of, and serving as collateral on, the note payable, is held in a trust established under the Plan and considered unallocated. The borrowing is to be repaid by Company contributions to the trust fund. As the Plan makes each payment of principal on the note, an appropriate percentage of stock, as determined by the Plan Trustee based on a formula prescribed in the Plan, is allocated to eligible participants' accounts in accordance with applicable regulations under the Code. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

1. the accounts of employees with vested rights in allocated common stock (allocated) and
2. common stock not yet allocated to employees (unallocated).

The borrowing is collateralized by the unallocated shares of common stock. The lender has no rights against shares of common stock once they are allocated under the provisions of the ESOP.

Eligibility - Employees of the Company and its subsidiaries become participants in the Plan provided they have completed 900 hours of service in the first year of employment, or any Plan year. The Plan also provides for eligibility of employees re-employed by the Company after terminating service. However, the Plan excludes leased employees, employees who directly or through their families have other, substantial, stock-based benefits within the meaning of Code Section 409(p)(4)(D), and employees covered by a collective bargaining agreement.

1. DESCRIPTION OF PLAN, CONTINUED

Contributions - The Company is obligated to make contributions in cash to the Plan which, when aggregated with any Plan dividends or interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted. The Company has the discretion to make additional cash or stock contributions to the Plan beyond the terms of the Plan's loan commitment, within limitations set forth by the IRC.

Voting rights - Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. In the event that instructions have not been given to the trustee by a participant, the trustee is to vote those shares based on the break-down of instructions received from participants. In certain situations, the trustee has the right to decide how shares of Sponsor common stock allocated to participant accounts will be voted. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Participant accounts - The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of unallocated shares of Sponsor common stock released by the Administrative Committee, and any forfeitures of terminated participants' non-vested balances, Company discretionary contributions, Company distributions, and Plan earnings. Participants eligible to receive an allocation consist of employees of the Company as of the last day of the Plan year, and employees who were active participants at any point in the Plan year if they terminated employment and reached normal retirement age, died, or became disabled prior the end of the Plan year. Allocations are based on a participant's eligible compensation, relative to total compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting - Participants vest 20% per year after the first two years of service and are 100% vested after six years of credited service. Upon death, disability, or normal retirement age, the participant will become fully vested in their account balance.

Payment of benefits - No distributions from the Plan will be made until a participant becomes disabled, dies, terminates employment with the Company, or meets certain in-service requirements. If termination is a result of death or disability, as defined, the participant or participant's beneficiary may elect to receive benefits in the form of a lump sum payment in the following Plan year.

A participant who terminates employment after having attained 59½ years of age will begin to receive benefits in the following Plan year. If a participant hired prior to January 1, 2023, terminates employment for any other reason than disability, death, or upon reaching age 59½, the participant can elect to receive their vested account balance in the following Plan year. For such participants hired on or after January 1, 2023, there is a three year waiting period before distributions can be elected. Benefits are paid out in a lump sum if under \$10,000, or in five annual installments over a five-year period if over \$10,000.

1. DESCRIPTION OF PLAN, CONTINUED

Payment of benefits, continued - Active participants who have attained 59½ years of age are eligible to receive in-service distributions based on their balance as of December 31, 2022. Benefits are paid out in a lump sum if under \$10,000, or in five annual installments over a five-year period if over \$10,000. Active participants who have attained age 61 and completed 10 years of continuous service are eligible to receive an in-service distribution in the following Plan year. Payment will be made in one lump sum payment for up to the lesser of 25% of their account balance or \$100,000. If a participant is eligible for both distribution options, whichever provides the greater distribution amount will be applied.

For retired or terminated participants who elect annual installment payments, each installment is equal to the value of the participants account at the time of the distribution, divided by the remaining number of installments to be paid; provided that, in the case of a participant with an account having a fair market value in excess of \$1,415,000, distribution of the participant's account will be made over one additional year (up to five years) for each \$280,000 or fraction thereof by which such account balance exceeds \$1,415,000.

Distributions are made in cash or in stock with a simultaneous put back to the Company in exchange for cash. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan, as long as the shares are not publicly traded or if the shares are subject to trading limitations. During 2024, the Company repurchased 11,635 shares of stock.

Put option - Under Federal income tax regulations, Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the most recent appraised value of the stock. The Company can pay for the purchase with interest over a period not exceeding five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification - Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Sponsor common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of Company shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify will have their balance transferred to the 401(k) Plan or distributed directly to them. Diversification distributions totaled \$174,210 for the year ended December 31, 2024.

Forfeitures - Employer contributions and Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation of all Plan participants eligible to receive an allocation during the Plan year. Forfeitures of terminated non-vested account balances allocated to remaining participants totaled \$610,979 in 2024.

1. DESCRIPTION OF PLAN, CONTINUED

Administration of plan assets - The trustee of the Plan holds the Plan's assets, which consist principally of Sponsor common stock. Company contributions are held and managed by the trustee, which invests cash received and any interest and dividend income. The trustee also administers the payment of interest and principal on the loan, which is reimbursed to the trustee through contributions as determined by the Company. The trustee makes distributions to participants. Officers or employees of the Company perform certain administrative functions. No such officer or employee receives compensation from the Plan. All expenses of maintaining the Plan are paid by the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Allocations - The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment valuation and income recognition - The shares of Sponsor common stock are valued at estimated fair value, which is determined by annual independent appraisals. The per share market value at December 31, 2024 and 2023, was \$273.92 and \$196.81, respectively. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation represents the unrealized gain in shares of Sponsor common stock.

Benefit payments - Benefit payments are recorded when paid.

Subsequent events - The Plan has evaluated events, if any, that have occurred subsequent to December 31, 2024, through July 31, 2025, the date the financial statements were available to be issued, and included information in the notes to the financial statements related to any identifiable events, if necessary.

4. FAIR VALUE MEASUREMENTS

U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTES TO FINANCIAL STATEMENTS, CONTINUED

4. FAIR VALUE MEASUREMENTS, CONTINUED

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Sponsor common stock:* The fair value is determined based on an independent appraisal. The appraisal was based primarily on an income approach, using the capitalization of historical debt-free cash flow method. Cash flow inputs were from past actual cash flows generated by the Company.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. NOTE PAYABLE TO PLAN SPONSOR

In 2013, the Plan entered into a \$500,000 term loan agreement with the Company in connection with the acquisition of the shares of the Company's common stock. The outstanding balance on the note payable was \$318,996 and \$337,592 at December 31, 2024 and 2023, respectively. The note payable is due in annual installments of \$35,476, including interest at 5%, through December 2037, and is collateralized by the unallocated shares of Sponsor common stock. The Plan Sponsor is obligated to make contributions in cash to the Plan in the amount necessary to enable the Plan to make its annual payments of principal and interest due on the note payable.

Shares are released from collateral and allocated to participants when principal and interest payments are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current year payments, divided by the total of this year's payments plus all future years' principal and interest payments. This resulted in 20,625 shares being released and allocated for the Plan year ended December 31, 2024.

6. PLAN TERMINATION

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Plan Administrator directs the trustee to pay all liabilities and expenses of the ESOP and to sell shares of the financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in common stock of, and has a note payable to, the Company. These are related party and party-in-interest transactions. As described in Note 1, the Company pays all Plan expenses. The Plan has a number of service providers. Such service providers are parties-in-interest under ERISA.

8. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan is qualified and the related trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

9. RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in Sponsor common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

10. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and interest, dividends, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Spinnaker Trust, the trustee of the Plan.

11. SUBSEQUENT EVENTS

In April 2025, the Plan's Distribution Policy was amended to allow a one-time lump sum distribution of the vested account balance for participants who met certain criteria. These criteria included terminated participants who were under the age of 59 1/2 at December 31, 2024, and retiree participants (separated from service) who were over the age of 59 1/2 on or before December 31, 2024. The lump sum payout was made in July 2025. As of July 31, 2025, distributions to date totaled approximately \$6,491,000. This amount included the one-time lump sum payout, as well as normally occurring distributions.
