### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **WithumSmith+Brown 401(k) Employee Savings Plan (the Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## **NOTE 1: DESCRIPTION OF PLAN**

The following description of the WithumSmith+Brown 401(k) Employee Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan, which was established July 1, 1988, is a defined contribution retirement plan maintained for the benefit of employees of WithumSmith+Brown, PC (the Employer and Plan Administrator) who have met eligibility requirements defined in the Plan agreement. Generally, employees are eligible to participate in the Plan upon their date of hire.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer utilizes the services of Fidelity Management Trust Company (FMTC) to process investment transactions, maintain participant account balances and act as trustee of the Plan's assets.

Certain duties related to the administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Certain other expenses related to the administration of the Plan are paid directly by the Plan Sponsor and are not recorded as expenses in the Plan's financial statements. These expenses totaled approximately \$16,000 for the year ended December 31, 2024.

### **Plan Amendment**

Effective March 18, 2024, the Plan was amended to enhance the discretionary match to add qualified student loan payments to the formula.

### **Contributions**

Participants may contribute the lesser of 100% of compensation (as defined in the Plan agreement) or \$55,000 in the form of pre-tax salary deferral, after tax (Roth) salary deferral, voluntary non-deductible after-tax employee deferral, or a combination of these options but not to exceed limitations imposed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Participants who are still employed during the Plan year and are eligible for a distribution from an account balance in this Plan, other than a loan account or a designated Roth contribution account, may elect to directly roll over the distribution to a designated Roth contribution account in the Plan. Eligible participants may also make an In-Plan Roth transfer which allows the participant to change the tax treatment of all or some of their pre-tax accounts in which they are 100 percent vested.

The Employer may make a discretionary matching contribution for each Plan participant equal to a percentage of each participant's deferral contribution. The Employer may also make a discretionary profit-sharing contribution. Employer contributions are also subject to limitations imposed by the IRS.

## **NOTE 1: DESCRIPTION OF PLAN (Continued)**

### **Participant Accounts**

Each participant's account is credited with their respective participant contributions, Employer matching contributions, earnings and an allocation of the profit-sharing contribution. Allocations of the profit-sharing contribution are based on the proportion that each participant's plan compensation bears to the aggregate plan compensation of all participants, as specified in the Plan agreement.

### **Vesting**

Participants are fully vested at all times in their own contributions plus actual earnings thereon. Vesting in the Employer's contributions and earnings thereon is based on years of service, as defined in the Plan agreement. A participant is one hundred percent vested in Employer contributions upon retirement, permanent disability or death, or after five years of credited service.

### **Investment Options**

Contributions to the Plan are invested as directed by the participants. Participants may invest in various mutual funds and a separate account offered by the Plan. For participants with account balances in excess of \$30,000, the Plan also offers the option to invest their funds in self-directed brokerage accounts. Participants may change their investment options at any time.

### **Notes Receivable from Participants**

Participants may borrow from their accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans may be extended for periods not to exceed five years, except when loan proceeds are used for the purchase of the borrower's primary residence, in which case the loan may be extended. Loans are secured by the participant's vested account balance and bear interest ranging from 2.88% to 9.25%, which is commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan Administrator. Principal and interest are paid through payroll deductions.

### **Forfeitures**

The nonvested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. Under the terms of the Plan agreement, forfeitures may be used to pay administrative expenses or reduce the Employer's contribution. Forfeitures used to reduce employer matching contributions and pay administrative expenses totaled approximately \$215,000 during the year ended December 31, 2024. There was approximately \$238,000 and \$159,000 in forfeitures available for future allocation at December 31, 2024 and 2023, respectively.

### **Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant (or their designated beneficiary) may elect to receive the participant's vested account balance in a lump-sum distribution. In-service distributions after a participant's attainment of age 59 ½ are permitted as specified in the Plan agreement.

### **Hardship Withdrawals**

In case of immediate and heavy financial hardship, a participant may withdraw all or a portion of the participant's vested account balance. A withdrawal shall be deemed for purposes of an immediate and heavy financial hardship if the withdrawal is necessary for certain eligible expenses, such as medical care, the purchase of a principal residence for the participant, payment of tuition and related education fees for the next twelve months of post-secondary education, payments necessary to prevent eviction of the participant from his or her principal residence or to avoid foreclosure on said residence, payments for funeral or burial expenses or expenses to repair damage to the participant's principal residence.

### **Termination of the Plan**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded in accordance with the Internal Revenue Code.

### **Payment of Benefits**

Benefits are recorded when paid. There are no amounts allocated to withdrawing participants that were not yet paid as of December 31, 2024 and 2023.

### **Administrative and Investment Expenses**

The Plan uses fee levelization in an effort to provide equal recordkeeping and administrative fees to all Plan participants. Under this structure, participants are charged recordkeeping and administrative fees on a pro-rata basis and revenue sharing generated from funds in which the participant is invested is credited directly to the participant. During the year ended December 31, 2024, administrative expenses paid by the Plan were approximately \$582,000.

Fees related to the self-directed brokerage accounts are charged directly to the participant's account and are included in net appreciation (depreciation) in fair value of the Plan's investments. Investment related expenses are included in net appreciation (depreciation) in fair value of the Plan's investments and are not readily determinable.

### **Estimates**

The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

## ***NOTE 3: INFORMATION PREPARED AND CERTIFIED BY PLAN TRUSTEE***

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all information pertaining to the Plan's investments and related investment activity reflected in the financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024, was certified by Fidelity Management Trust Company. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedule. Based on the information provided and certified by the trustee, there are no fixed income obligations, leases or debt instruments in default or deemed uncollectible, as defined by ERISA, for the years ended December 31, 2024 and 2023.

**NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2      Inputs to the valuation method include the following:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Assets held in self-directed brokerage accounts primarily consist of exchange traded funds and common stocks that are valued on the basis of readily determinable market prices.

### **NOTE 5: GROUP ANNUITY INSURANCE CONTRACT**

At December 31, 2024 and 2023, the Plan held an investment in the Principal Preservation Separate Account (PPSA), a group annuity insurance product of Prudential Retirement Insurance and Annuity Company (PRIAC). The Plan owns a promise to pay interest at crediting rates that are announced in advance and guaranteed for a specified period of time as outlined in the contract. The interest crediting rates for the PPSA are determined by PRIAC without the use of a specific formula and are not based on the performance of the assets held in the collateral account and may not be less than 1.50%. Based on those factors, the fair value of the PPSA approximates the contract value, which totaled \$7,572,511 and \$7,970,245 at December 31, 2024 and 2023, respectively. Interest is credited by using a single interest rate that is applied to all contributions made to the product regardless of the timing of those contributions.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Participants may ordinarily direct the withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes.

There are no events that would limit the ability of the Plan to transact at contract value paid either immediately or, depending on the rate environment and cash flow levels, over time. There are no events that allow the issuer to terminate the contract, and which require the Plan Sponsor to settle at an amount different than contract value paid either within 90 days or over time.

### **NOTE 6: TAX STATUS**

Effective September 2, 2020, the Plan executed an adoption agreement for the Fidelity Management & Research Company's Volume Submitter Profit Sharing/401(k) Plan with CODA (the Prototype). As an adopter of the Prototype, the Plan is not subject to tax under present income tax law.

The IRS ruled on June 30, 2020, that the Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving that letter, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

### **NOTE 6: TAX STATUS (Continued)**

Accounting standards require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

### **NOTE 7: RISKS AND UNCERTAINTIES**

The Plan's investments are exposed to various risks such as interest rate, market and credit risks. In addition, certain of the investment options available to Plan participants may invest in foreign securities. There are certain additional risks involved when investing in funds with underlying foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.
