## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Timberline Construction Corp. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. Description of the Plan**

The following description of the Timberline Construction Corp. 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan established to provide employees of Timberline Construction Corporation (TCC) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). TCC's affiliate, Timberline Communications, Inc., is a participating employer in the Plan. TCC and TCI are collectively referred to as the Employer. Effective March 1, 2024, the Plan was amended to provide for all employees of the Employer to become eligible to participate in the Plan on the first day of the month (previously the first day of the quarter) following the completion of one month of service with the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

TCC is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Management Trust Company (FMTC) is the appointed trustee of the Plan and holds and manages Plan investments, as well as provides recordkeeping services, at the direction of the Plan Administrator. Pinnacle Pension Consultants LLC (Pinnacle) is the Plan's investment advisor.

***Contributions***

Participants may make voluntary contributions through salary reductions up to 100% of their eligible annual pre-tax compensation, as defined by the Plan document, limited to the maximum amounts allowed under the provisions of the IRC. Further, participants who are 50 years of age or older before the end of the Plan year may contribute additional catch-up contributions. The Plan also allows participants to defer after-tax contributions up to 100% of eligible compensation, limited to the maximum amounts allowed under the provisions of the IRC and rollover contributions from other qualified plans, as defined in the Plan document. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan provides for automatic enrollment, whereby eligible employees are automatically enrolled to defer 5% of eligible earnings, as applicable, in the Plan. Employees must submit an election to opt out of the automatic enrollment provision of the Plan.

The Employer's safe harbor matching contribution is equal to 100% of the participant's contribution, up to 3% of compensation. In addition, the Employer may choose to make additional discretionary matching contributions. There were no discretionary matching contributions made to the Plan during the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and the Employer's safe harbor matching contribution and allocations of (a) the Employer discretionary contributions, (b) Plan earnings (losses), and (c) administrative expenses. Plan earnings (losses) and administrative expenses are allocated to participant accounts based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their elective contributions, rollover contributions, Employer safe harbor matching contributions and accrued earnings thereon. Participants become fully vested in the Employer's discretionary matching contributions and accrued earnings thereon over five years as follows: 20% after 1 year, 40% after 2 years, 60% after 3 years, 80% after 4 years, and 100% after 5 years. Each participant shall be 100% vested in their account balances upon death, disability, or attainment of normal retirement age.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Note terms range from one to five years, or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. Participants can have only one note outstanding at any given time. In addition, terminated participants with an outstanding loan may continue making payments after termination in accordance with the promissory note terms.

***Payment of Benefits***

Upon retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) can elect to receive 100% of their vested account balance, payable in a single lump-sum distribution or a rollover to a qualifying retirement account. Participants who have reached the age of 59½ may elect to withdraw all or a portion of their account while still employed by the Employer. In-service withdrawals are also permitted for Rollover and Roth Rollover account balances at any time.

If a participant's vested balance is equal to or less than \$1,000, the participant will receive an immediate cash-out of their vested account balance, and the non-vested portion shall be treated as a forfeiture. Effective January 1, 2024, in accordance with the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act, if a participant's vested balance exceeds \$1,000 and is equal to or less than \$7,000 (previously limited to \$5,000), the amount will be rolled over to an individual retirement plan designated by the trustee, unless otherwise directed by the participant.

Effective January 1, 2023, the Plan adopted certain provisions of the SECURE 2.0 Act, which increased the age of the required distributions to begin from 72 to 73.

***Hardship Withdrawal***

Hardship distributions are permitted from a participant's vested account balance, subject to limitations imposed by the IRC. Effective January 1, 2024, in accordance with the SECURE 2.0 Act, the Plan, under certain circumstances, will allow employees to self-certify that an event has occurred that constitutes a hardship for purposes of taking a hardship withdrawal.

***Forfeitures***

Participants in the Plan who leave the employment of the Employer before completing the applicable vesting requirements forfeit the non-vested portion of their accounts. Forfeited non-vested accounts may be used to reduce future Employer contributions or pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,283 and \$25, respectively. During 2024, participants forfeited amounts and earnings totaled \$10,009 while \$5,751 was used to reduce Employer required contributions to the Plan. There were no forfeitures used to pay administrative expenses.

***Plan Termination***

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants, and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within the stated terms.

Delinquent participant notes receivable are reclassified as distributions based on terms contained in the Plan document.

***Contributions***

Participant and Employer safe harbor matching contributions are recorded weekly when the Employer remits the contributions for investment into the Plan.

***Payment of Benefits***

Benefits are recorded when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses.

***Estimates***

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

At December 31, 2024 and 2023, the Plan invested in three mutual funds that accounted for approximately 41% and 44%, respectively, of total Plan investments.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

**3. Fair Value of Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

*Money Market Fund:* The money market fund is valued at deposit amount plus accrued interest, as determined according to stated terms.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments are reported at level 1 within the fair value hierarchy.

**4. Income Tax Status**

The Plan is an adoption of a pre-approved defined contribution plan sponsored by FMR LLC. FMR LLC has received a determination letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan Administrator and trustee believe that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believe the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**7. Related Party and Party-in-Interest Transactions**

Certain plan investments are held and managed by FMTC and Pinnacle provides consulting on investment performance and employee education on retirement; therefore, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan made direct payment to FMTC and Pinnacle for administrative services of \$3,620 and \$10,068, respectively. Participant notes receivable also qualify as party-in-interest transactions.

**8. Subsequent Events**

Effective January 1, 2025, the Plan adopted a provision of the SECURE 2.0 Act, which increased the catch-up contribution limit for participants between the ages of 60 and 63 to the greater of \$10,000 or 150% of the regular catch-up contributions (\$11,250 for 2025).

Effective January 1, 2025, the Plan was amended to clarify that certain employees of the Employer are excluded from participation in the Plan as follows:

- Employees covered by a collective bargaining agreement,
- Leased employees,
- Non-resident aliens not receiving earned UDS income, and
- Interns, temporary workers or seasonal employees.

Management has evaluated subsequent events through August 13, 2025, which is the date these financial statements were available to be issued.
