Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of American Healthcare, LLC Retirement Savings Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1: PLAN DESCRIPTION

American Healthcare, LLC (the Sponsor) established a 401(k) plan and related trust effective August 1, 1989. The Plan was amended and restated effective January 1, 2015. The following description of American Healthcare, LLC Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time and part-time employees of the Sponsor who are age 21 or older who have completed six months of consecutive service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan agreement. The Plan also allows Roth contributions, which are made on an after-tax basis. Annual pretax and Roth participant contributions are limited by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Sponsor may make matching contributions at its discretion. The Sponsor's matching contribution for the years ended December 31, 2024 and 2023 was 25% of the participants' contributions, up to 6% of their compensation. The Sponsor may also make profit sharing contributions at its discretion. There were no additional profit-sharing amounts contributed for the years ended December 31, 2024 and 2023.

Participant Accounts: Each participant's account is credited with the participant's contribution, allocations of the Sponsor's contributions and plan earnings, and charged with benefit payments and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting: Participants are immediately vested in their contributions and any Sponsor matching contributions and profit-sharing contributions, plus the actual earnings thereon.

Investment Options: Upon enrollment in the Plan, participants may direct contributions to any of numerous investment options. These options include pooled separate accounts with underlying investments in mutual funds that seek growth, income or capital preservation, as well as funds managed for a specific retirement target date or lifestyle allocation. The Plan currently offers various investment options for participants.

Notes Receivable from Participants: Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less, subject to certain restrictions. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is commensurate with prevailing local rates as determined periodically by the plan administrator. Principal and interest is paid ratably through payroll deductions.

NOTE 1: PLAN DESCRIPTION *(continued)*

Payment of Benefits: On termination of service due to death, disability, retirement or any other reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or systematic installments. Participants may also elect to withdraw funds while still employed once they reach the age of 59½. Hardship withdrawals are also permitted, subject to certain limitations and restrictions.

Administrative Expenses: The Plan's administrative expenses primarily include investment management and professional fees for services provided by parties-in-interest. Certain administrative expenses of the Plan are paid by both the Plan and the Sponsor.

Forfeitures: Forfeitures are first used to pay administrative expenses of the Plan, then used to reduce Sponsor contributions into the Plan. Forfeitures available to pay administrative expenses or to reduce Sponsor contributions were \$6,792 at December 31, 2024 and 2023. No forfeitures were used to reduce administrative fees or reduce Sponsor contributions into the Plan for the years ended December 31, 2024 and 2023.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian, John Hancock Life Insurance Company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(continued)*

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan agreement.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Management has evaluated subsequent events through August 8, 2025, which is the date the financial statements were available to be issued, and determined that there were no subsequent events requiring disclosure.

NOTE 3: FAIR VALUE MEASUREMENTS

The Plan's pooled separate accounts are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available.

Level 2 Fair Value Measurements

The fair values of pooled separate accounts are based on the market value of underlying investments and consist of investments in mutual funds and an investment in a collective investment trust. The mutual funds publish their daily net asset value and transact at that price. The mutual funds are deemed to be actively traded. The collective investment trust's fair value is calculated as the number of units held multiplied by the daily net asset value published by the collective investment trust.

NOTE 4: PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Sponsor contribution portion of their accounts.

NOTE 5: TAX STATUS

Effective January 1, 2023, the Plan was amended and restated by adopting the CCH Incorporated, DBA ftwilliam.com Non-Standardized Pre-Approved Profit-Sharing Plan with CODA, which received an opinion letter from the Internal Revenue Service on June 30, 2020 which stated that the Plan, as then designed, was in compliance with the applicable requirements of the *Internal Revenue Code (IRC)*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 7: RELATED-PARTY TRANSACTIONS

Certain Plan investments are funds managed by John Hancock Life Insurance Company, the Custodian. As the Custodian of the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan for administrative services were \$141,525 and \$119,557 for the years ended December 31, 2024 and 2023, respectively

Certain administrative functions are performed by employees of the Sponsor. These employees are also Plan participants. No such employee receives compensation from the Plan.

Some professional fees are paid by the Sponsor on behalf of the Plan.

NOTE 8: EXCESS CONTRIBUTIONS REFUNDABLE

At December 31, 2024 and 2023, a payable of \$74,911 and \$60,797, respectively, was recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service.
