**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**NOTE 1: DESCRIPTION OF PLAN**

The following brief description of the Agriland Farming Company, Inc. 401(k) Plan (the Plan) provides only general information. The Plan has been adopted by the following employers: Agri Systems, Inc., Agriland Nursery, Inc., Pistachio Harvesting, Inc., and Sequoia Transport, Inc. (the Company). Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all eligible employees of the Company. It is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility** – Employees of the Company are eligible to make salary deferrals on the first day of the plan quarter coincident with or next following their date of hire and attainment of age 18. Employees will participate in the Employer's contributions after completing one year of service with the Company and attaining age 18.

**Administration** – The Plan is sponsored and administered by the Company. Costs of administering the Plan that are not paid by the Plan are paid by the Company.

**Employee Contributions** – An employee will be eligible to make a pre-tax salary deferral upon completion of the age and service requirements. Eligible employees may also elect to make Roth salary deferrals. Plan participants may contribute up to 100% of their pre-tax annual compensation subject to certain Internal Revenue Code limitations (\$23,000 and \$22,500 in 2024 and 2023, respectively). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions (\$7,500 in 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified plans or IRA's.

**Employer Contributions** – The Company may elect to make discretionary profit sharing contributions to the Plan. Profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

The Company may also make discretionary matching contributions. For the year ended December 31, 2024, the Company had a tiered match as follows: the Company matched 100% of employee contributions, up to \$250; the 50% of employee contributions up to 7% of eligible compensation deferred to the Plan; and then 10% of employee contributions above 7% of eligible compensation deferred to the Plan. The discretionary matching contribution for the year ended December 31, 2024, was \$152,811, net of excess contributions.

**Participant Accounts** – Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution and investment earnings, and charged with withdrawals and an allocation of fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1: DESCRIPTION OF PLAN (Continued)**

***Vesting*** – Participants are vested immediately in their salary deferral and rollover contributions plus actual earnings thereon. As of January 1, 2024, employer matching and discretionary profit sharing contributions are 100% vested after completion of two (2) years of service. Participants that terminated employment prior to January 1, 2024, remain on a six-year, graduated schedule for the portion of their accounts related to employer contributions. In the event of death, disability or retirement, a participant’s interest in employer contributions becomes fully vested.

***Notes receivable from participants*** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant’s account and bear an interest rate based on the prime rate of interest published by the Federal Reserve as of the date the loan is established plus one (1) percent. Principal and interest is paid through bi-weekly payroll deductions.

***Forfeitures*** – Forfeitures (participants’ allocated interest in plan assets which are not vested because employment is terminated before the vesting period is complete) remain subject to being restored for five years after a participant terminates employment. Forfeited nonvested accounts totaled \$7 and \$5,839 for the years ended December 31, 2024 and 2023, respectively. The forfeitures may be used to offset future contributions or to pay plan administrative expenses.

***Payment of Benefits*** – In the event of termination of service, death, disability or retirement, a participant’s vested interest in the Plan is distributed as a lump sum, as soon as administratively feasible.

***Investment*** – Participants are allowed to direct their contributions and the related matching employer contributions by the Company into any of the various investment options offered by the Plan.

**NOTE 2: SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting*** – The financial statements of the Plan are prepared under the accrual basis of accounting.

***Use of Estimates*** – The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition*** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's custodians, Empower Annuity Insurance Company of America (Empower Retirement), certified the value of the investments. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Excess contributions payable* – Excess contributions payable represent amounts refunded to participants after year end to comply with regulatory contribution limitations with a corresponding reduction to contributions.

*Administrative expenses* – The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions from the accompanying statement of changes in net assets available for benefits. Fees related to the processing of distributions to participants are charged directly to the participant's account and are included in administrative expenses. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

*Payment of Benefits* – Benefits are recorded when paid.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separated Accounts (PSAs)*: PSAs are investment options that invest solely in shares of underlying mutual funds. Each PSA is valued at net asset value of assets comprising the accounts. The net asset value is used as a practical expedient to estimate the fair value.

**NOTE 4: RELATED-PARTY TRANSACTIONS**

The plan’s investments are shares of pooled separate accounts managed by Empower Annuity Insurance Company of America (Empower Retirement). Empower Retirement is the custodian as defined by the Plan and, therefore, qualifies as a party-in-interest to the Plan.

**NOTE 5: PLAN TERMINATION**

Although termination of the Plan is not presently contemplated, the Company does have the right to terminate the Plan at any time, subject to the provision set forth in ERISA. In the event of termination, participants become 100% vested in their matching employer contributions.

**NOTE 6: INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Empower Retirement the custodian of significantly all assets, has certified to the completeness and accuracy of:

1. Investments as of December 31, 2024 and 2023, included on the accompanying statements of net assets available for benefits.
2. Dividends and interest, net appreciation in fair value of investments, benefits paid to participants and administrative expenses, included on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
3. Investments reflected on the supplemental schedule of assets (held at end of year).

**NOTE 7: FEDERAL INCOME TAX STATUS**

The IRS ruled on June 30, 2020, that the pre-approved plan document adopted by the Company is qualified, in form, under Section 401(a) of the Internal Revenue Code (the "Code") and the underlying trust is, therefore, exempt from federal income tax under Section 501(a) of the Code. The Plan itself has not received a determination letter from the IRS on the current plan document. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S Federal jurisdiction. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


