**Notes to Financial Statements**

**Note 1 - The Plan and Its Significant Accounting Policies**

**General** - The following description of the United Factory Furniture Corporation 401(k) Profit Sharing Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established on 1969 by United Factory Furniture Corporation trade name Walker Furniture (the Company) to provide benefits to eligible employees of United Factory Furniture Corporation, Best Mattress, Inc., and Custom Furniture Rental, Inc. as defined in the Plan document. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Administration** - Under the terms of the Plan, the Company has appointed an Administrative Committee (the Committee) to manage the operation and administration of the Plan. The Company has contracted with Capital Bank and Trust Company and its affiliates (together referred as CB&T), a third-party administrator to process and maintain the records of participant data, and to act as the trustee and the custodian for the Plan. Substantially all expenses incurred for administering the Plan are paid by the Company except for audit fees and distribution processing fees of approximately \$12,000 during the year ended January 31, 2025, which are paid directly from participants' account balances. During the year ended January 31, 2025, Plan's investment management fees have been paid indirectly within the Plan's investments ranging from approximately annual rate of 1.00% to 1.50% of each investment. The Plan's investment management fees are already reflected in each fund's daily price; participant accounts are not charged separately.

**Basis of accounting** - The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** - The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

***Subsequent events*** - The Company monitors significant events occurring after the financial statement date and prior to its issuance to determine the impacts, if any, of events on the financial statements to be issued. All subsequent events of which the Company is aware were evaluated through the date of the independent accountant's report.

***Investments, investment valuation and income recognition*** – The Plan's investments are stated at fair value. Investments of the Plan are held by CB&T and invested based solely upon instructions received from participants. Participants may direct the investment of their contributions and employer contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers mutual funds and collective trust funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Fair value measurements*** - Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date.

***Fair value hierarchy*** - Valuation techniques used by the Plan are based upon observable and unobservable inputs. Observable or market inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's assumptions about market participant assumptions based on the best information available. Assets and liabilities are classified in the fair value hierarchy based on the lowest level of input that is significant to the fair value measurement.

Level 1: Quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs for the asset or liability. No level 3 assets were held by the Plan.

The fair value hierarchy gives the highest priority to observable inputs and lowest priority to unobservable inputs.

**Valuation techniques** - The following is a description of the valuation techniques used to measure fair value. There were no changes in the techniques used to measure fair value in the year ended January 31, 2025.

- Mutual funds: Valued at the daily closing price reported on the active market on which the individual securities were traded.
- Collective trust funds: Valued at the net asset value (NAV) as the practical expedient, established by the fund’s sponsor, and are interest-bearing cash equivalents which are valued at the observable NAV of the underlying investment units held by the Plan at year-end. The fund price is always stated at \$10 per unit. These investments have no redemption restrictions or future commitments, and they have a daily redemption frequency.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation techniques are appropriate and consistent with other market participants, the use of different techniques or assumptions to estimate fair value could result in a different fair value measurement at the reporting date.

**Cash and cash equivalents** - All highly liquid investments purchased with an original maturity of three months or less (generally money market funds) are considered to be cash equivalents. These investments are usually held for a short period of time, pending long-term investment.

***Forfeited accounts*** - Forfeited nonvested accounts are used to reduce future employer contributions or are allocated to eligible participants based on eligible compensations, as determined by the Company.

***Notes receivable from participants*** - Participant loans are not available under the current Plan provisions.

***Benefit payments*** - In general, benefit payments are recorded when paid.

***Income taxes*** - The Plan has adopted Capital Group Retirement Plan Services Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA which has received an opinion letter from the Internal Revenue Service indicating it is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Internal Revenue Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

The Plan administrator evaluates any uncertain tax position taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax position taken by the Plan, and has concluded that as of January 31, 2025, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***Reconciliation of financial statements to Form 5500*** - The difference between the financial reported in the financial statements and the information reported in the Form 5500 arise from \$9,346 excess contributions refundable at January 31, 2024.

***Risks and uncertainties*** - The Plan provides for various investment options in any combination of mutual funds, fixed income securities and other investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

## **Note 2 - Related Party Transactions**

Certain Plan investments in mutual funds and collective trust funds are managed by CB&T, the trustee and the custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value and qualify as party-in-interest. The Plan also pays record-keeping and investment advisory fees to a third-party administrator and its affiliates. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

## **Note 3 - Participation and Benefits**

The Plan document definition of compensation is based on when the compensation is “paid” versus when it is “earned.” As such, the Company has determined that participant deferrals may not be due to the Plan, and the Plan may have no right to the deferrals, until the compensation is actually paid to the participant.

***Employer contributions*** - The Company is allowed to make discretionary contributions as defined in the Plan and as approved by the Board of Directors. During the year ended January 31, 2025, the Company matched 25% of each eligible participant’s contribution up to a maximum of 4% of the participant’s eligible compensation.

***Participant contributions*** - Participants may elect to have the Company contribute an amount or a percentage of their eligible compensation not to exceed the annual amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Contributions withheld are invested in accordance with the participants’ directions.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participants’ directions and the Plan’s provisions.

***Vesting*** - Participants are fully vested in their contributions and earnings thereon. In general, participants are subject to a six-year cliff vesting with regard to Company matching contributions, and earnings thereon, after which time they become 100% vested in their Company matching contributions, and earnings thereon. In addition, participants become 100% vested in their Company matching contributions, and earnings thereon, at attainment of age 65, death before termination of employment, or becoming permanent disabled.

***Participant accounts*** - Each participant’s account is credited with the participant’s contributions, applicable Company matching contributions, and Plan earnings, and is reduced for any benefit payments and administrative expenses. Plan earnings are allocated to each participant’s account based on the ratio of the participant’s account balance and share of net earnings or losses of their

respective elected investment options. Allocations are determined in accordance with the provisions of the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

***Forfeitures*** - If a participant terminates employment before becoming fully vested in their Company matching contributions, the nonvested Company matching contributions (and earnings thereon) are forfeited at the earlier of the date the participant receives a distribution or incurs a five-year break-in-service. Forfeited balances due to taking a distribution of vested amounts are restored if the participant returns to an eligible status within five years of termination and repays any amount previously distributed. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company matching contributions, restore previously forfeited balances, or pay eligible plan expenses.

Unallocated forfeiture balances as of January 31, 2025 and 2024, were \$2,255 and \$408, respectively. During the year ended January 31, 2025, employer matching contributions were reduced by \$432 from forfeited nonvested account.

***Payment of benefits*** - Upon termination, death, or retirement, participants or beneficiaries may elect to receive a lump-sum amount or a partial or systematic withdrawal amount based on the vested value of their accounts. The Plan allows for in-service and hardship distributions when participants meet certain criteria. Participants may also, at any time, withdraw all or part of their rollover accounts. The Plan also allows for automatic lump sum distribution of participant vested account balances that do not exceed \$1,000.

There are \$19,090 and \$18,435 in unclaimed property account as of January 31, 2025 and 2024, respectively. These are benefit payments that were undeliverable to participants and returned back to the Plan custodian. Under the Plan's provisions, after a certain time period of inability to identify payees' current addresses, these returned undeliverable payments are reinstated into the Plan's assets holding for future participant claims. During the year ended January 31, 2024, \$236 of unclaimed benefit payments were returned to CB&T due to undeliverable addresses or other various reasons, and \$0 of previously unclaimed benefit payments were later delivered, claimed and cashed by participants. The net amount of these two transactions, \$236, has been recorded as "Unclaimed benefits, net" on the statement of changes in net assets available for benefits.
