Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Mohave Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Mohave Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Note 1 – Description of Plan

The following description of The Mohave Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

The Plan was established and became effective for participation on January 1, 2014, and amended and restated effective March 1, 2020. The Plan is a defined contribution 401(k) and profit sharing plan covering all eligible employees of Mohave Mental Health Clinic, Inc. (Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

A. Eligibility

All employees who have attained age of 21 and completed two months of service are eligible to participate in the Plan on the first day of the month following the date the eligibility requirement is met, with the exception of contract employees. All eligible employees who have completed one year of service are eligible to receive safe harbor and discretionary employer contributions.

B. Contributions

Participants may make pre-tax and Roth contributions subject to maximum amounts allowed under the Internal Revenue Code (IRC). Those participants age 50 and over are permitted additional "catch-up" contributions under the Plan. Upon becoming eligible to make salary deferrals under the Plan, a participant will automatically be entered into a salary deferral election equal to three percent of eligible compensation. Effective March 1, 2020, participants are auto-enrolled at four percent of eligible compensation. This deferral rate will automatically increase by one percent annually until it reaches seven percent of eligible compensation. This change impacted all participants who were not enrolled in the Plan or who were enrolled at a deferral rate less than four percent as of March 1, 2020. Employees are able to opt out or change the contribution to a higher percentage at any time. The Plan also allows for rollover contributions from other qualified plans.

The Organization is authorized to make employer safe harbor non-elective contributions of three percent of eligible compensation beginning on the first of the month following the employee's first year anniversary. Employees must have worked 1,000 hours in the year to qualify for this contribution. Employees who do not qualify after the first year will be reviewed for eligibility annually on their anniversary date.

Note 1 – Description of Plan

Once an employee becomes eligible for the employer safe harbor non-elective contributions, they are also eligible for a qualified non-elective contribution based on the following contribution scale:

<u>Safe Harbor Eligibility Date</u>	<u>Contribution %</u>
2 nd year of eligibility	5% (includes 3% Safe Harbor)
4 th year of eligibility	6% (includes 3% Safe Harbor)
6 th year of eligibility	7% (includes 3% Safe Harbor)
8 th year of eligibility	8% (includes 3% Safe Harbor)
10 th year of eligibility	9% (includes 3% Safe Harbor)
12 th year of eligibility	10% (includes 3% Safe Harbor)

The Plan also provides that the Organization may contribute to the Plan in the form of discretionary profit sharing contributions. This amount, if any, will be determined by the Organization. There were no discretionary profit sharing contributions for 2024.

C. Participant Accounts

All investment options are participant-directed. A separate account is maintained for each investment option of a participant by type of contribution. Each participant's account is credited with the participant's contributions, employer safe harbor non-elective contributions, qualified non-elective contributions, and allocations of (a) the Organization's discretionary profit sharing contributions, and (b) Plan earnings, and charged with an allocation of administrative expenses. Plan earnings are allocated and credited to the account daily based on the adjusted balance of each participant's account. The benefit to which a participant is entitled is the benefit from the participant's vested account.

D. Investment Options

Participants may direct their contributions and the Organization's contributions into various investment choices provided by the Plan. These options include pooled separate accounts and a guaranteed interest account. Additionally, participants may transfer funds between investments.

E. Vesting

Each participant's account is fully vested at all times; therefore, forfeitures do not occur under the Plan.

F. Payment of Benefits

Participants may withdraw their vested account balances in full or partial lump sums or installments upon retirement, disability or termination. Beneficiaries may withdraw vested account balances upon the death of a Plan participant. Participants may also withdraw all or a portion of their contributed account balances for specific hardship reasons subject to approval by the Plan Administrator.

G. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The loans are secured by the vested balance in the participant's account. Participants are only allowed one outstanding loan at a time. Principal and interest are paid ratably through payroll deductions. The interest rate is one percent above the prime rate on the first business day of the month the loan is originated.

H. Administrative Expenses

Plan participants pay costs associated with certain investment expenses such as fund withdrawal fees, which are deducted from the respective participant's account. Also, fees are paid by the account of the participant taking a loan. The Organization pays all other Plan administration costs. Investment management related expenses and fees related to the administration of notes receivable from participants are included in administrative expenses.

I. Plan Termination

Although it has not expressed any intention to do so, the Organization has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan is terminated, net assets of the Plan will be allocated in accordance with the terms of the Plan.

Note 2 – Summary of Significant Accounting Policies

The significant accounting policies followed by the Plan are as follows.

A. Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. Accordingly, additions are recognized when earned and deductions are recorded when incurred. Further, contributions are considered earned in the period withheld.

Note 2 – Summary of Significant Accounting Policies

B. Use of Estimates

Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported additions and deductions. Actual results could differ from those estimates.

C. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ameritas Life Insurance Company (the trustee of the Plan).

D. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Investments in shares of pooled separate accounts are stated at net asset value, which are readily determinable fair values of those shares as they are considered open-end mutual funds and are the basis for current transactions. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net appreciation in the fair value of investments reflects the change in fair value of the investments held at year end and realized gains and losses on investment transactions during the year. The investment in the guaranteed investment account is valued at the amount Plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceeded credited rates.

E. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distribution based upon the terms of the plan document.

Subsequent to year end, several employees received participant loans from their respective accounts, which totaled \$158,034.

F. Tax Status

The Plan adopted a non-standardized prototype plan document (Prototype Plan). The Prototype Plan received an opinion letter dated March 31, 2014, and its latest opinion later dated June 30, 2020, in which the Internal Revenue Service determined that the Prototype Plan, as then designed, was in accordance with the applicable sections of the Internal Revenue Code (IRC). Management has not obtained an individual determination letter for the Plan. Although the Plan has been amended since receiving the opinion letters, management and the Plan's administrator believe that the Plan is currently designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust remains tax-exempt at December 31, 2024. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions by the plan and recognize a tax liability if the plan has taken an uncertain position that more than likely would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Payment of Benefits

Benefit payments are recorded when paid.

H. Date of Management's Review

Subsequent events have been evaluated through August 11, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Note 3 – Fair Value Measurements

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts are valued at net asset value (NAV) of shares held by the Plan at year end as reported by the fund managers. Each of the pooled separate accounts invests either in multiple securities or in single mutual funds which are generally identified in the name of the pooled separate account. Investments in these funds can be redeemed at any time upon request and have redemption prices that are determined by the fund's NAV per unit. The custodian transacts in these funds on a daily basis as part of the separate account trading activity, therefore the resulting NAV is published and/or the fund managers are ready to transact at the quoted prices transacts in these funds on a daily basis as part of the separate account trading activity. Were the Plan to initiate a full redemption of the trust, the custodian reserves the right to temporarily delay payment from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The Plan has no unfunded fund commitments at December 31, 2024 and 2023.

Note 3 – Fair Value Measurements

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair values of assets for pooled separate accounts are measured on a recurring basis at December 31, 2024 and 2023 were \$14,479,104 and \$13,373,765, respectively. The pooled separate accounts were measured at Level 1 of the fair value hierarchy.

Note 4 – Investment Contract with Insurance Company

The Plan participates in an investment contract with Ameritas Life Insurance Company (Ameritas) reported as guaranteed investment accounts on the financial statements. Total guaranteed investment account balances at December 31, 2024 and 2023 were \$586,305 and \$604,232, respectively. The Ameritas Guaranteed Investment Account is collateralized by the general account assets of Ameritas. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals, and administrative expenses.

The Ameritas Guaranteed Investment Account earns a declared interest rate for new deposits in each calendar quarter. Subsequent to the initial guaranteed period, a renewal guarantee is applied for deposits made in the calendar quarter in all prior years. Credited rates are set based on yields earned on new purchases of fixed income securities for the general account for new deposits each quarter. Subsequent renewal rates are based on the investment performance of the general account at the time of renewal. Credited rates are guaranteed for the duration of the guaranteed period, and do not vary with the subsequent performance of assets of the general account which back these guarantees.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events may limit the ability of the plan sponsor and/or plan participants to transact at contract value with Ameritas. Examples of these events would include (but would not be limited to) amendments to the Plan document, premature termination of this contract, and termination of the Plan. In these examples, the contract value could be reduced by any applicable surrender charges upon distribution of contract's funds. Under no event may Ameritas terminate this contract and settle at an amount different from contract value. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

Note 5 – Market Risk

The Plan investments included pooled separate accounts (mutual funds), which invest in various investment securities and in various companies within various markets. The pooled separate account investments are recorded at fair value in accordance with the reporting requirements governing the Plan. Net changes in asset value is reflected as net appreciation (depreciation) in fair value of investments which includes realized income or loss as well. All such investments are subject to various market and economic risk factors as well as the national and global economies. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 6 – Unaudited Information Prepared and Certified by the Custodian

The following unaudited information in the Plan's financial statements and supplemental schedule was obtained from data prepared and certified to be complete and accurate by Ameritas Life Insurance Company within the meaning of 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- All amounts reported in the supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year), except participant loans.

Note 7 – Party-In-Interest Transactions

Plan investments are managed by Ameritas Life Insurance Company, the trustee/custodian of the Plan. Certain administrative functions are performed by officers and employees of the Organization. Other recordkeeping and administrative functions are also performed by Ameritas Life Insurance Corporation. Ameritas and the Organization are considered parties-in-interest for which statutory exemption exist. No Administrator, officer or employee receives compensation from the Plan. Fees incurred by the Plan for the investment management and recordkeeping services provided by Ameritas are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Such indirect payments amounted to \$7,724 in 2024.
