Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Phifer Retirement and 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.



- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Phifer Retirement and 401(k) Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Phifer Retirement and 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets Held for Investment Purposes as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1. DESCRIPTION OF PLAN

The following description of the Phifer Retirement and 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, restated effective January 1, 2021, is a defined contribution plan covering all employees of Phifer Incorporated (the “Company”). In order to make salary deferral contributions an employee must be age nineteen or older. In order to receive employer contributions an employee must be age nineteen or older and have completed a minimum of 1,000 hours of service during either the twelve-month period beginning with the employee’s date of employment, or any Plan year following this initial measurement period. The Plan is subject to the provisions of ERISA. Prior to January 1, 2023, the age requirement for participation for deferrals and employer contributions was twenty-one.

The Board of Directors is responsible for oversight of the Plan. The Plan provides that the Retirement Committee will serve as the Plan Administrator and determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Board of Directors. Mrs. Sheryl Harper currently serves as the chair of the Retirement Committee.

Contributions

Employees, without regard to length of service, may elect by entering into a salary reduction agreement with the employer, to reduce earnings from the Company by a percentage between 2% and 30%, and up to the amount allowed by the Internal Revenue Service. Highly-Compensated employees’ contributions could be further limited in order to comply with applicable limitations, including the nondiscrimination provisions, set forth in the Internal Revenue Code and related Treasury Regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective, January 1, 2024 the employee could elect that these contributions be traditional pre-tax or ROTH contributions. Prior to that date all contributions were traditional pre-tax. Also effective January 1, 2024, (1) new participants will have automatic deferral of 5% of compensation unless they make an affirmative election otherwise and (2) participants, other than those considered highly compensated or not contributing, became subject to automatic escalation of their contribution percentage. The 1% annual increase takes place on either the anniversary date of newly hired participants or January 1st each year for those already contributing and continues to increase by 1% each year up to the maximum of 15%. Participants may also contribute amounts representing distributions from other qualified plans or individual retirement accounts. The participant’s contributions are allocated to investment accounts selected by the participant from among those available under the Plan.

The Plan allows the Company, by Board action, to contribute a matching amount to the Plan for such Plan year equal to such percentage of the salary reduction contributions of the participants as the Board, in its sole and absolute discretion, may deem appropriate, not to exceed 10% of the employee’s compensation. In order to qualify for the match of salary reduction contributions in a given year, the employee must be employed on the last day of the year, with certain exceptions. The employer’s matching contributions are allocated to investment accounts selected by the participant from among those available under the Plan.

NOTE 1. DESCRIPTION OF PLAN (continued)

Additionally, the Plan provides that the Company will contribute employer retirement fund contributions to the Plan each year, in such amounts as the Board will determine. Such contributions will be allocated to each participant's account as shown below:

1. Up to and including, but not to exceed, 5% of the participant's compensation up to and including 50% of the taxable Social Security wage base in effect as of the beginning of the Plan year.
2. If any contribution remains after #1 above, then to each participant in the proportion of his compensation in excess of 50% of the taxable Social Security wage base in effect as of the beginning of the Plan year bears to the total of all compensation of all participants in excess of 50% of the taxable Social Security wage base, but not to exceed 9.3% of such excess.

In order to qualify for the employer retirement fund contribution in a given year, the employee must be employed on the last day of the year, with certain exceptions. Employees hired to work at the Fayette plant are not eligible for the employer retirement fund contribution.

Recently Adopted Accounting Guidelines – Allowance for Credit Losses

In June 2016, the FASB issued guidance (FASB ASC 326) which significantly changed how entities will measure credit losses for most financial assets and certain other instruments that aren't measured at fair value through net income. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing an entity's exposure to credit risk and the measurement of credit losses. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 were employer contributions receivable.

The Plan adopted the standard effective January 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in new/enhanced disclosures only.

Participant Accounts

All contributions for a participant are credited to his or her account. The Trustee, on a daily basis, determines the value of each of the separate funds. Increases or decreases for each participant's account reflect his or her proportionate interest in each fund, as adjusted for fund activity and valuation since the preceding valuation date. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting and Forfeited Accounts

All active employees become fully vested in all Plan contributions immediately upon entry; therefore, no forfeitures exist other than funds mistakenly or erroneously credited to participant accounts. These are immaterial in amount and are applied as credits toward employer contributions or used to pay reasonable Plan expenses.

Payment of Benefits

Upon termination of service, death, disability, or retirement, the participant may receive the value of the vested interest in his or her account in the form of either a lump sum distribution or provided the participant's account exceeds \$5,000, in periodic installments or partial lump sum payments. The Plan allows for hardship withdrawals, subject to certain restrictions.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the trustee and investment advisers. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the plan are paid by the Plan and are included in administrative fees unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain plan expenses are reimbursed to the Plan by the Trustee and these reimbursements are included in other income. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 18, 2025, the date the financial statements were available to be issued.

In December 2022 Securing a Strong Retirement Act (Secure 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective in 2024 and forward. The amendment for this Act is pending as of December 31, 2024.

NOTE 3. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company (the trustee of the Plan).

NOTE 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5. GUARANTEED INTEREST ACCOUNT

In 2009, the Plan entered into a fully benefit-responsive guaranteed investment contract with New York Life Trust Company. John Hancock (formerly New York Life) maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value as reported to the Plan by John Hancock. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but in no event will such effective annual interest rate, minus deductions for expenses, be less than 1%. Such interest rates are reviewed semiannually for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include, but are not limited to, total or partial plan termination, mergers, spin-offs, lay-offs, early retirement incentive programs, sales or closing of all or part of plan sponsor operations, bankruptcy or receivership. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The contract does not specify the circumstances under which the issuer may terminate the contract other than a written notice to the contract holder 30 days prior to the intended termination date. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan is invested in shares of a guaranteed interest account managed by John Hancock. John Hancock is the Trustee as defined by the Plan, and in this capacity invests Plan assets in the guaranteed interest account, as directed by participants. In the opinion of the administrator, the transactions between the Plan and John Hancock are conducted on substantially the same basis as between unrelated parties. Income earned by the Plan in relation to the guaranteed interest account was \$867,902 for the year ended December 31, 2024. Charges paid for administration of this account by netting against interest credited to the guaranteed interest account were \$89,442 for the year ended December 31, 2024. Recordkeeping and administrative fees totaling \$44,607 for the year ended December 31, 2024, paid directly to John Hancock are included in administrative fees. John Hancock also received indirect compensation paid from the individual funds. John Hancock provided the Plan \$6,960 during the year ended December 31, 2024, to cover a portion of the administrative expenses incurred by the Plan. These funds are reported as other income in these financial statements.

Morgan Stanley provides investment management services to the Plan. Fees incurred by the plan for the investment management services are paid through revenue sharing rather than a direct payment.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 8. TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax- exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
